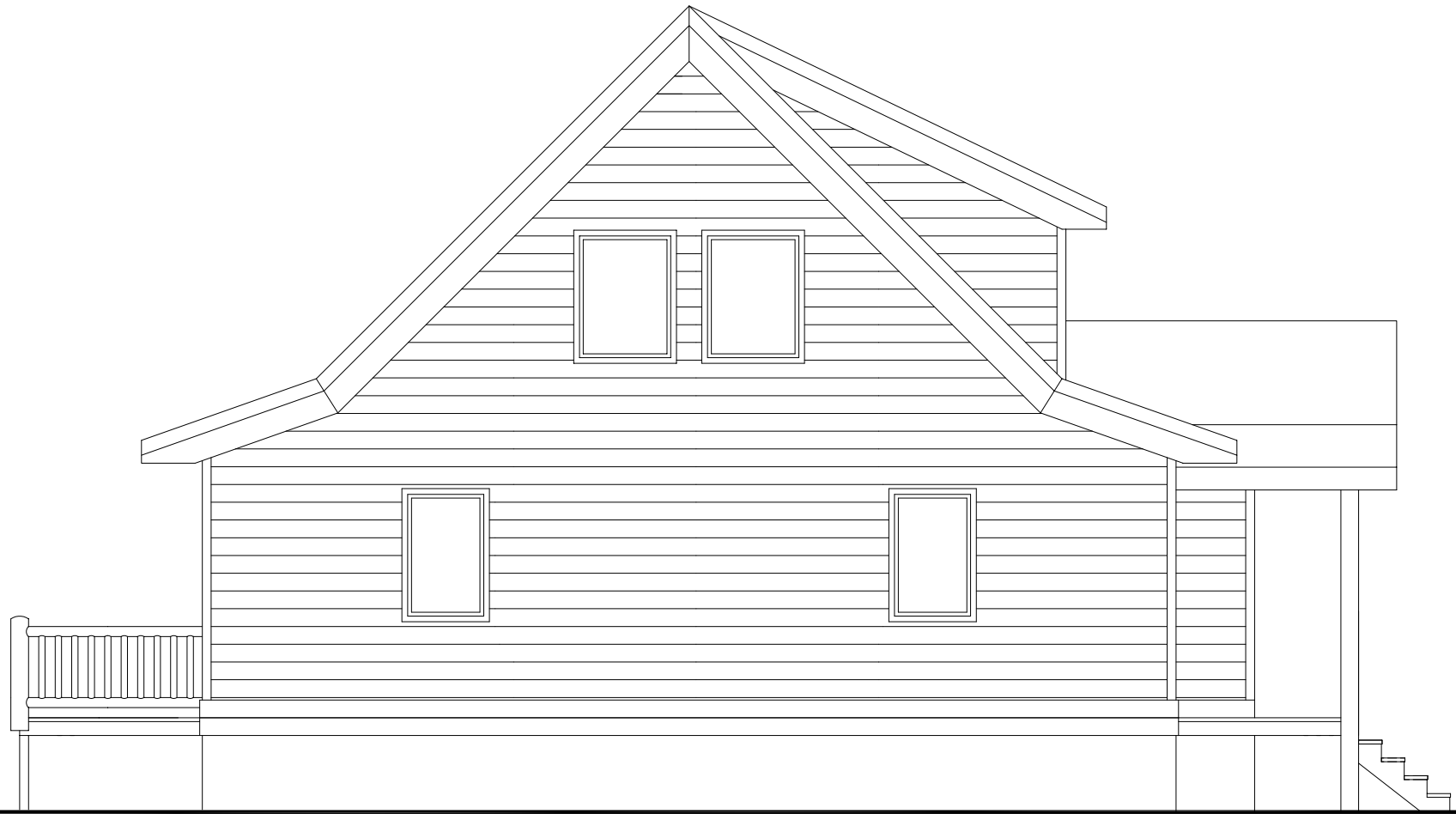
ASPEN STUDY PLAN
