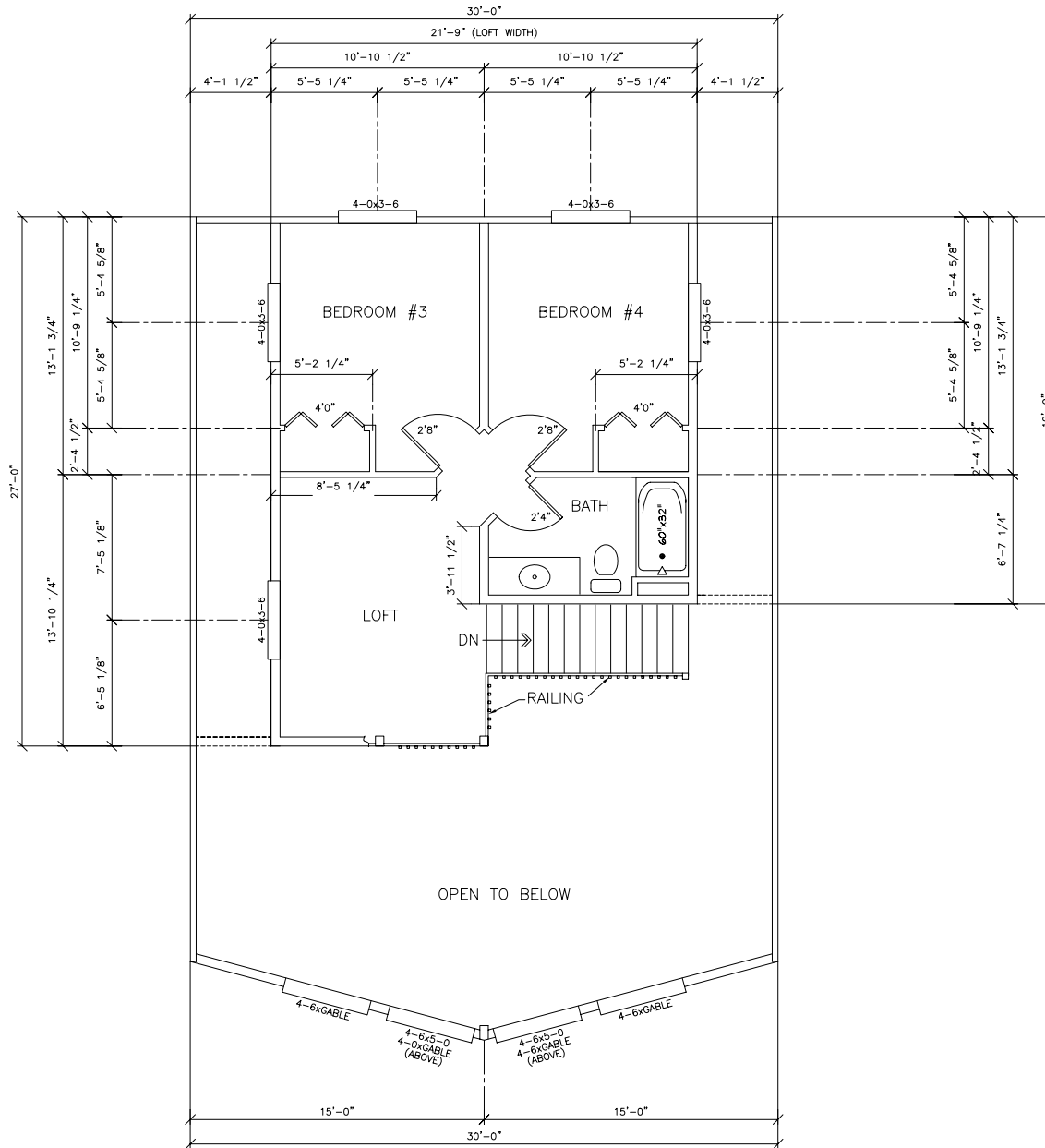

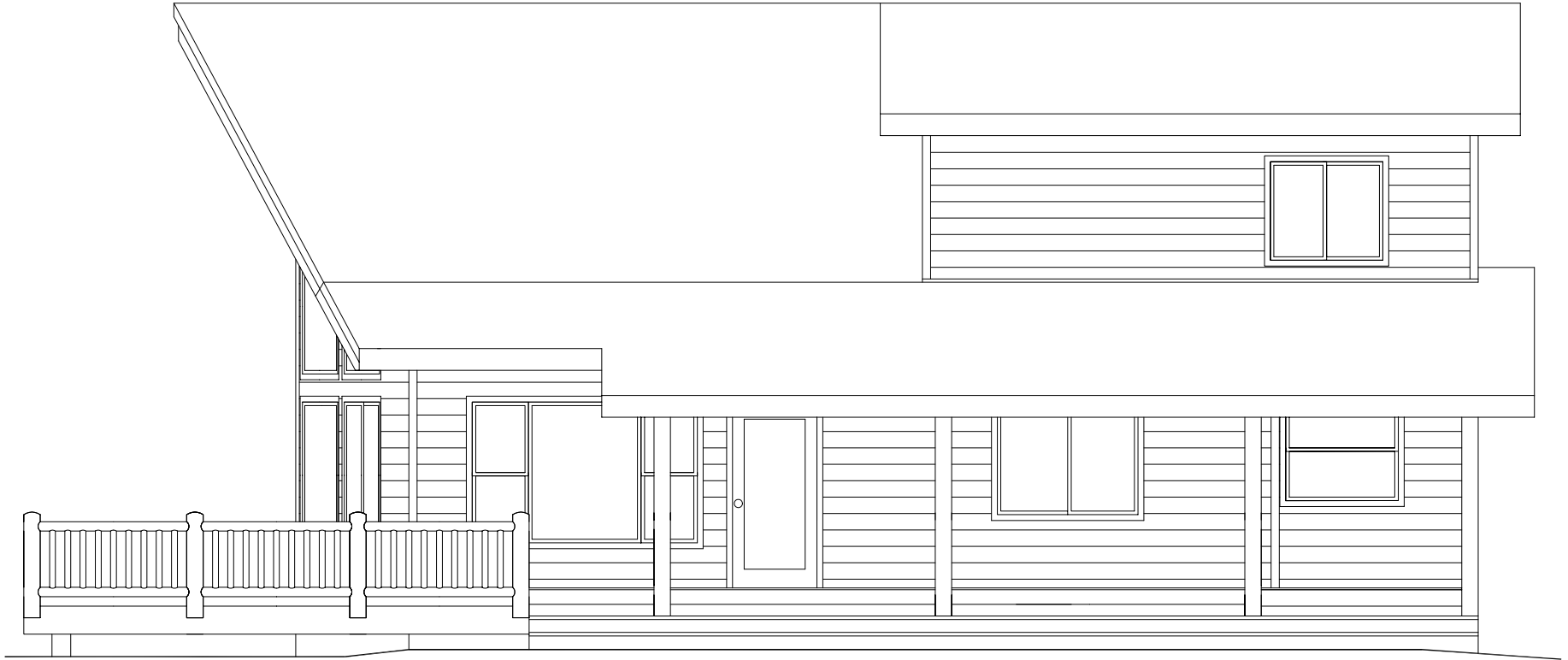

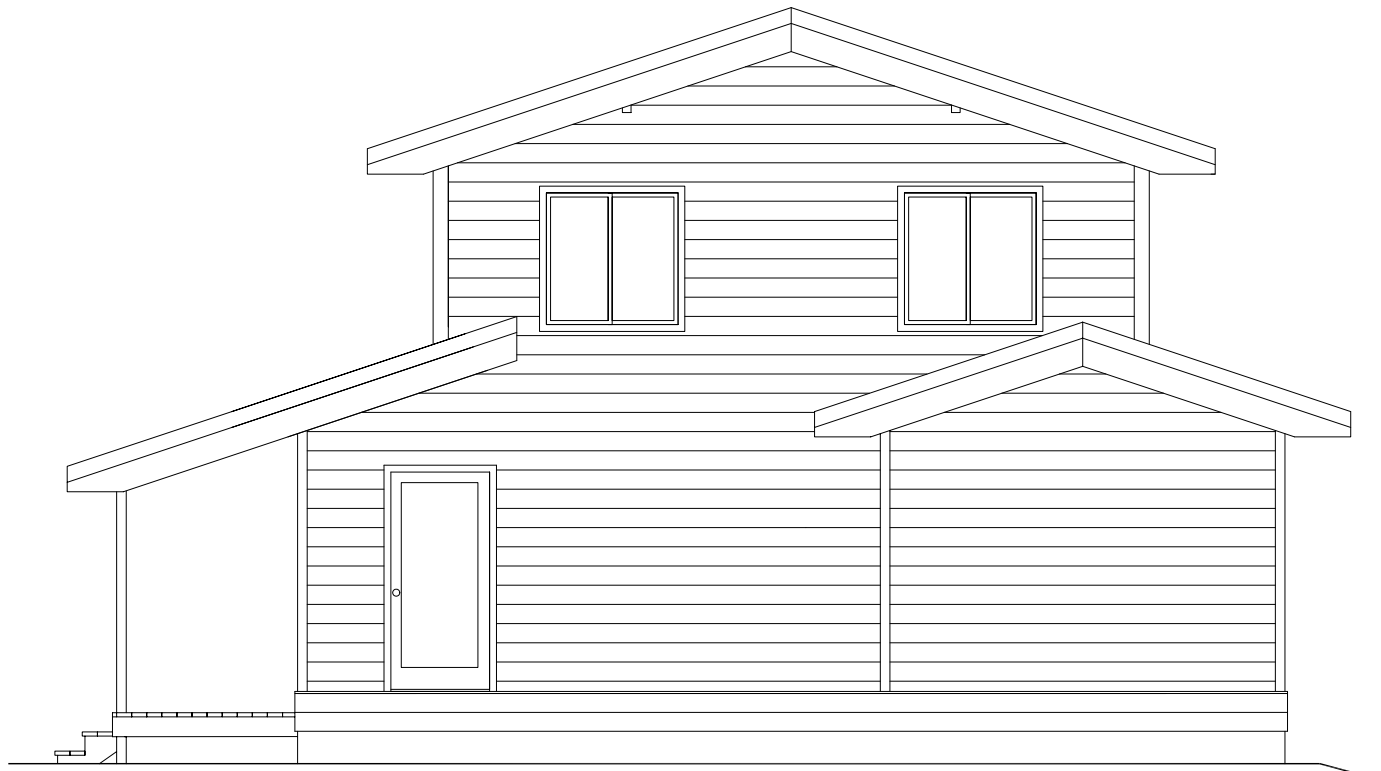
BIRCH BAY STUDY PLAN
