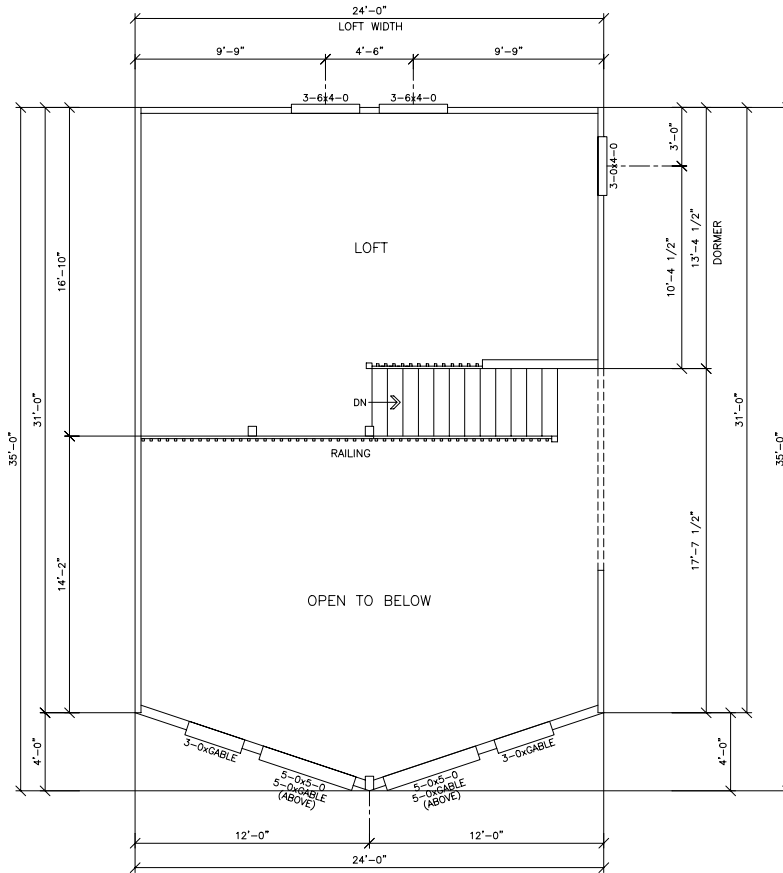


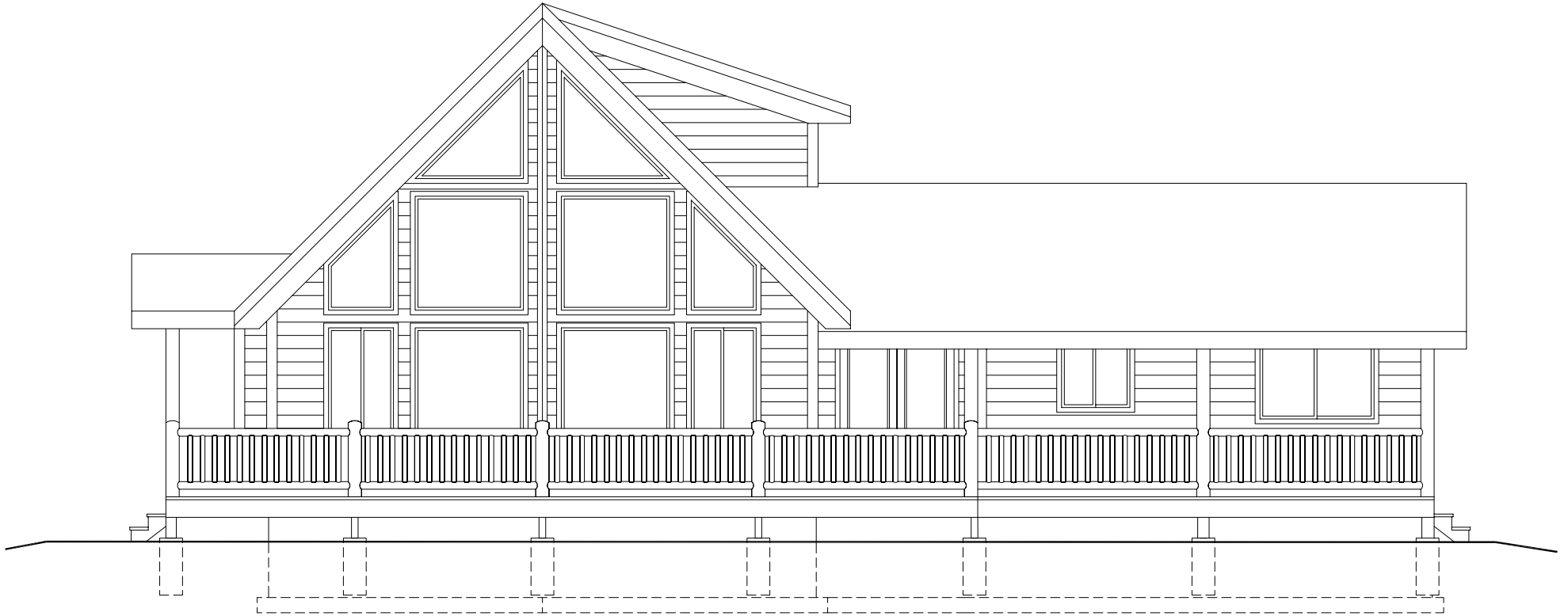

 1,516 SF



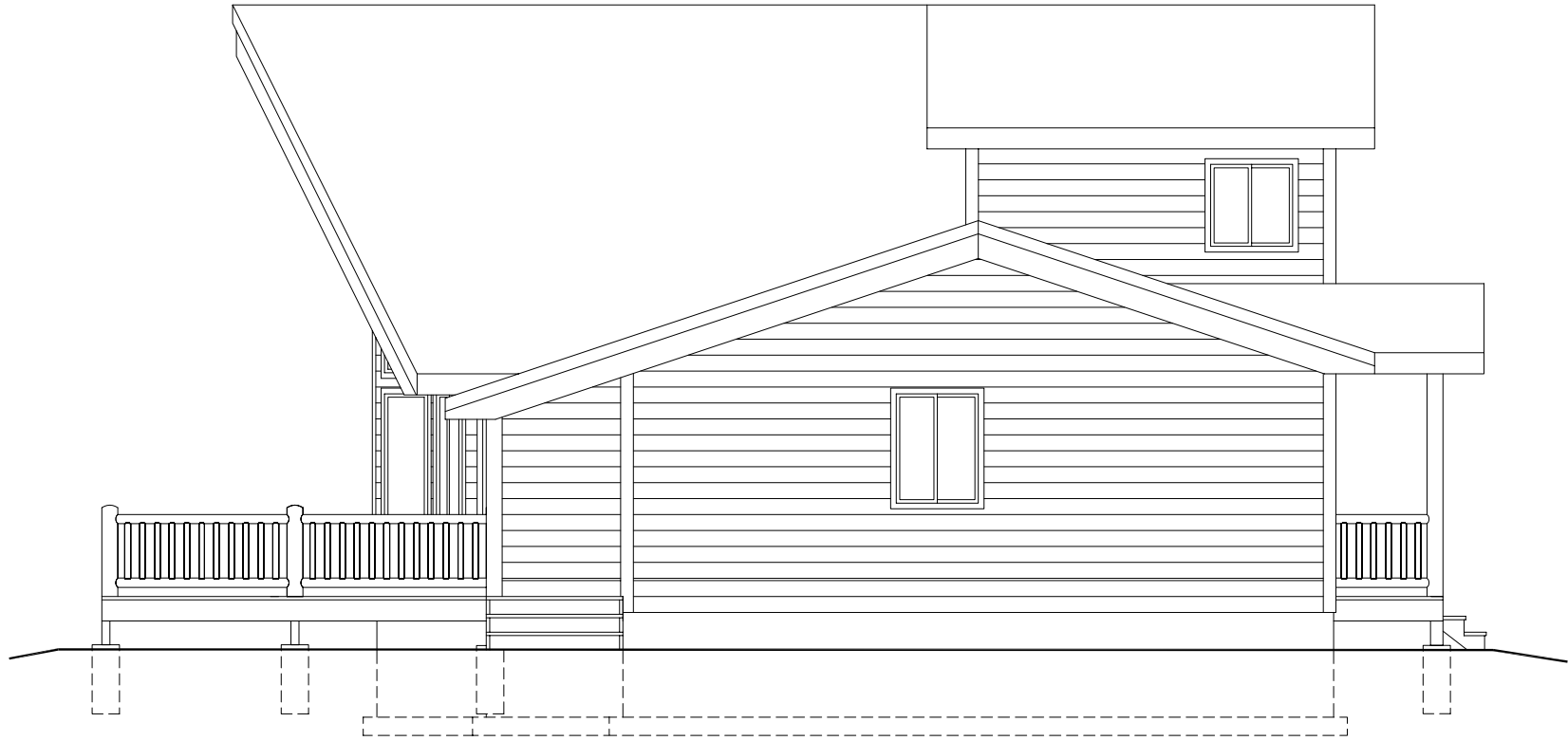

 367 SF



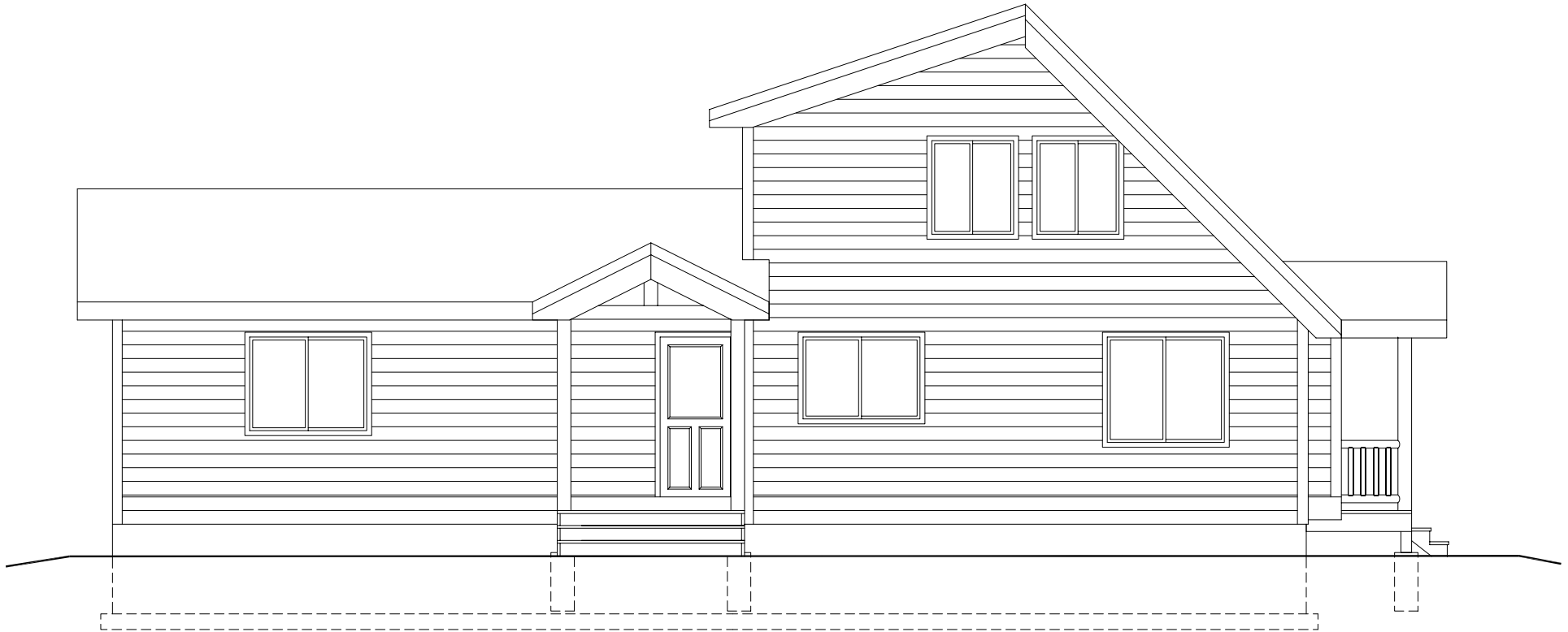

ELEVATION



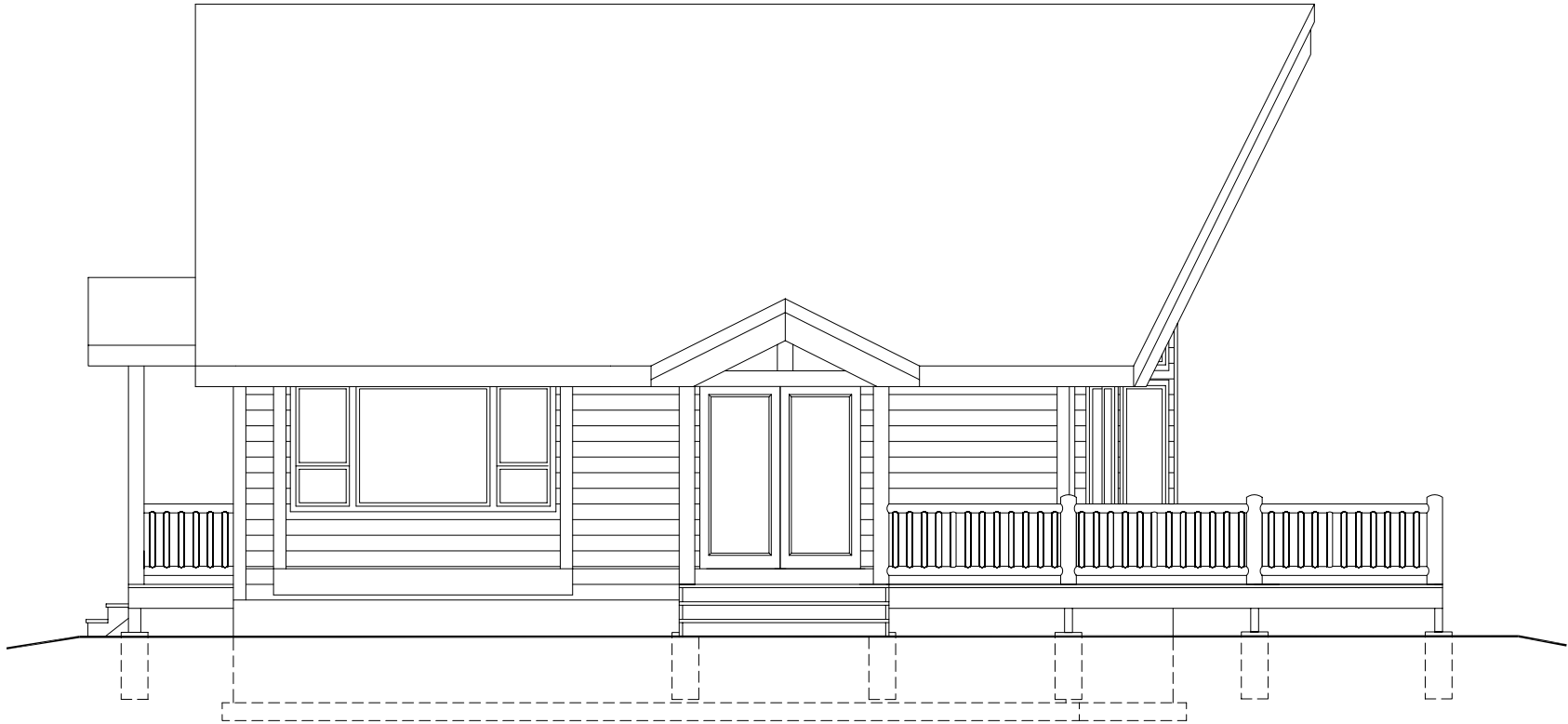
