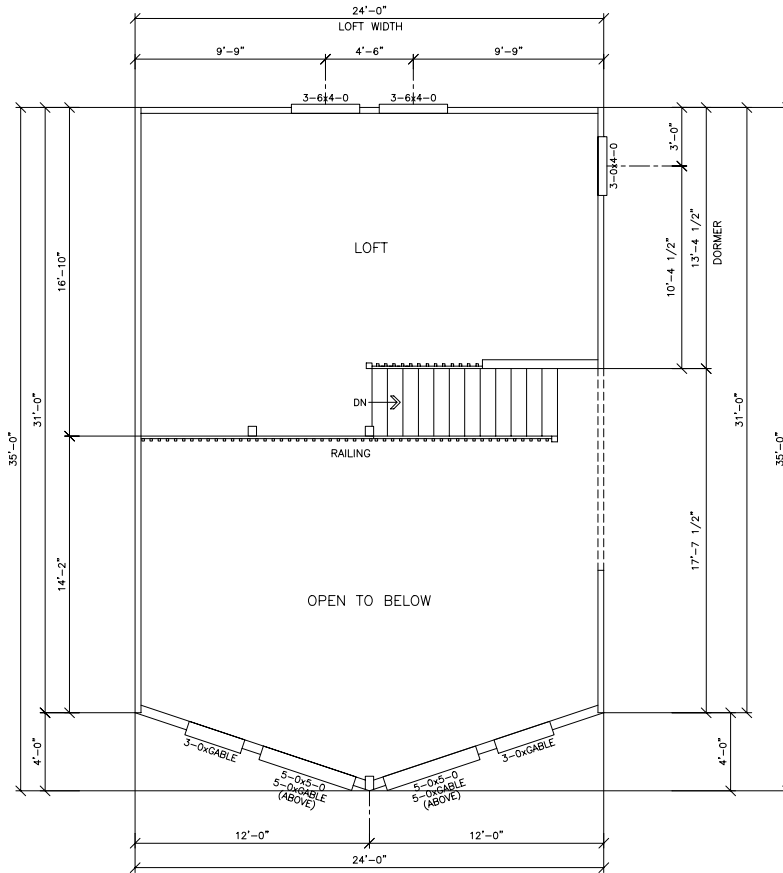


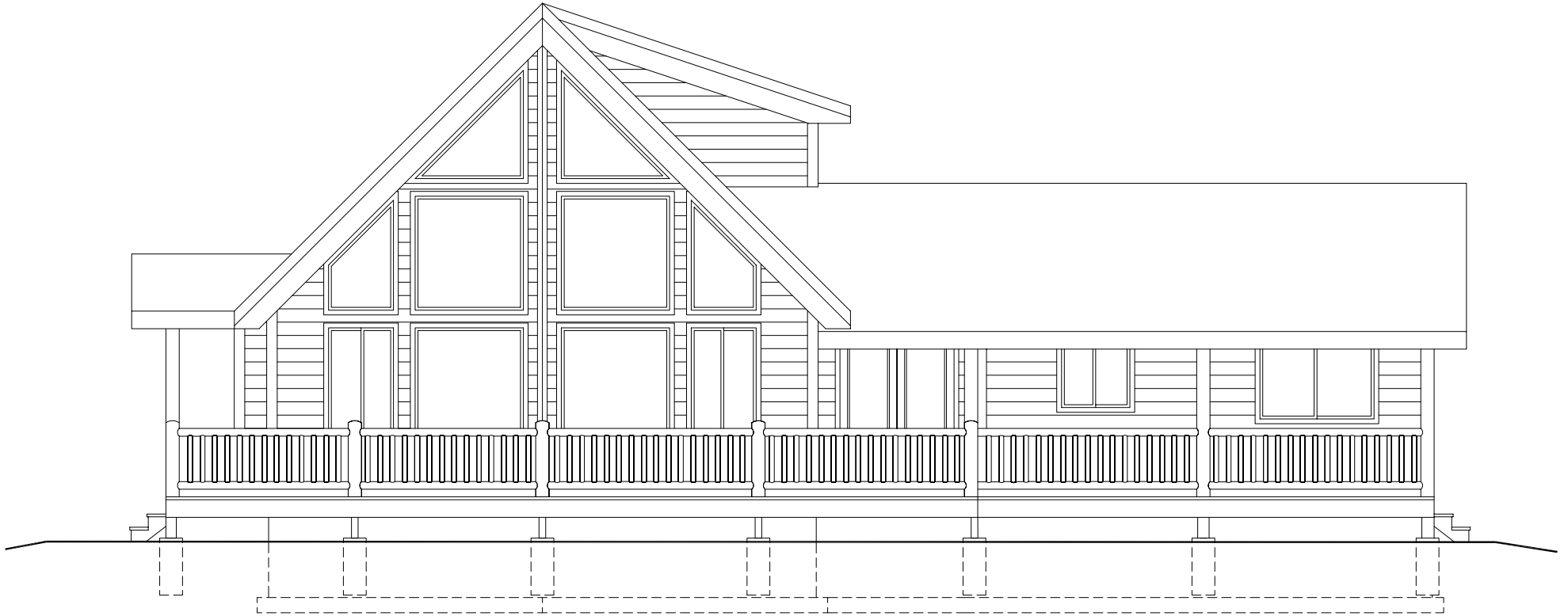

 1,516 SF



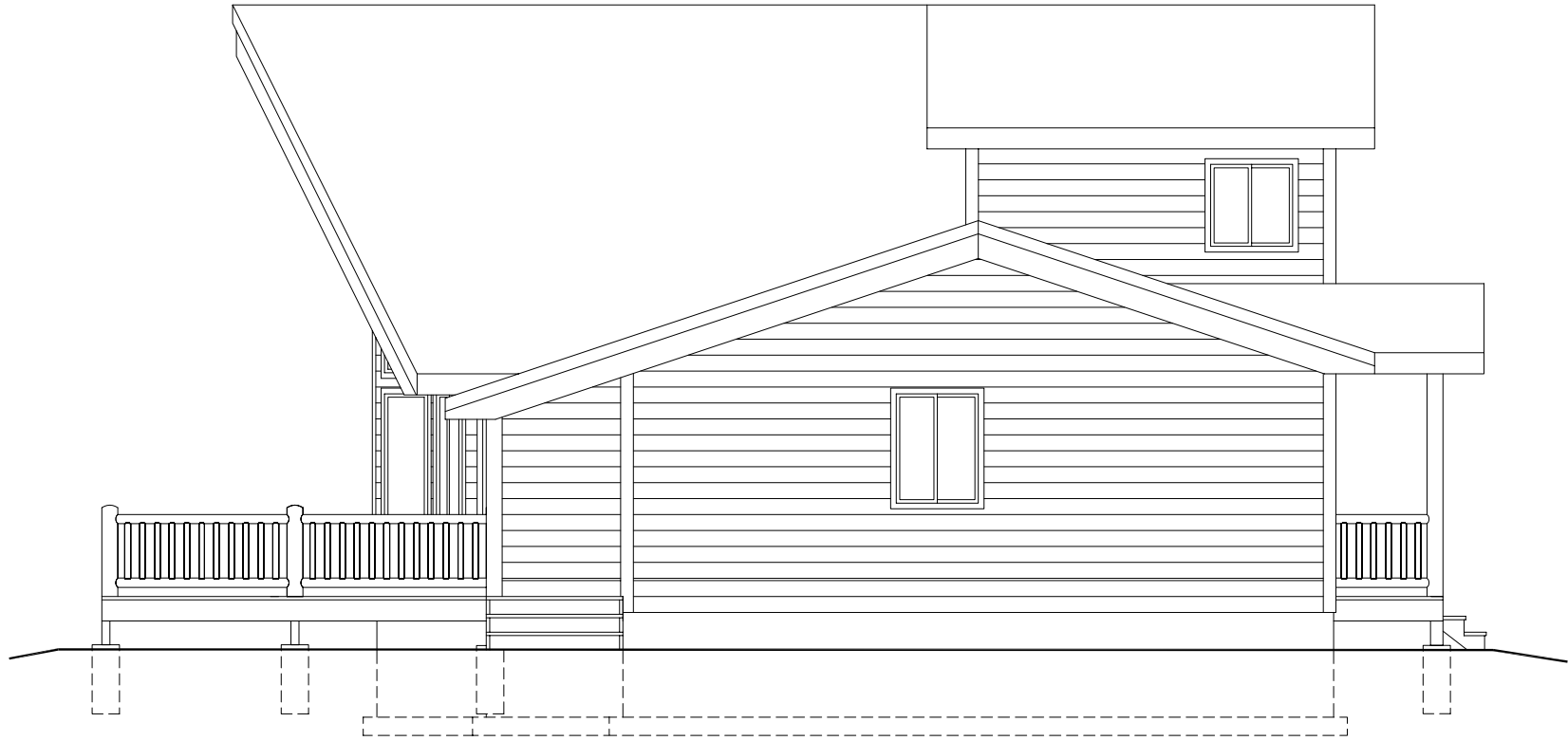

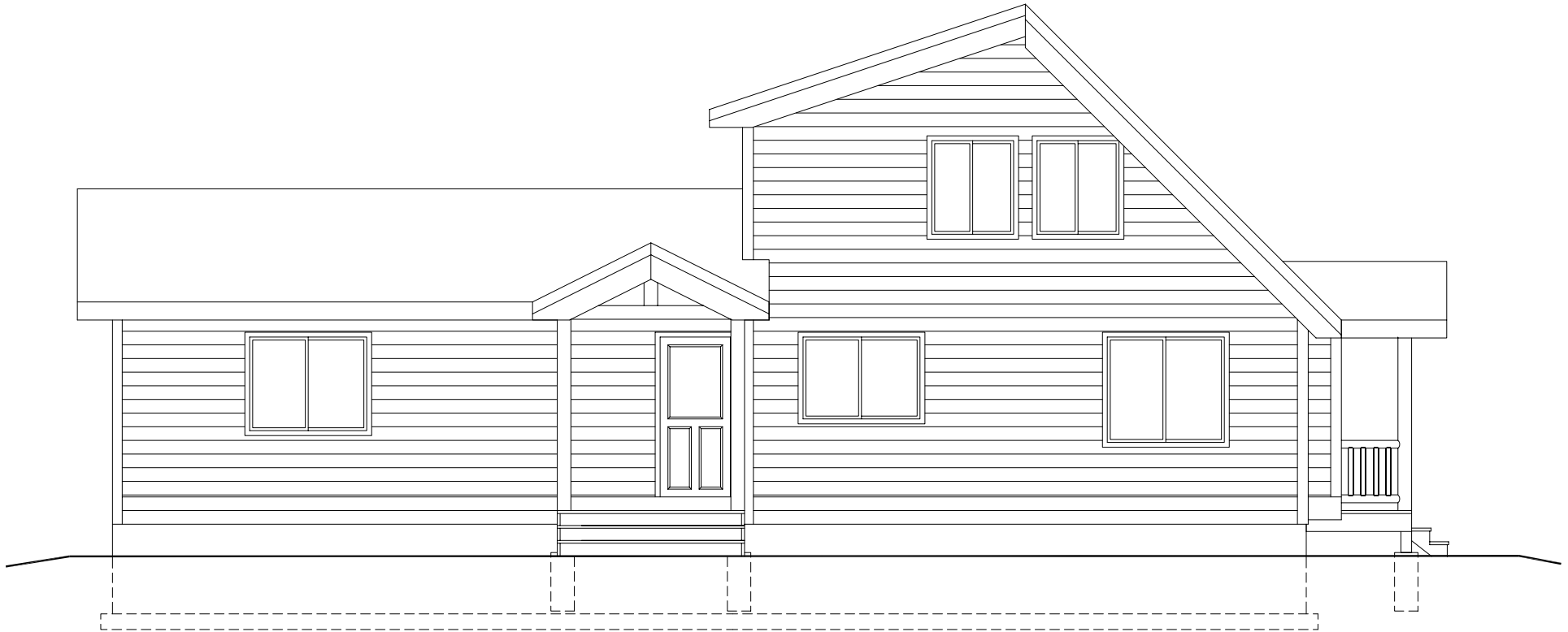

ELEVATION



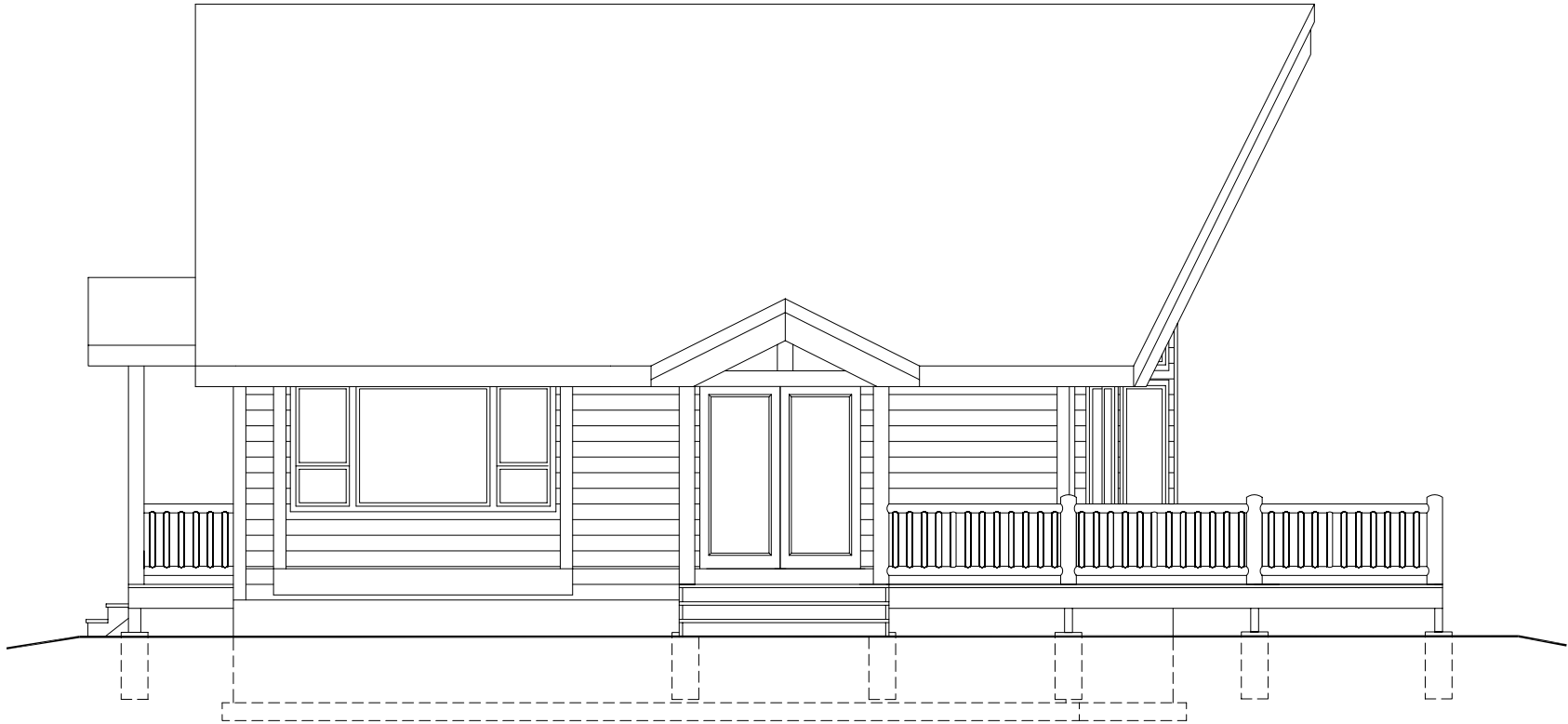
