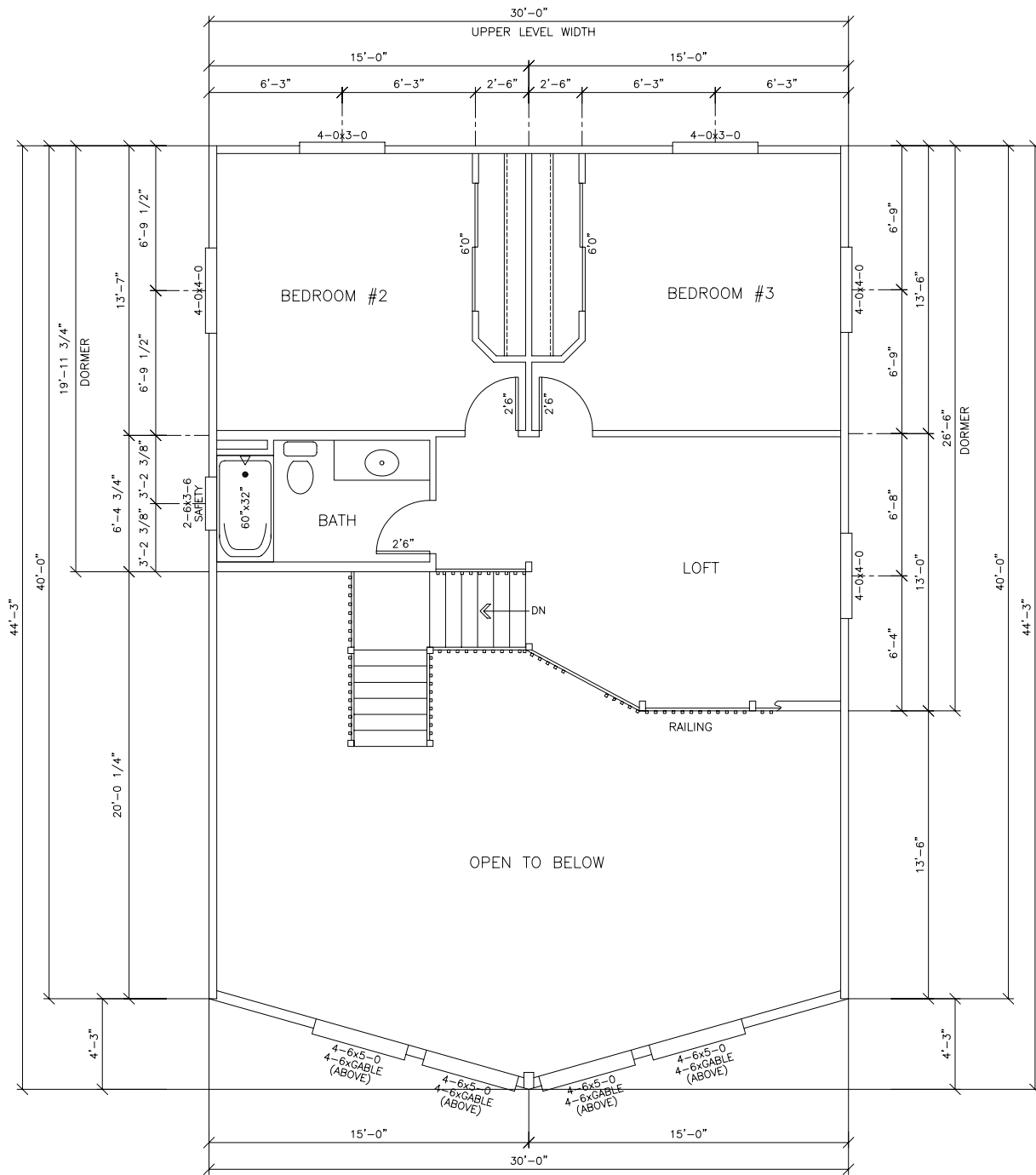

 1,264 SF



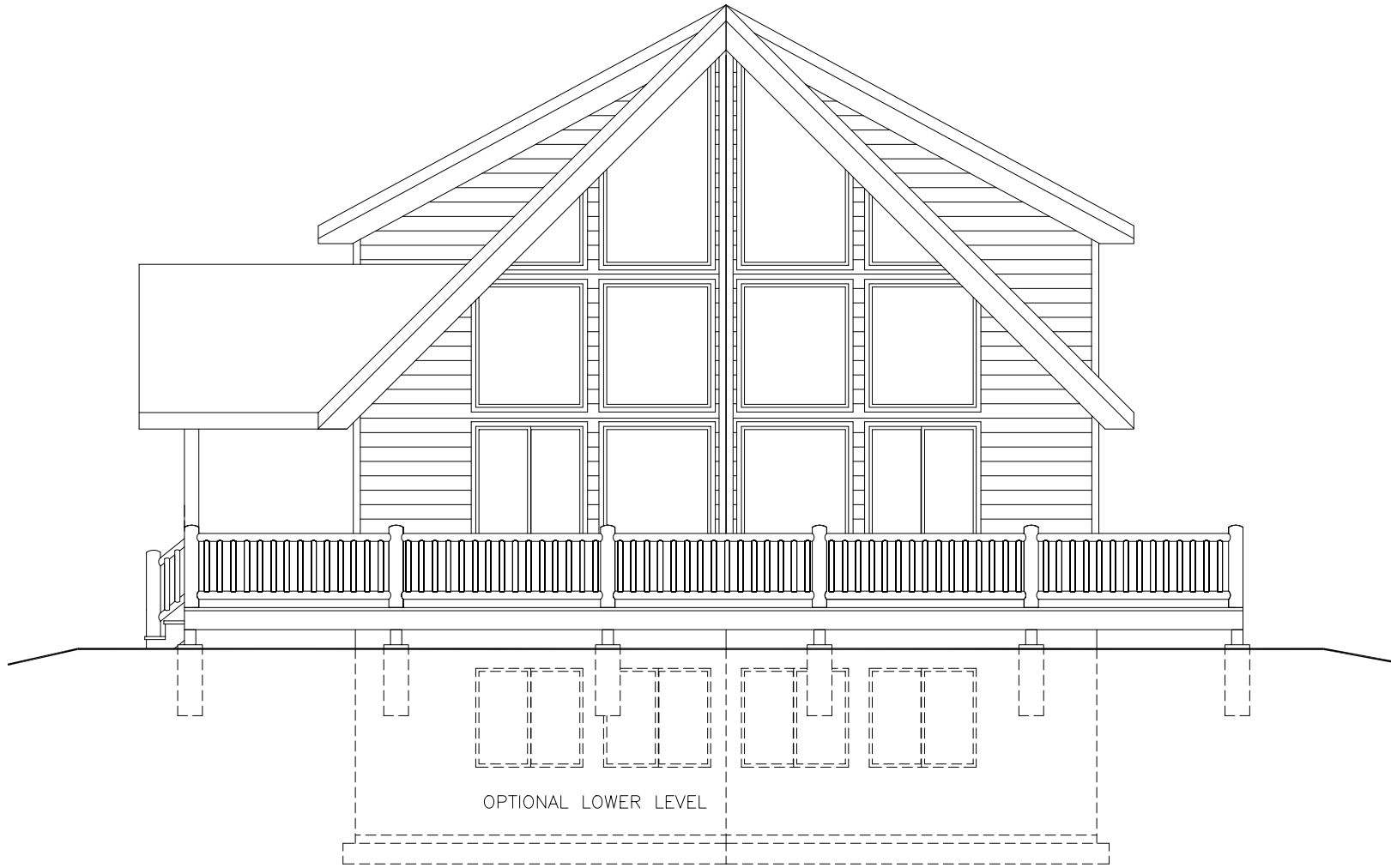

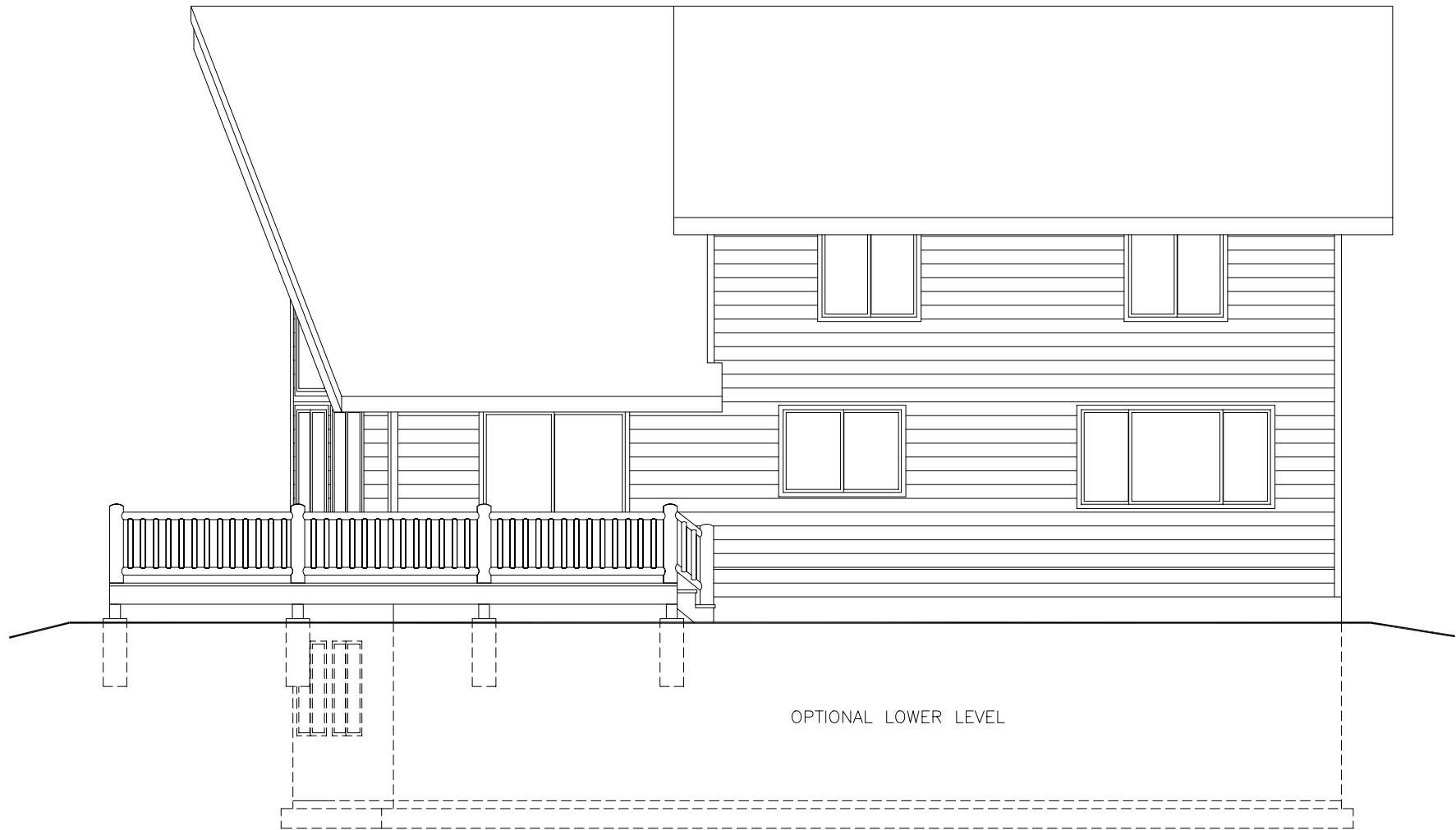

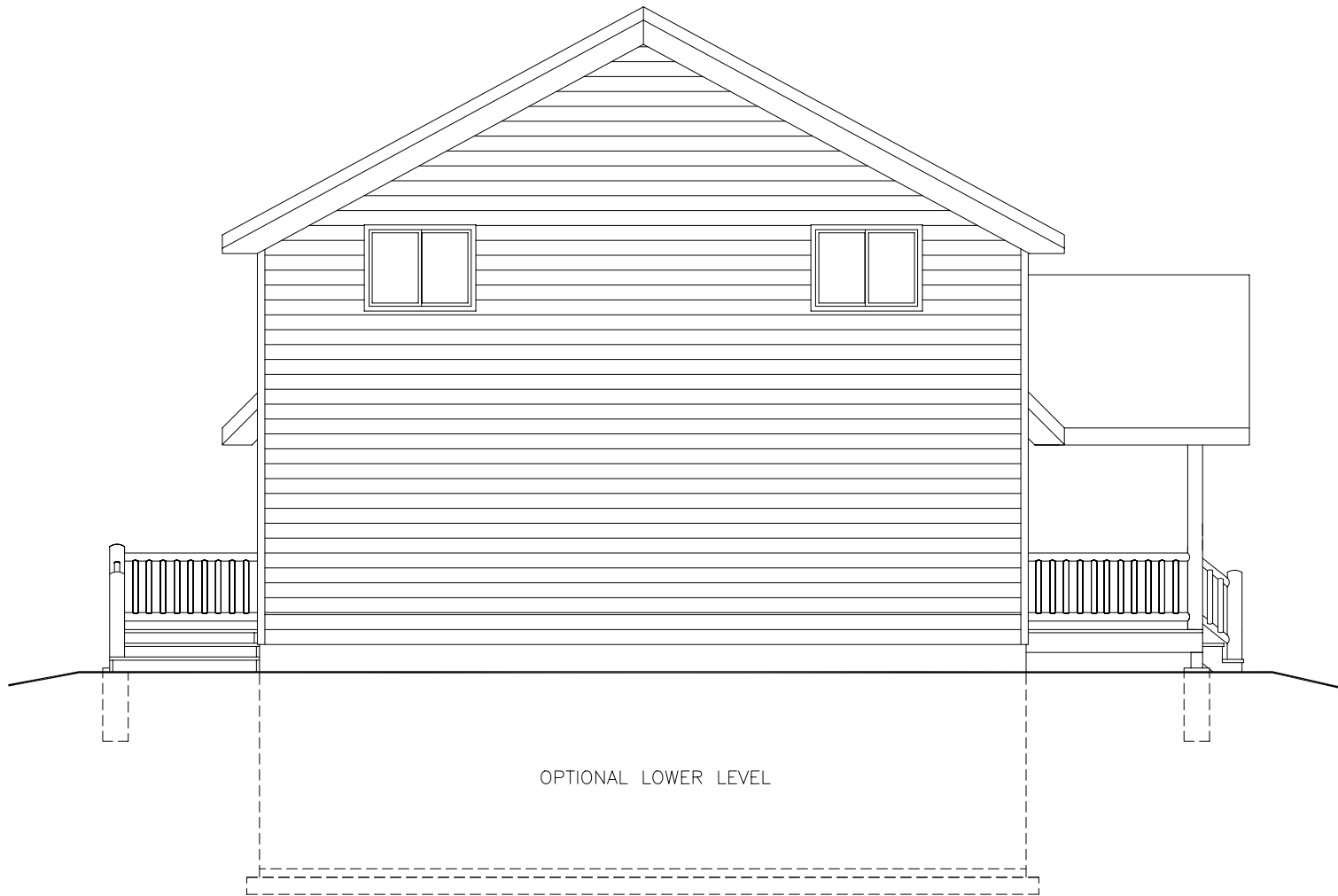
