ELEVATION



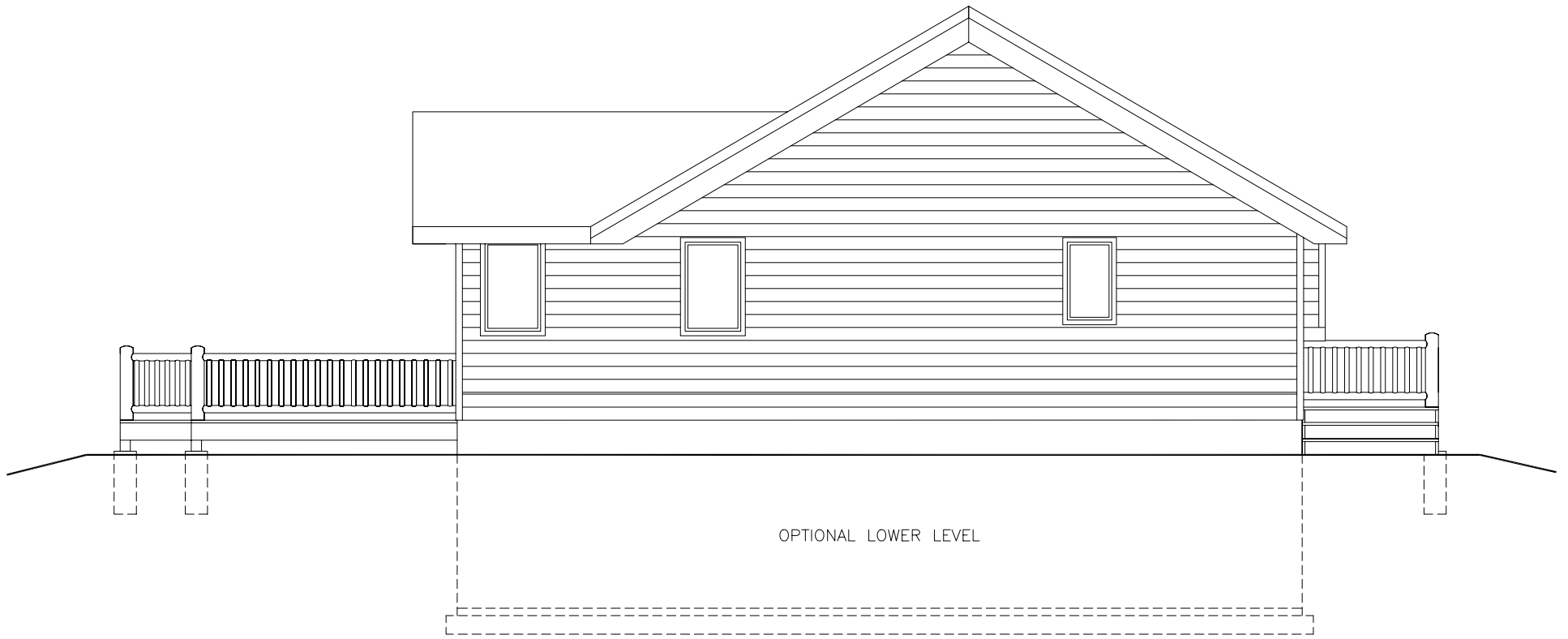
