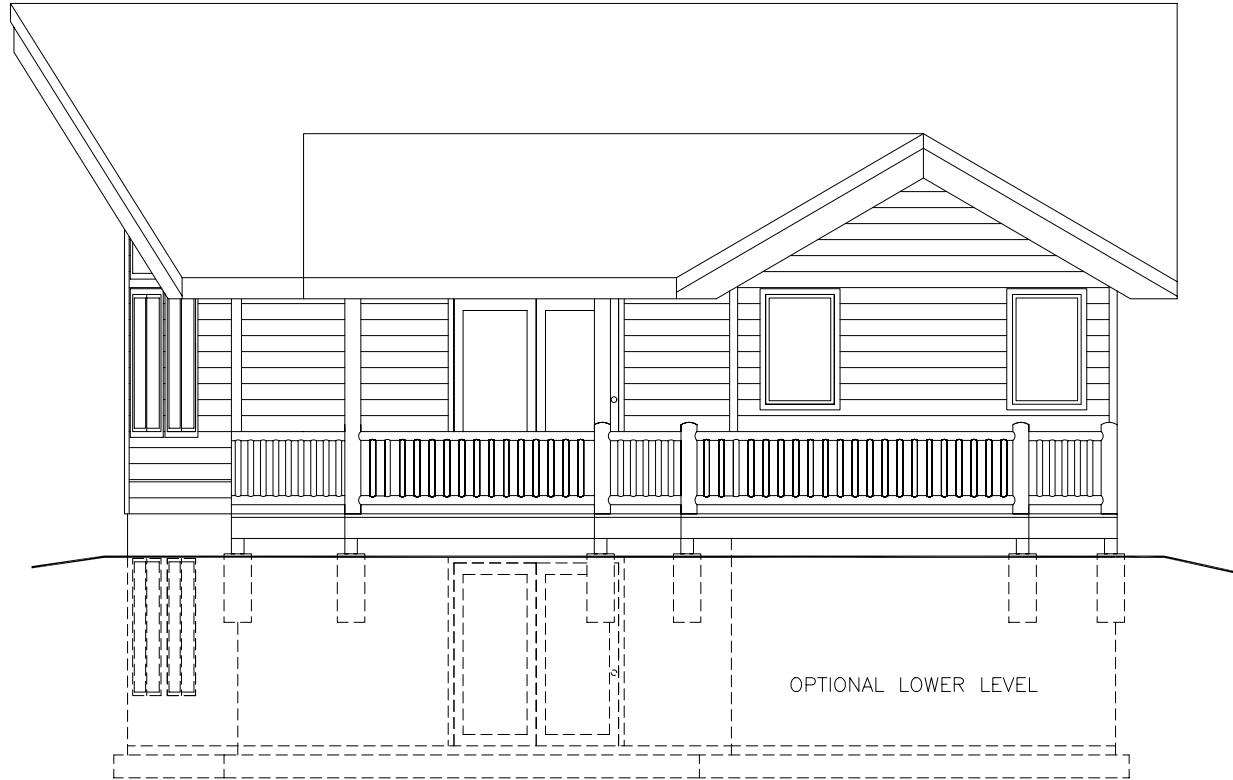

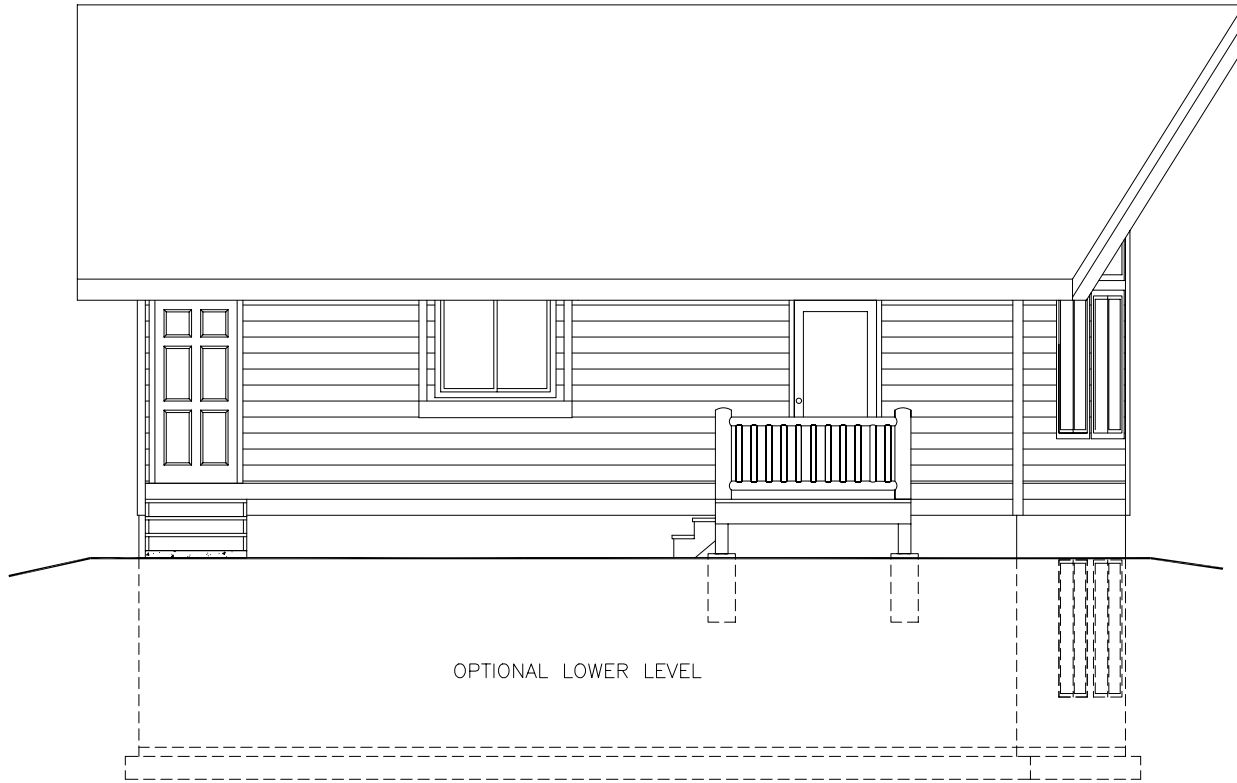

ELEVATION



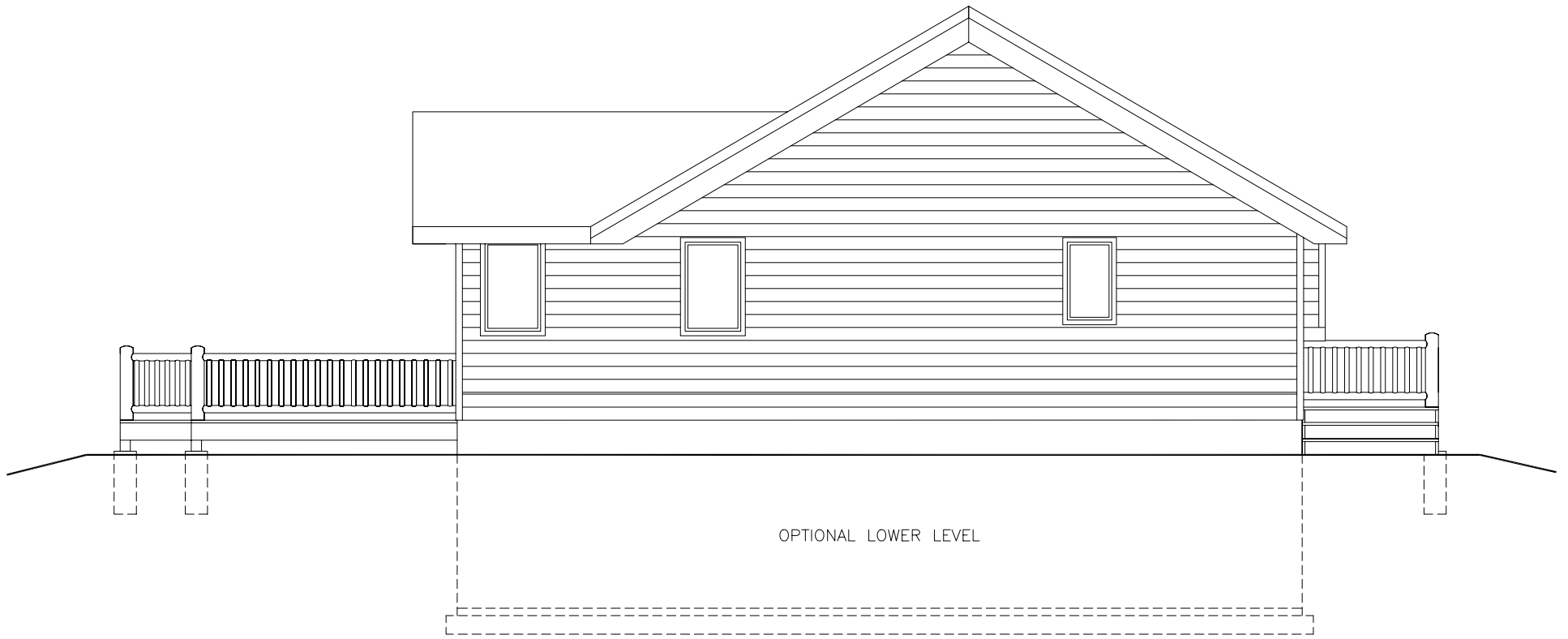
