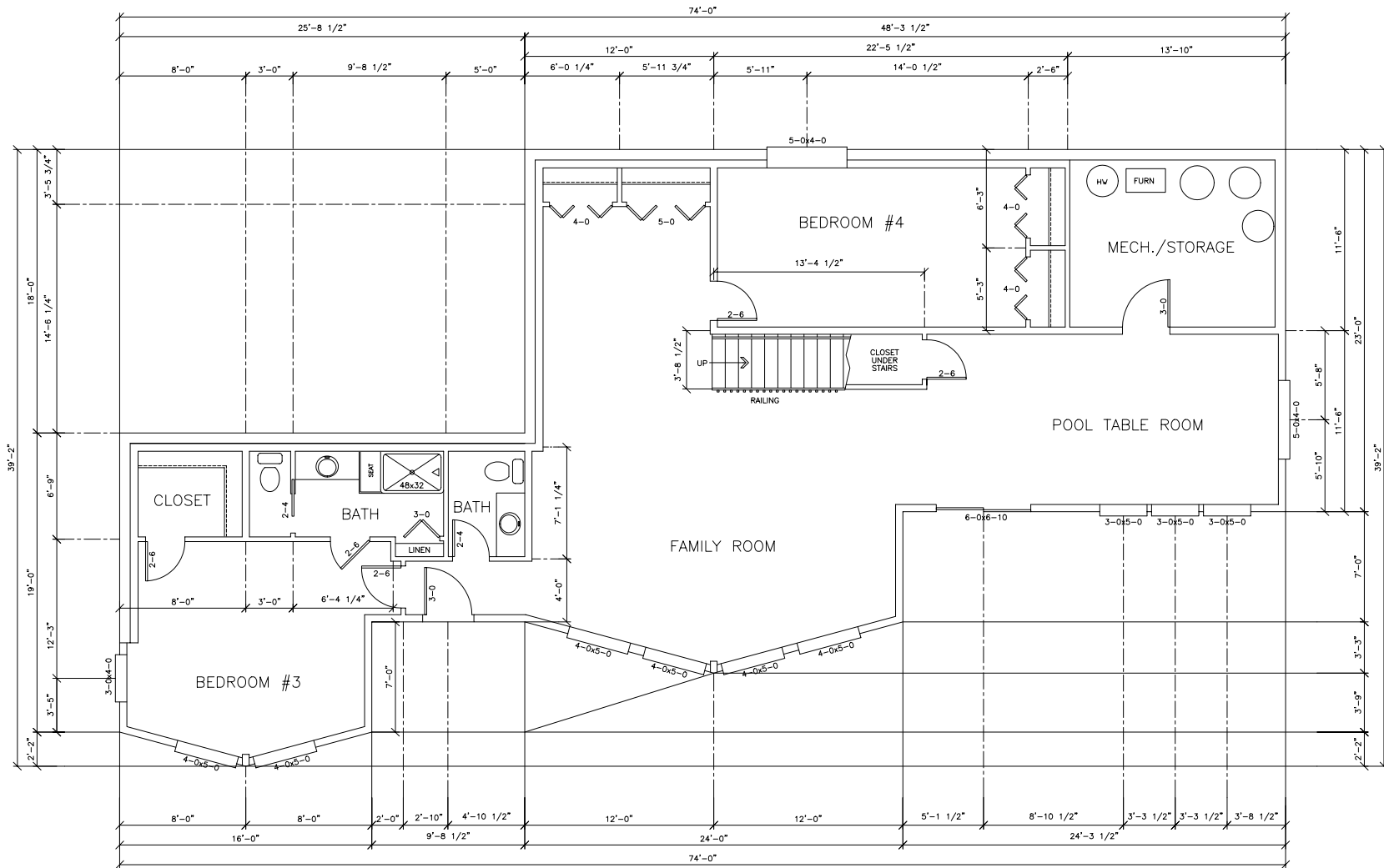

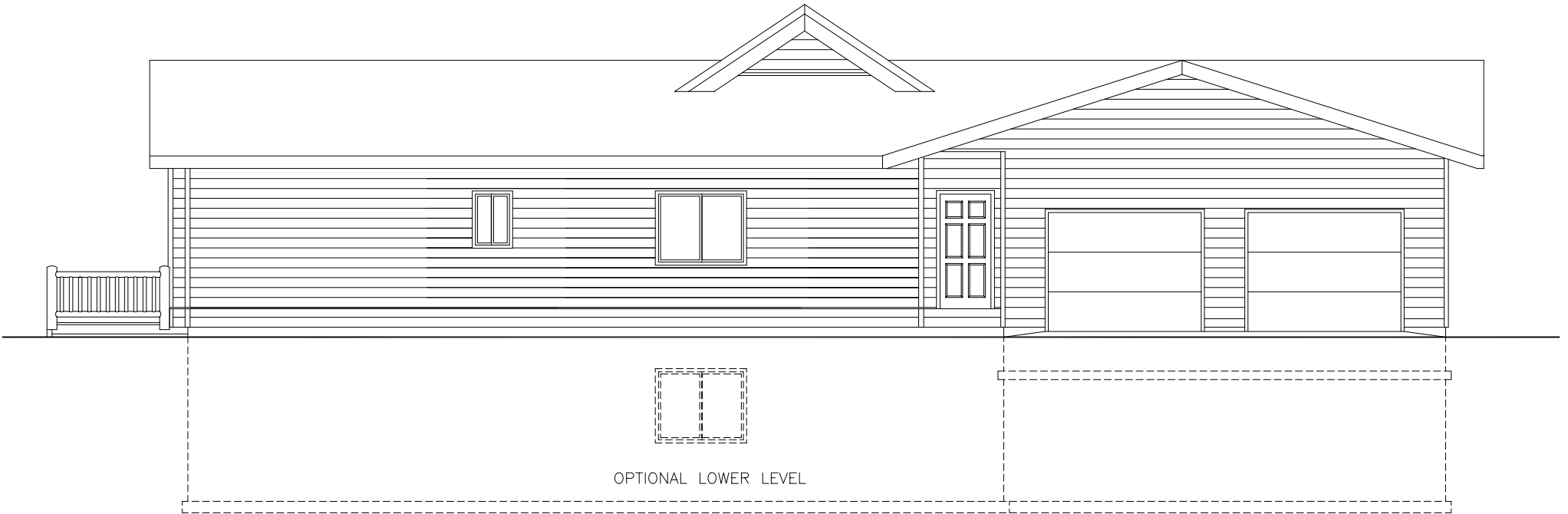

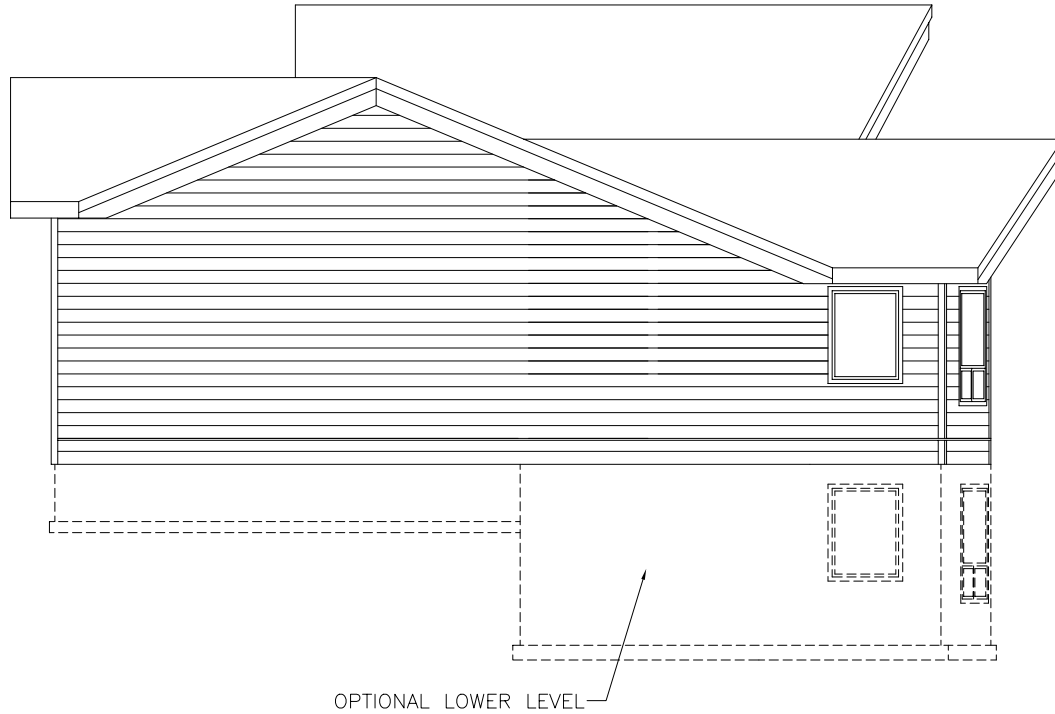
**CONIFER STUDY PLAN**
