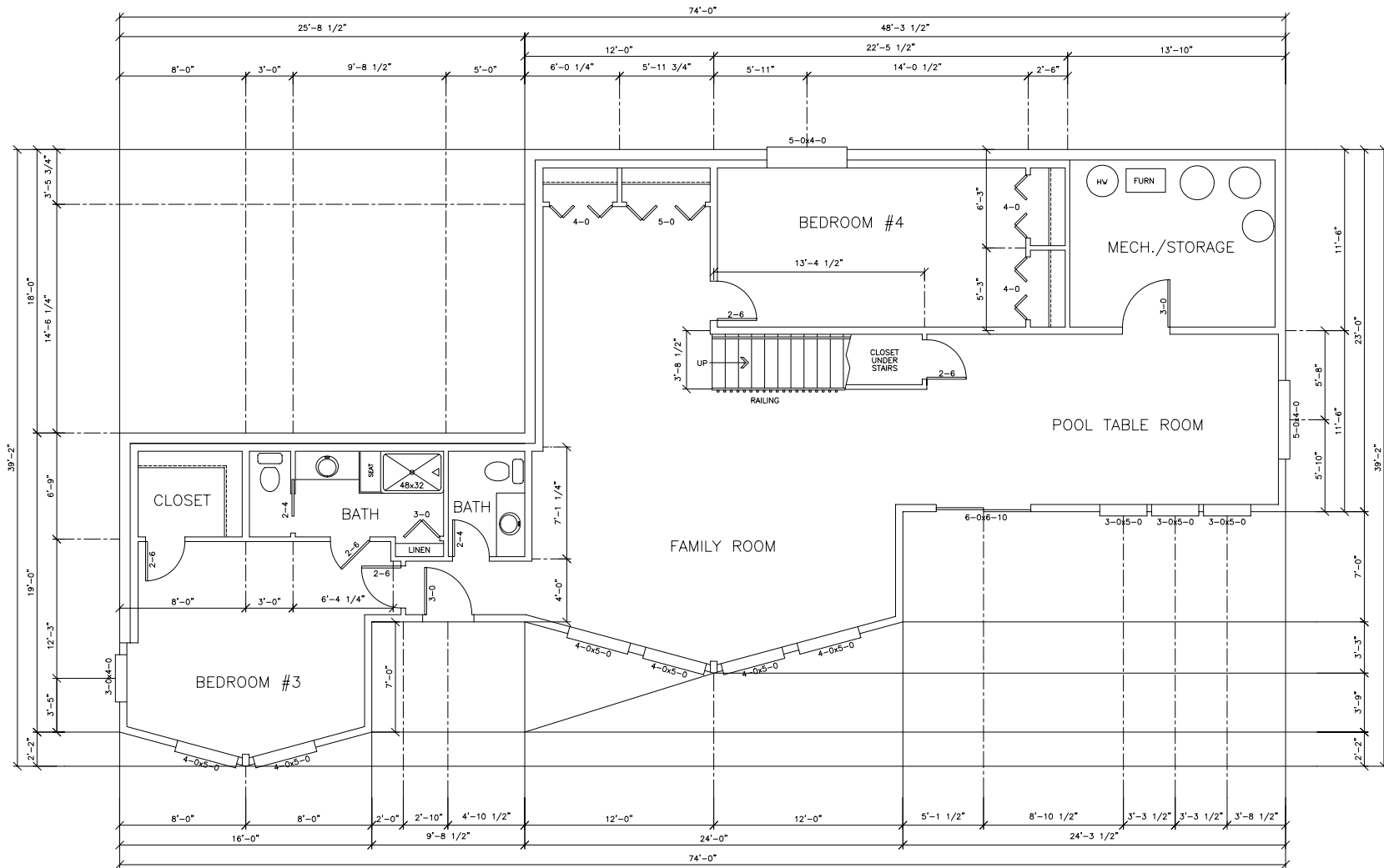

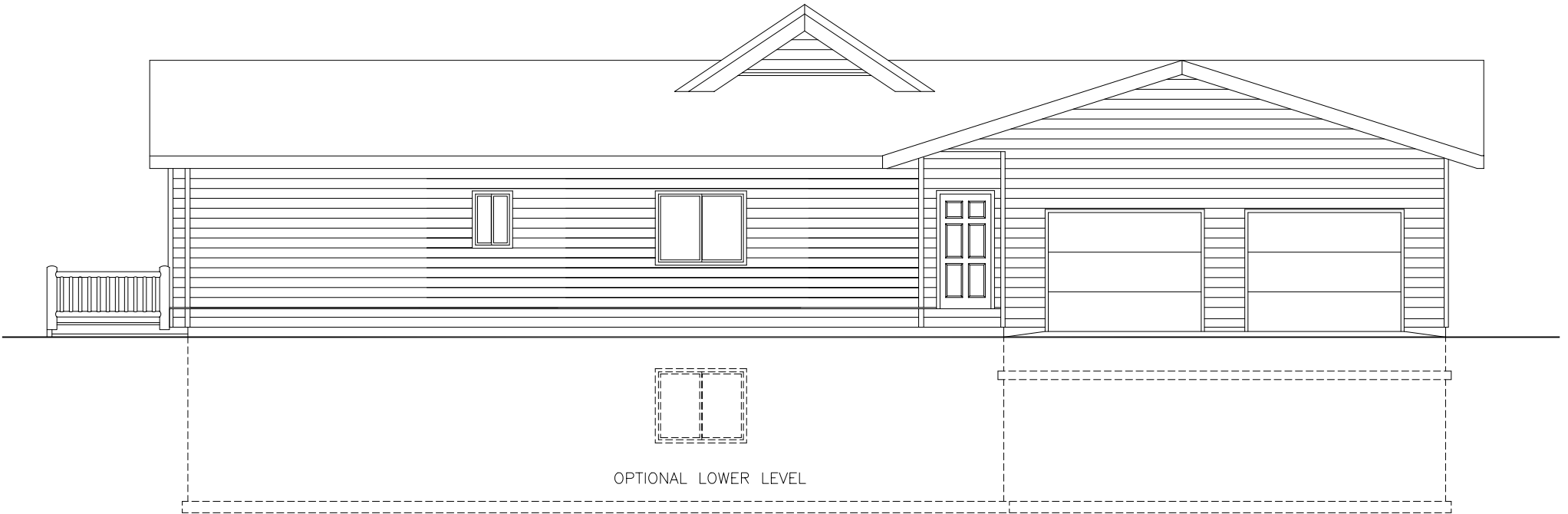

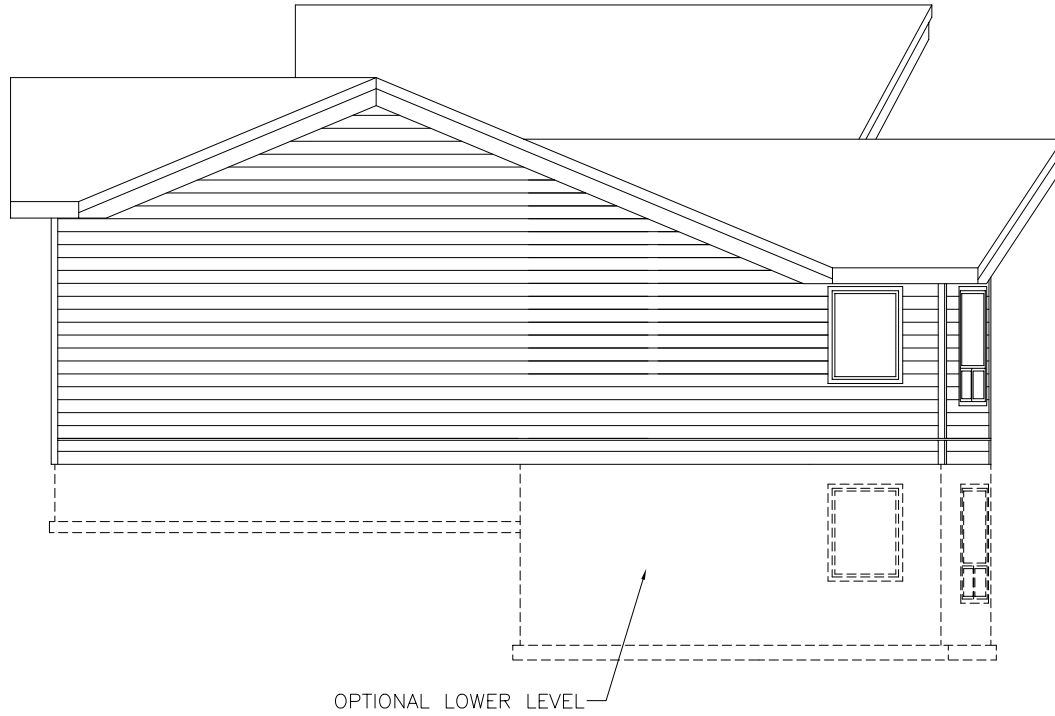
CONIFER STUDY PLAN
