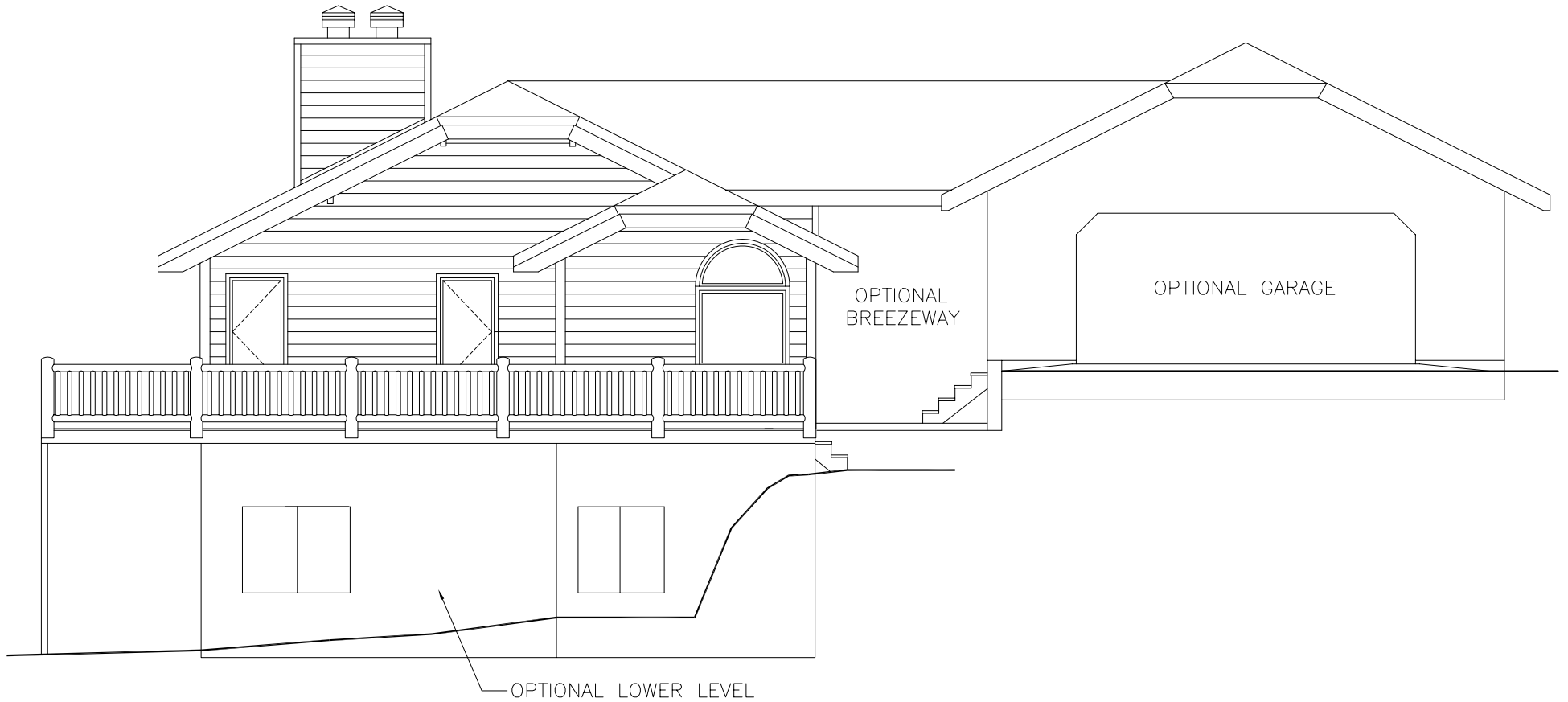

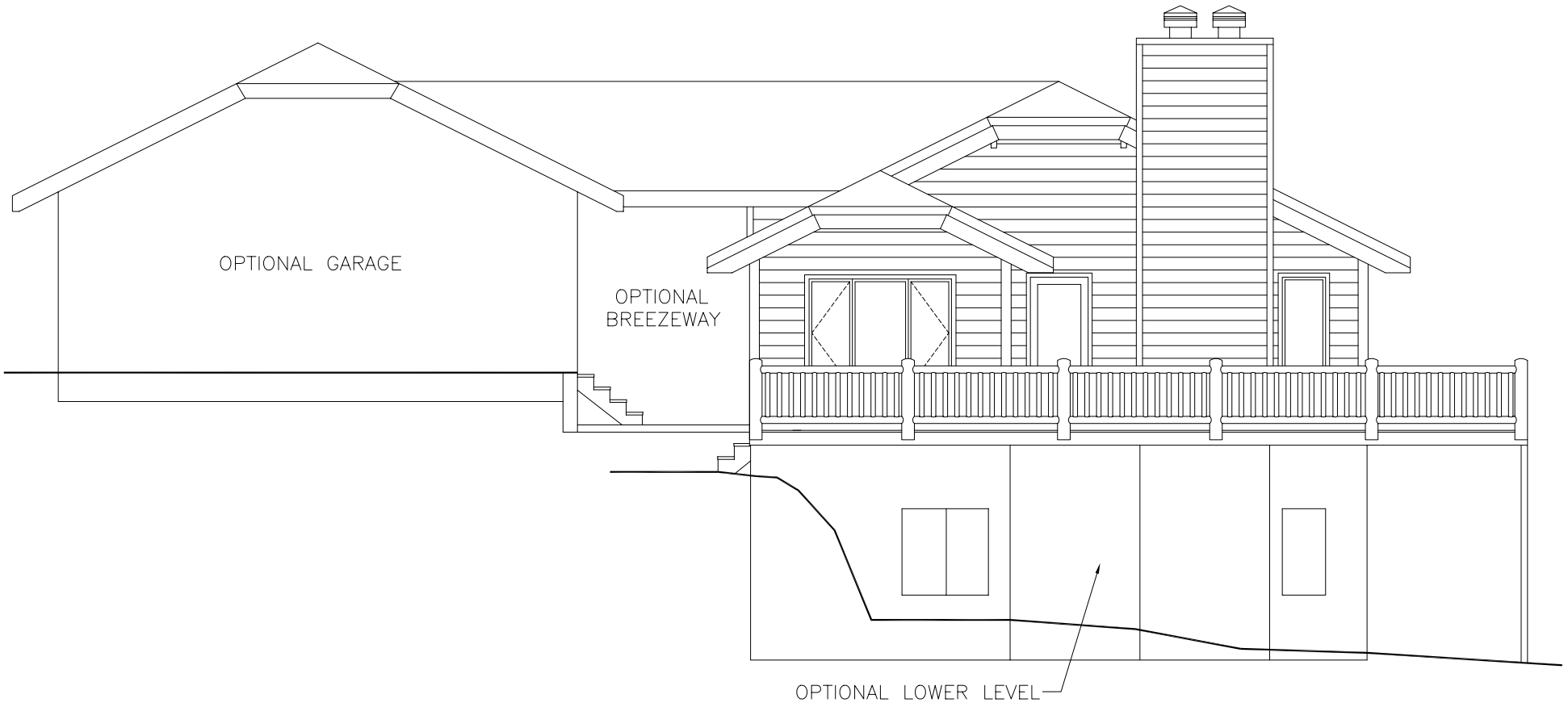
ESTES RANCH STUDY PLAN

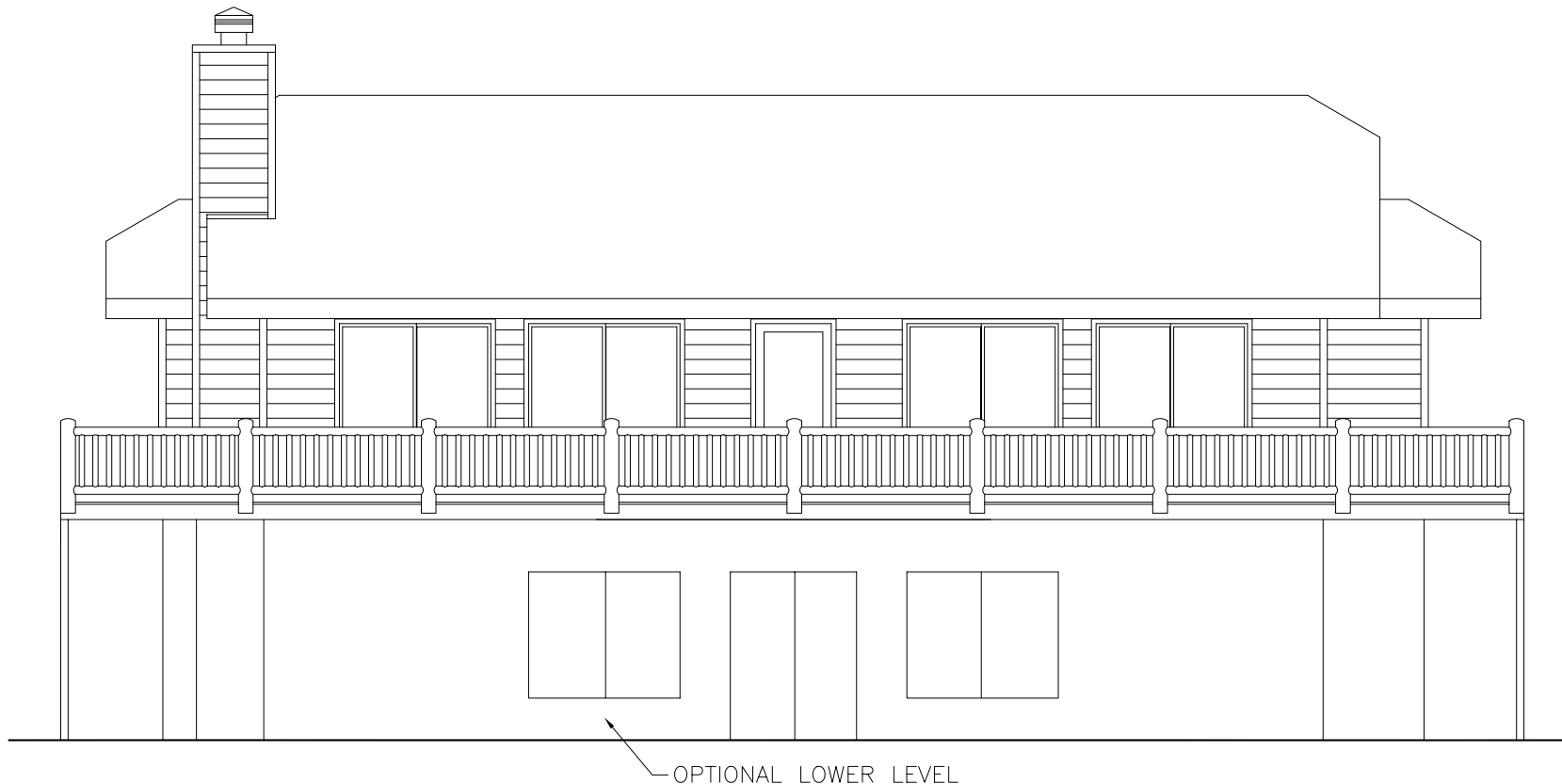
ESTES RANCH STUDY PLAN
