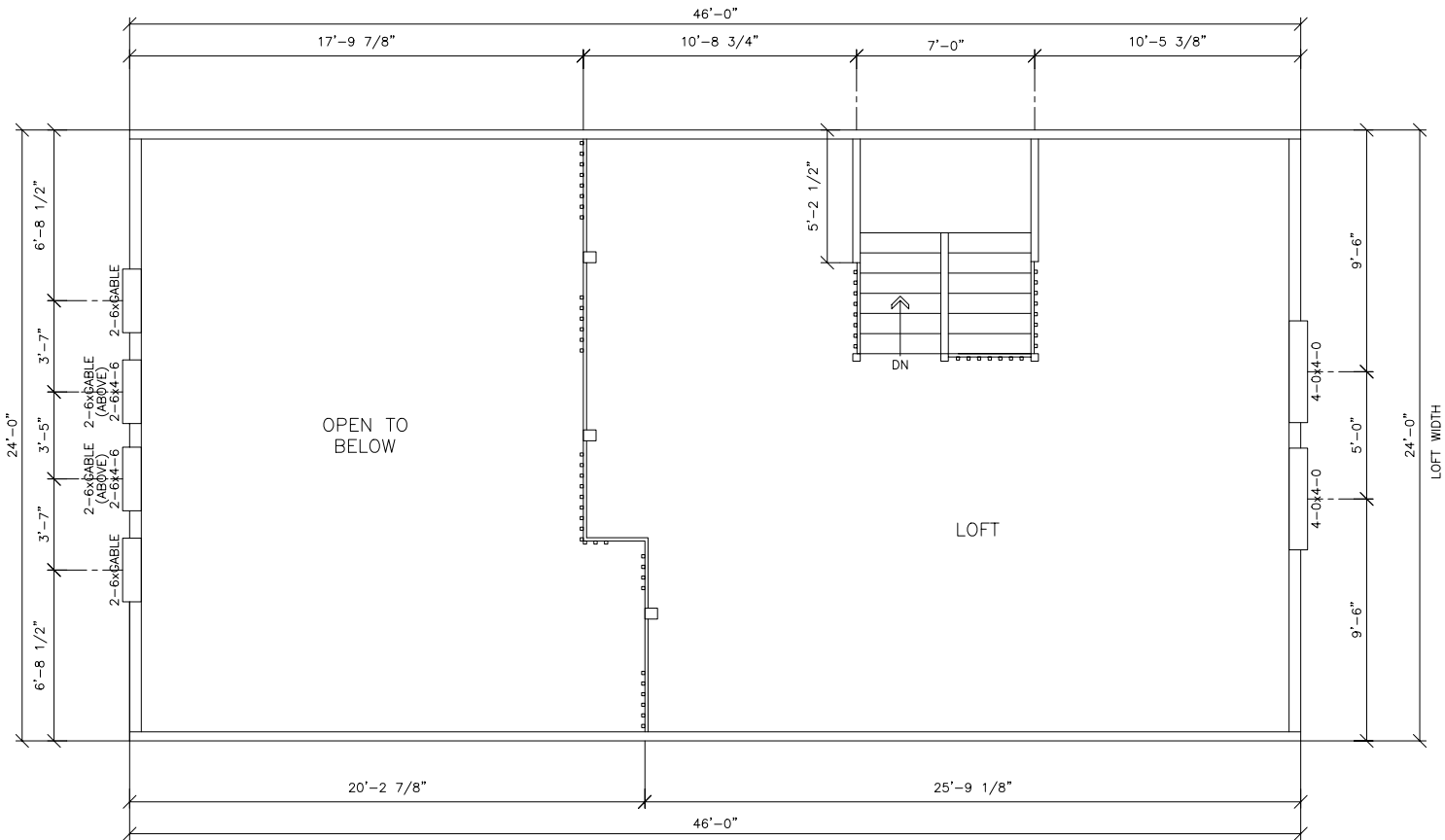

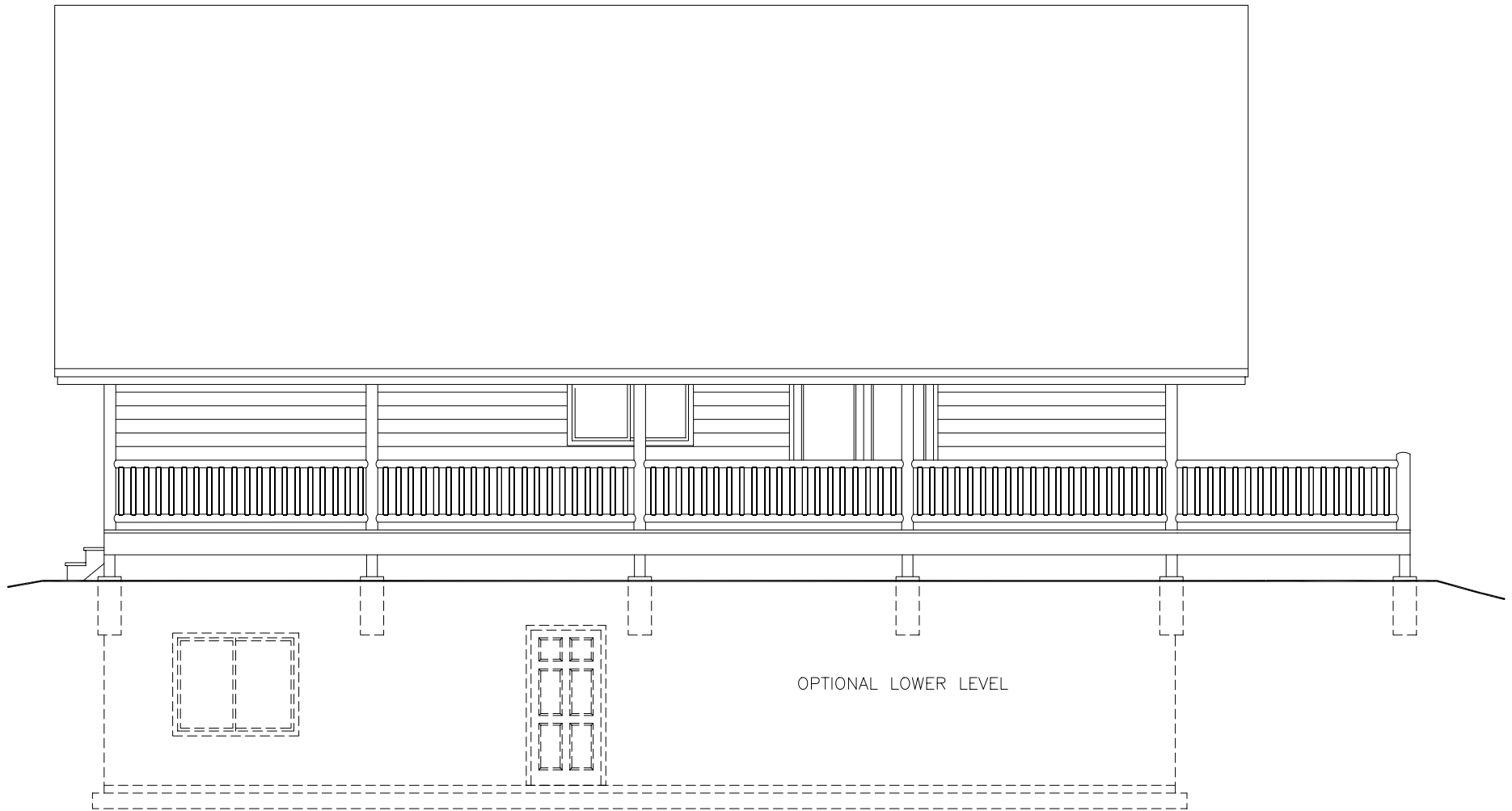
## EVERGREEN STUDY PLAN

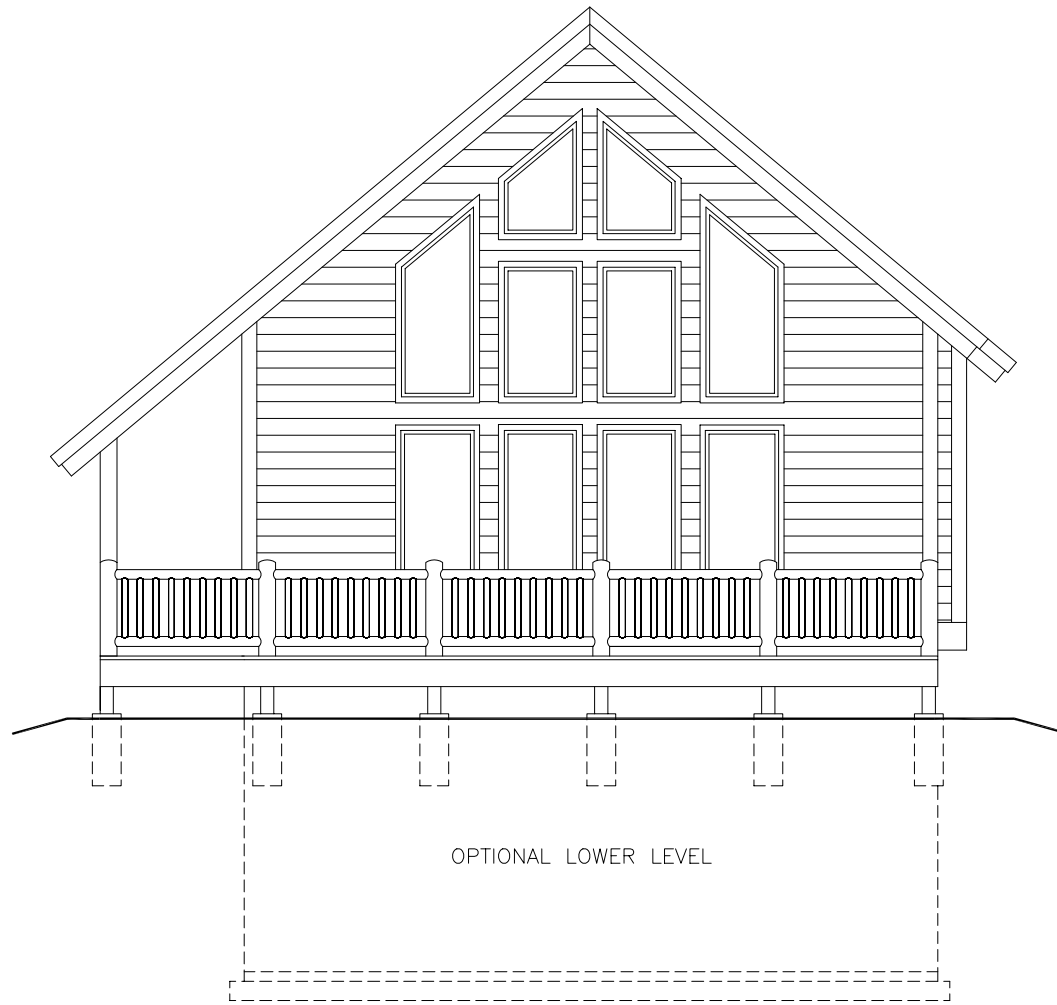
**EVERGREEN STUDY PLAN**

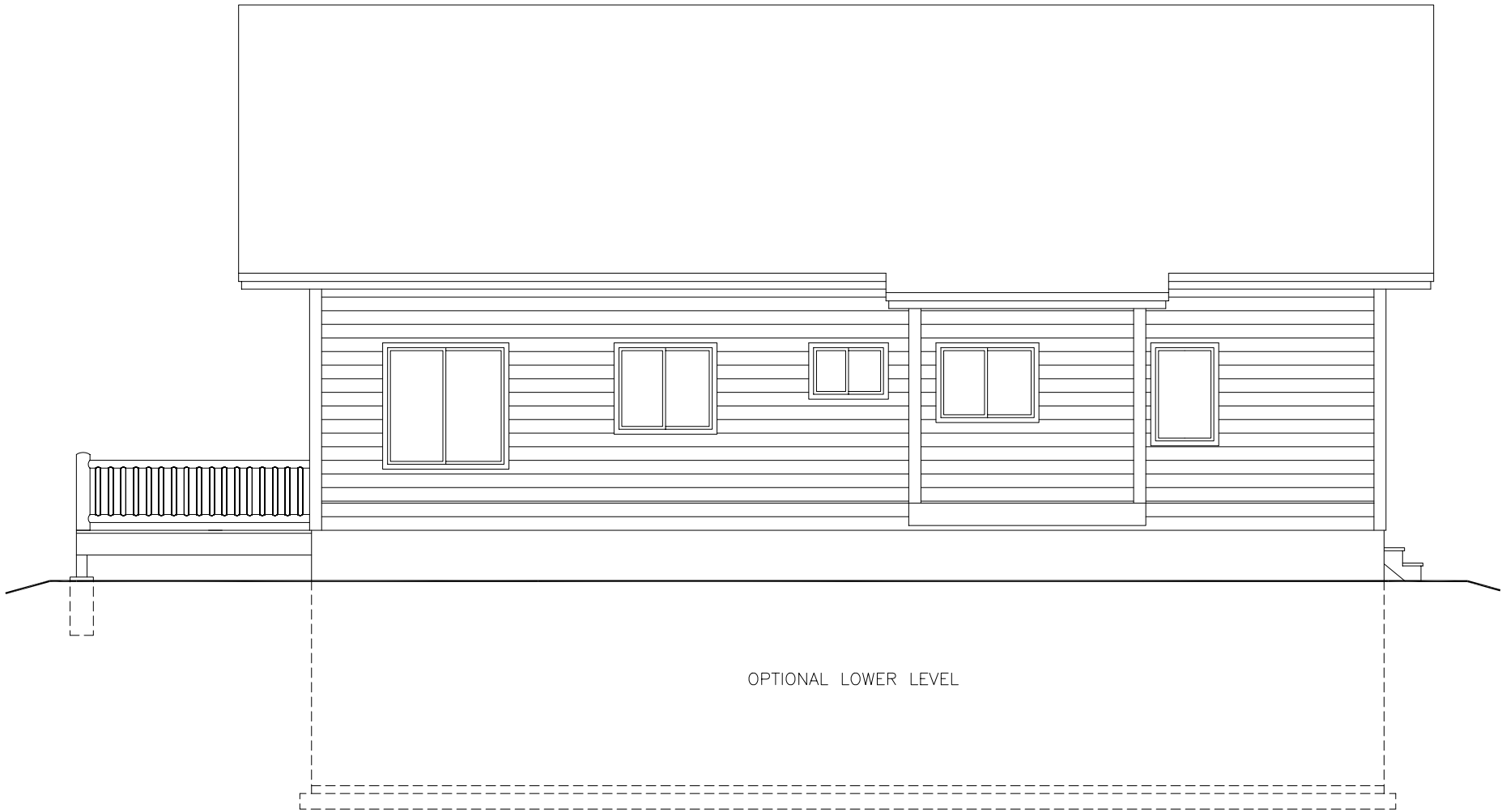
ELEVATION

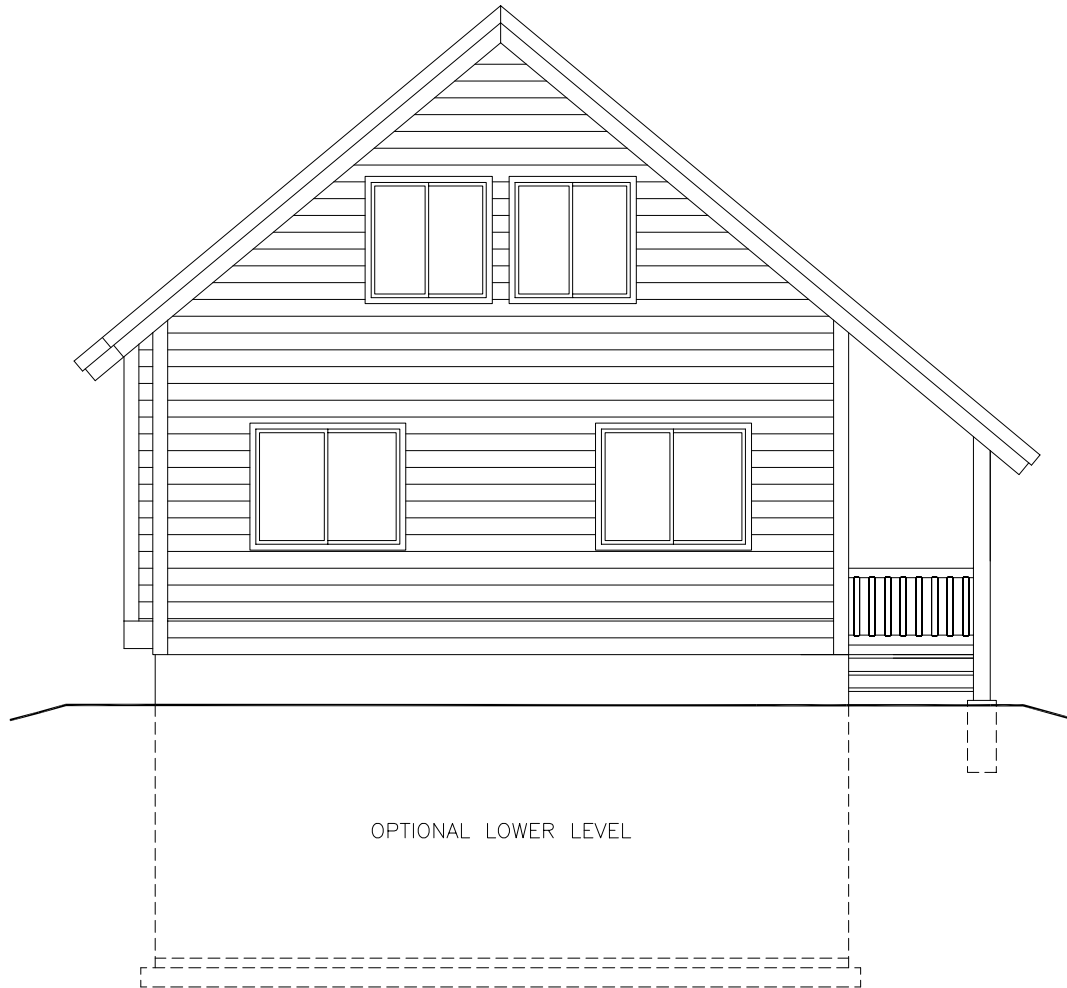
# EVERGREEN STUDY PLAN
