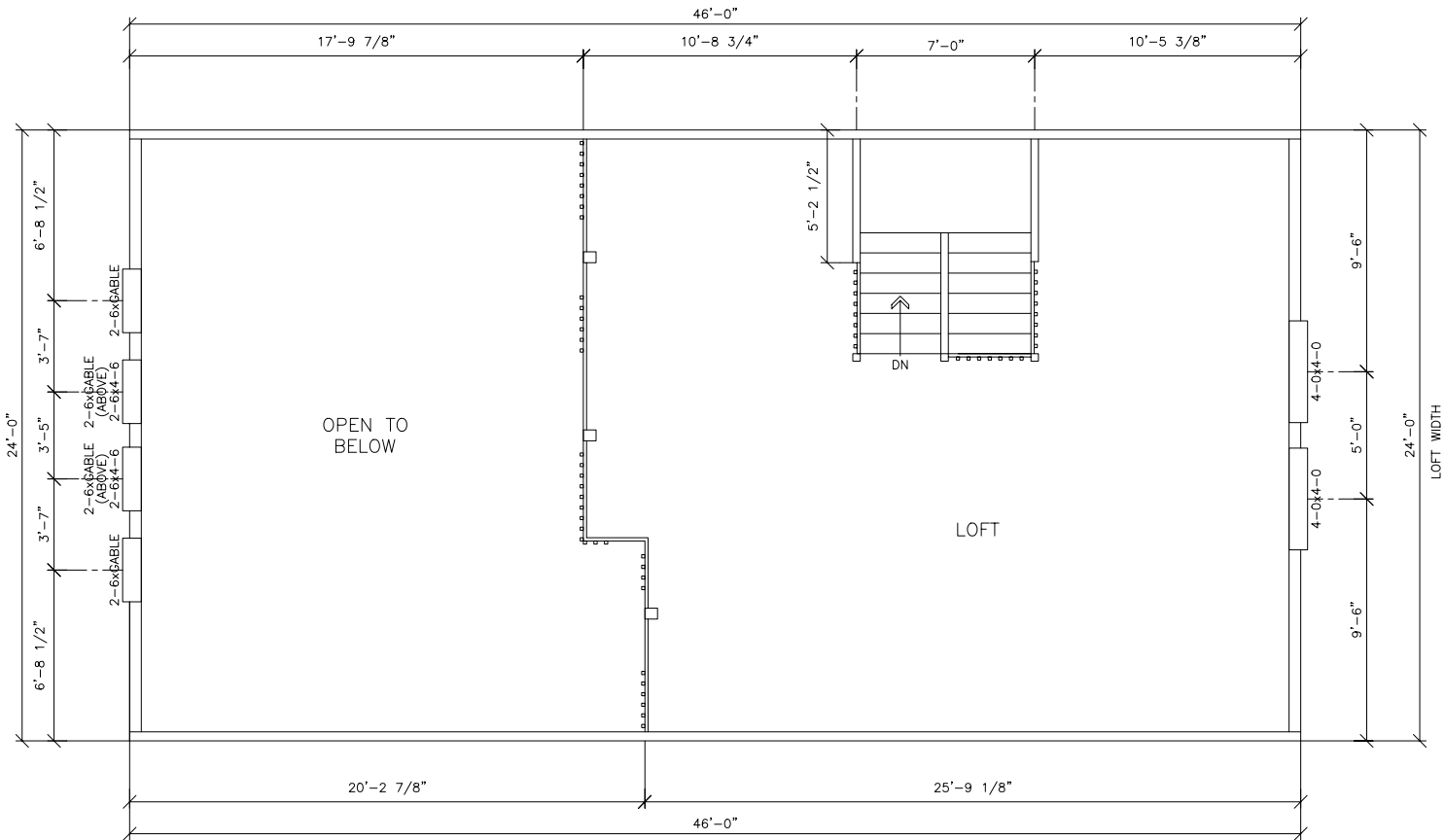

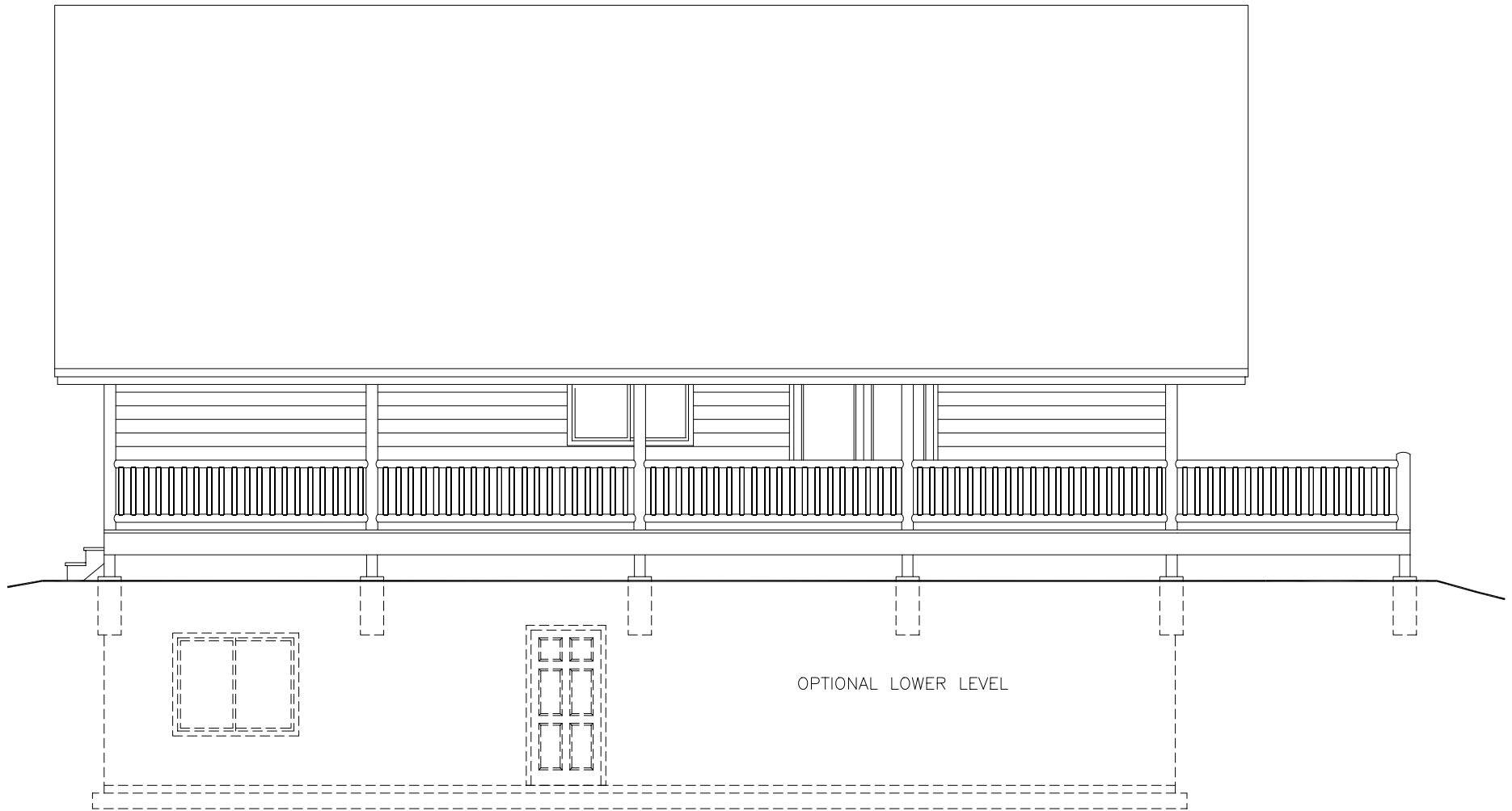
EVERGREEN STUDY PLAN

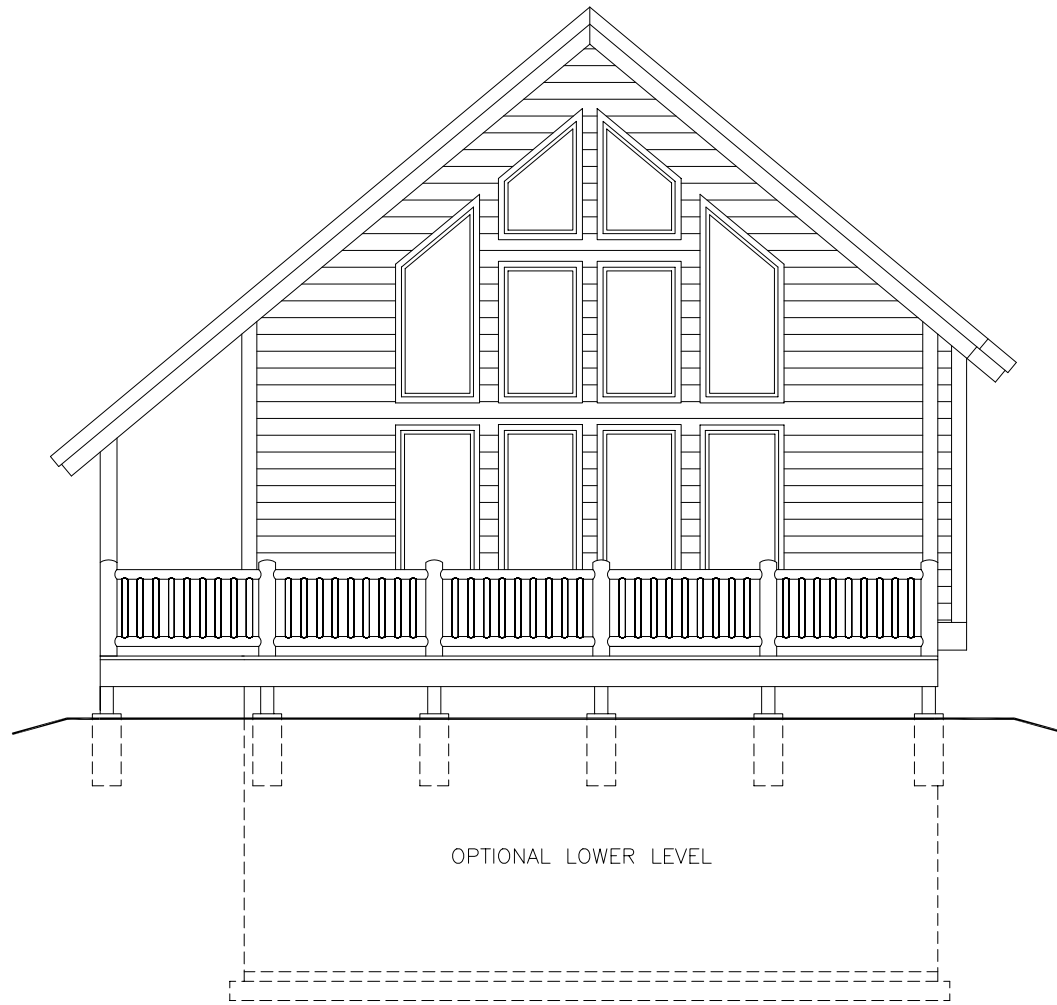
EVERGREEN STUDY PLAN

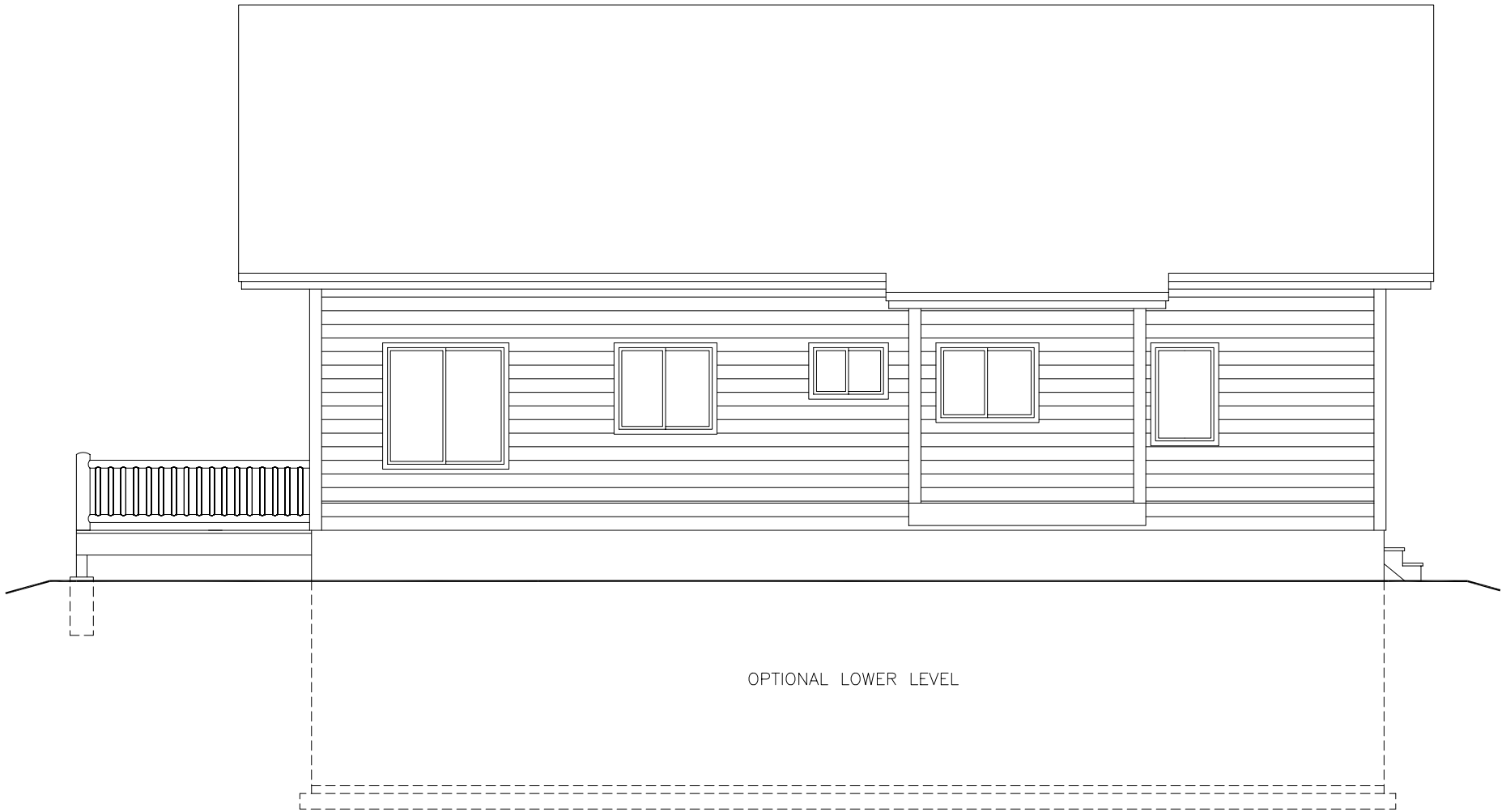
ELEVATION

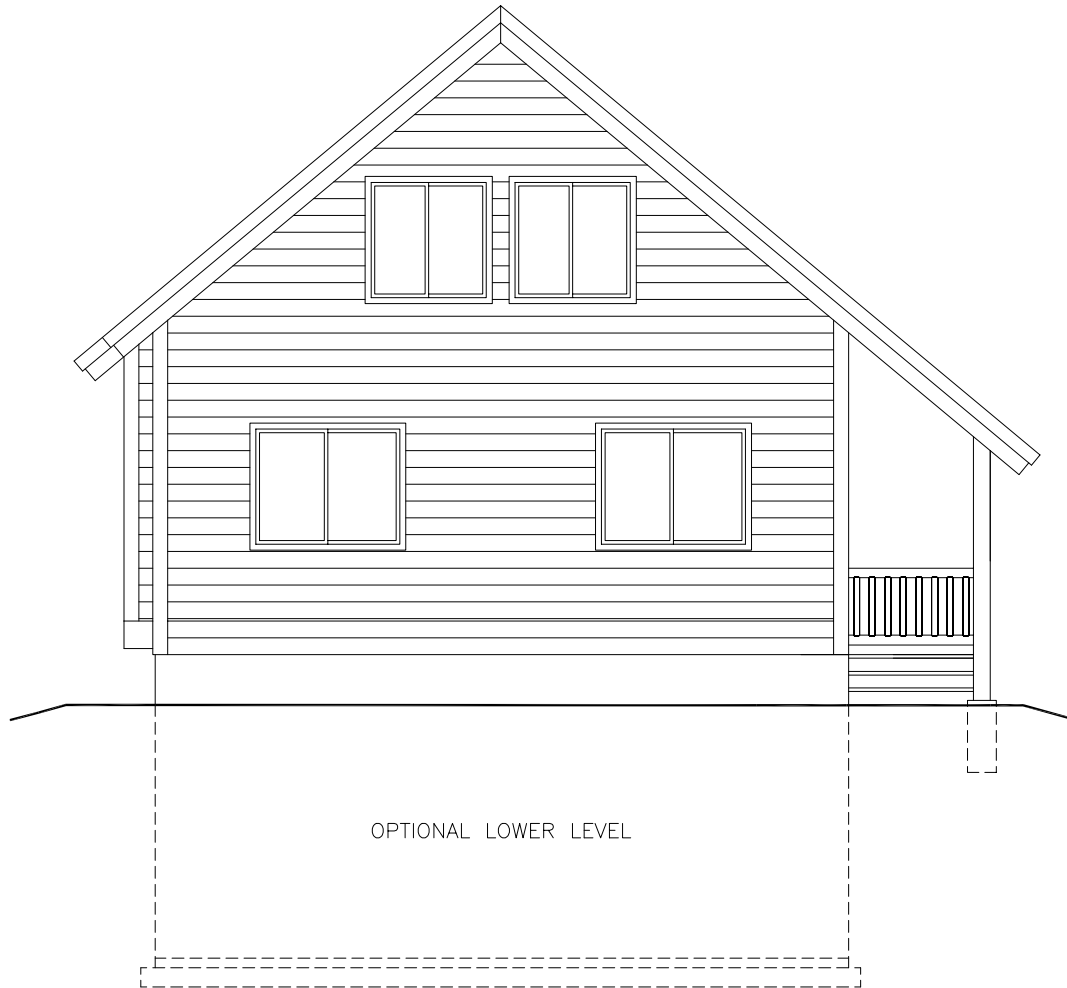
EVERGREEN STUDY PLAN
