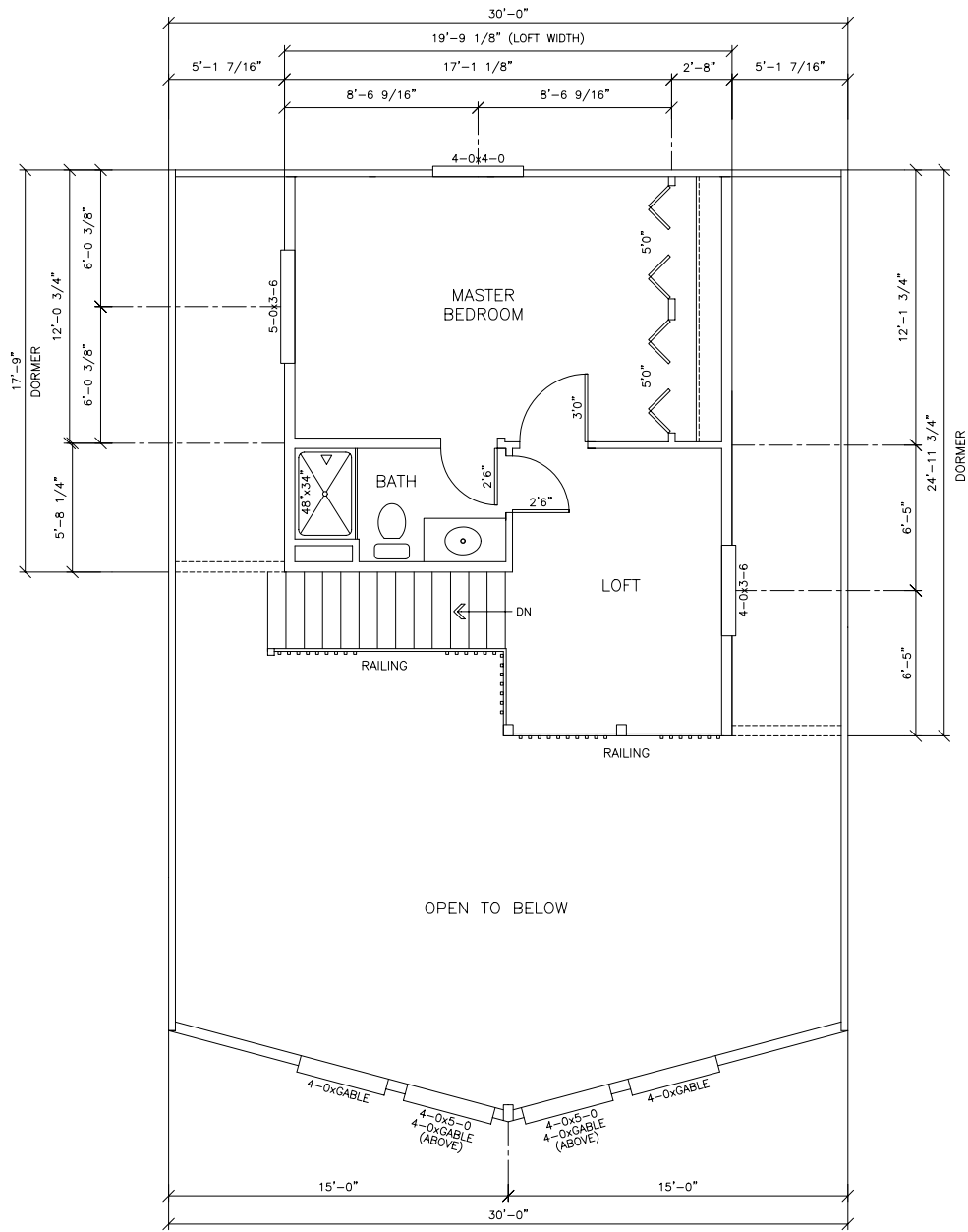

FREMONT STUDY PLAN

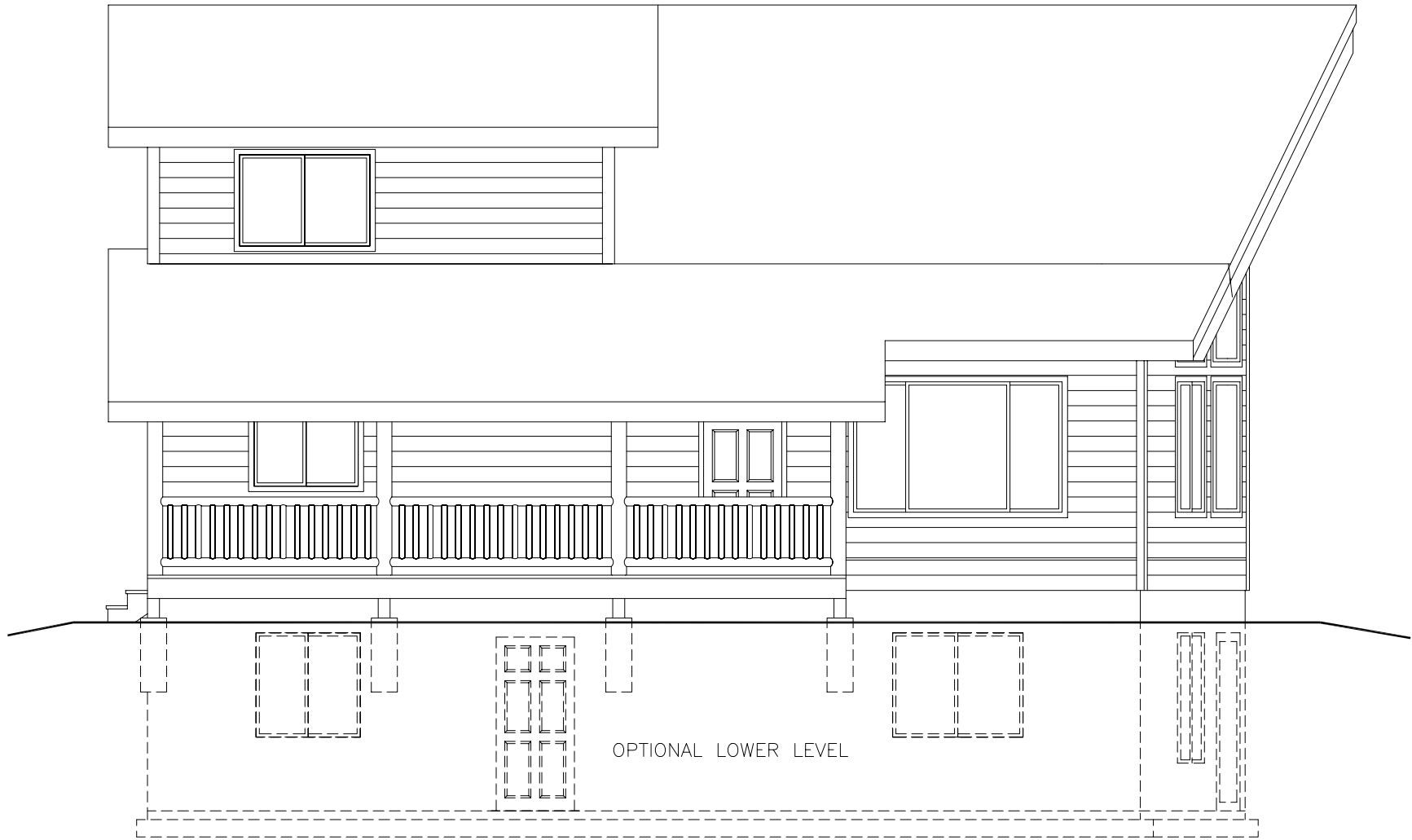
MAIN LEVEL

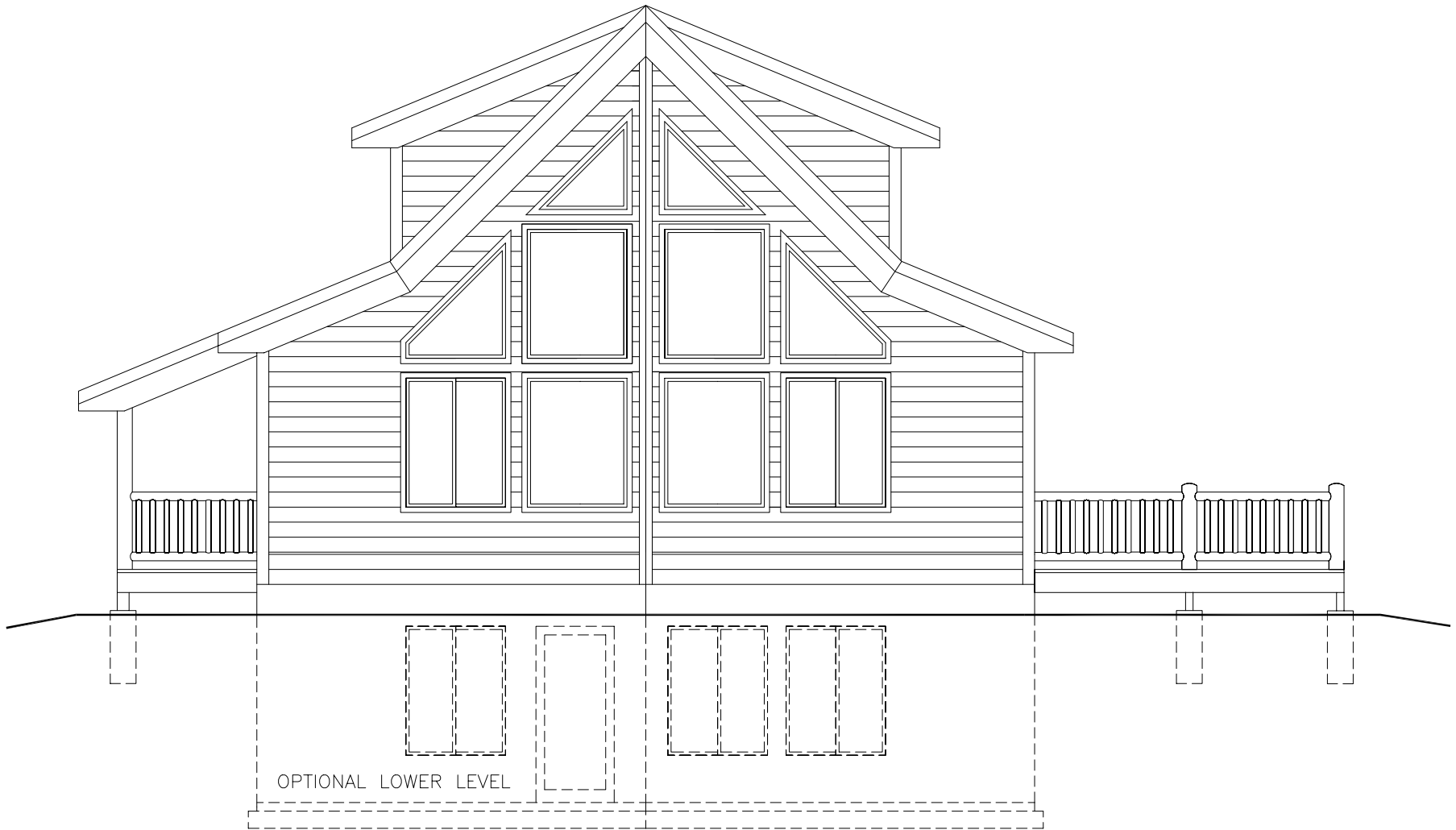

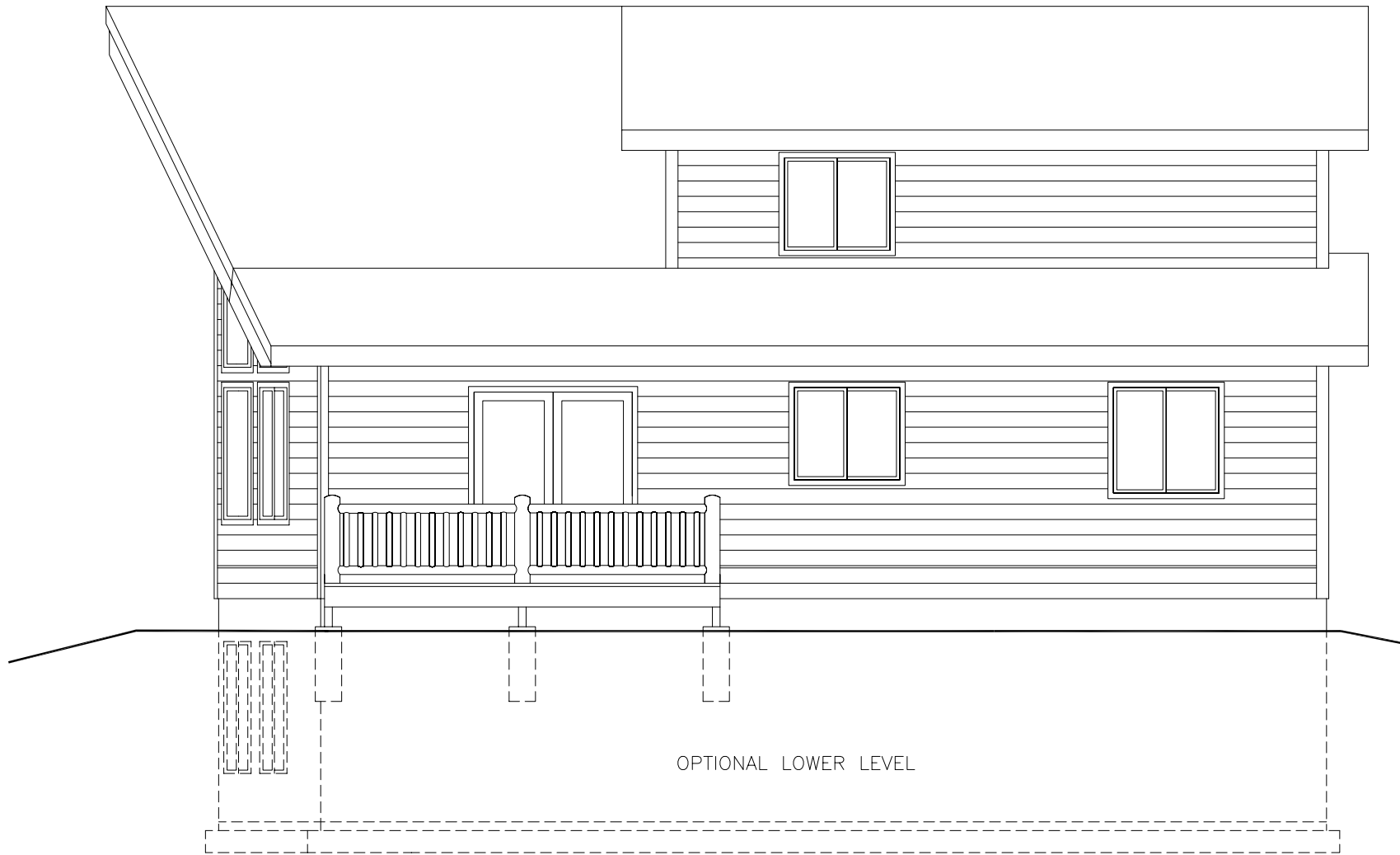

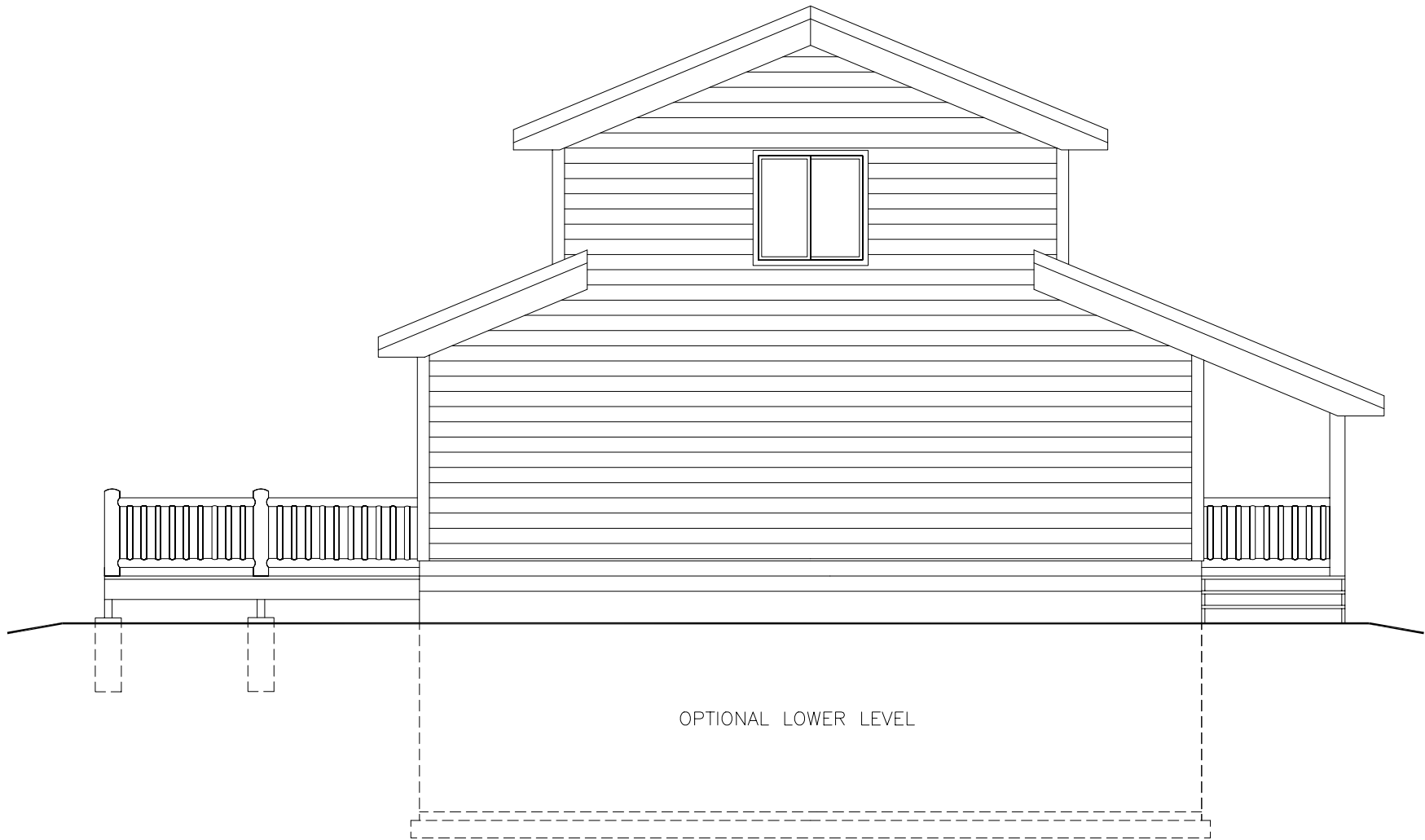
