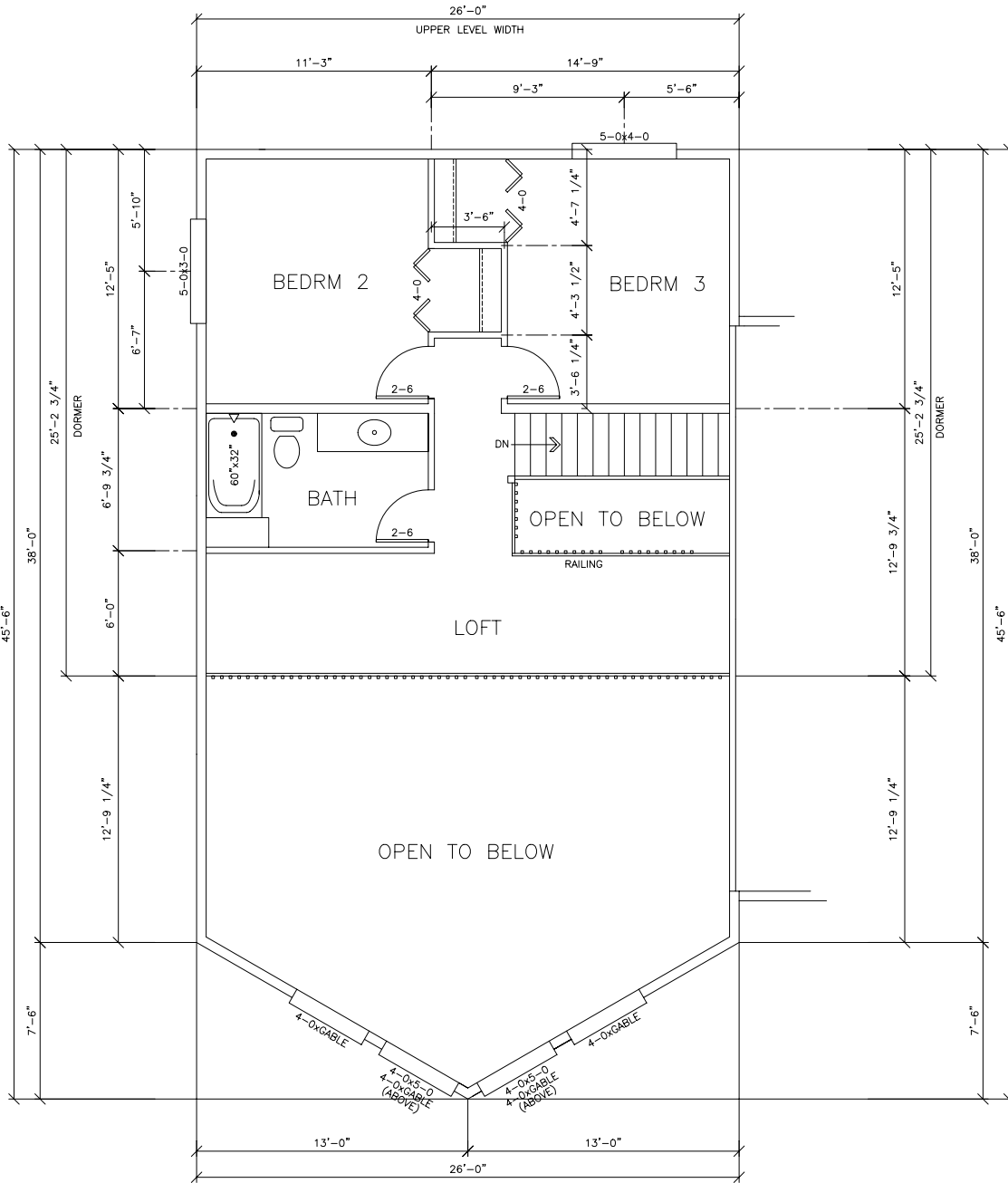


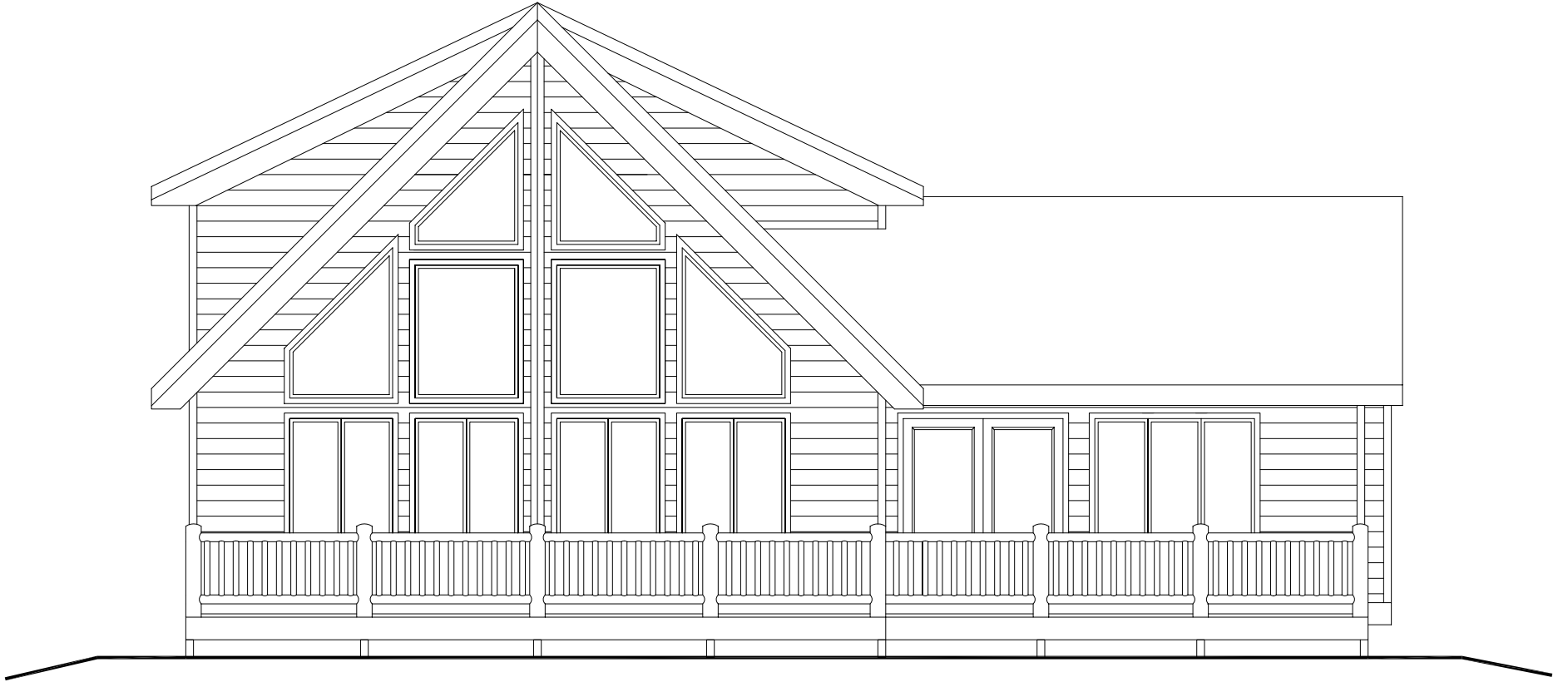

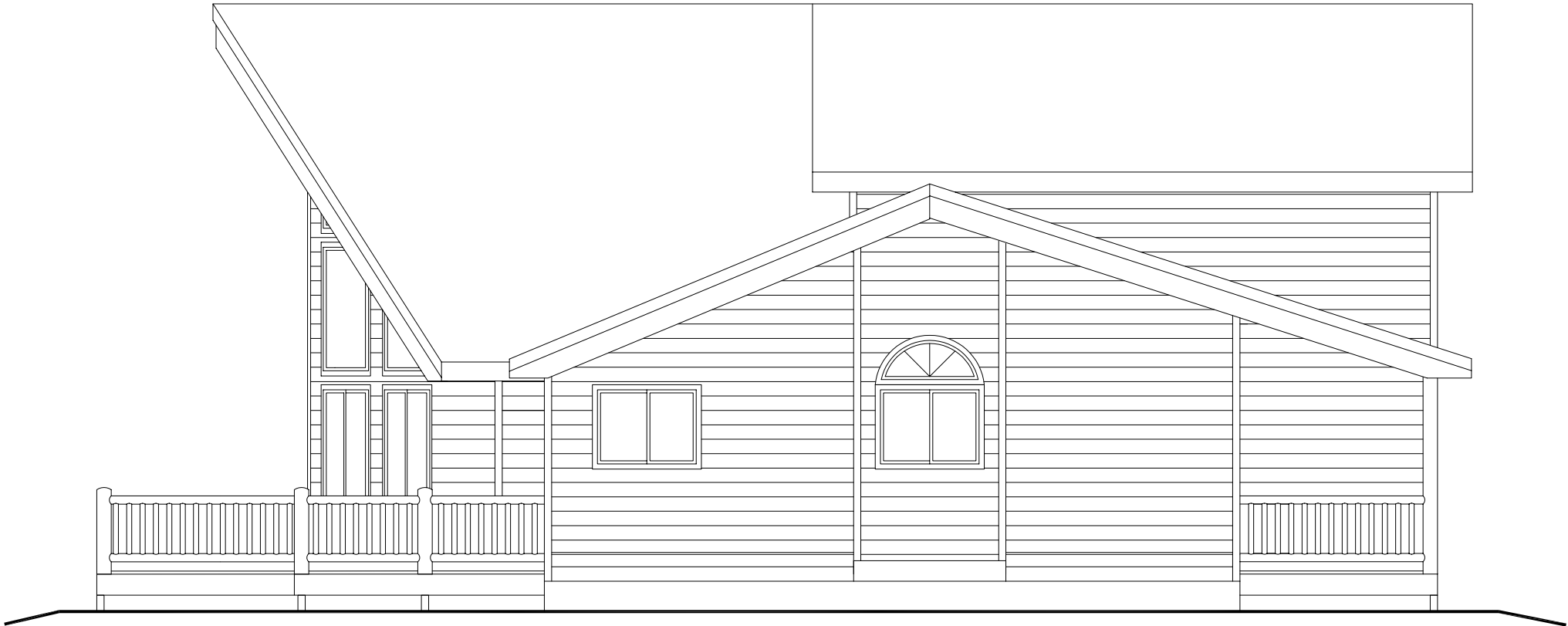

ELEVATION

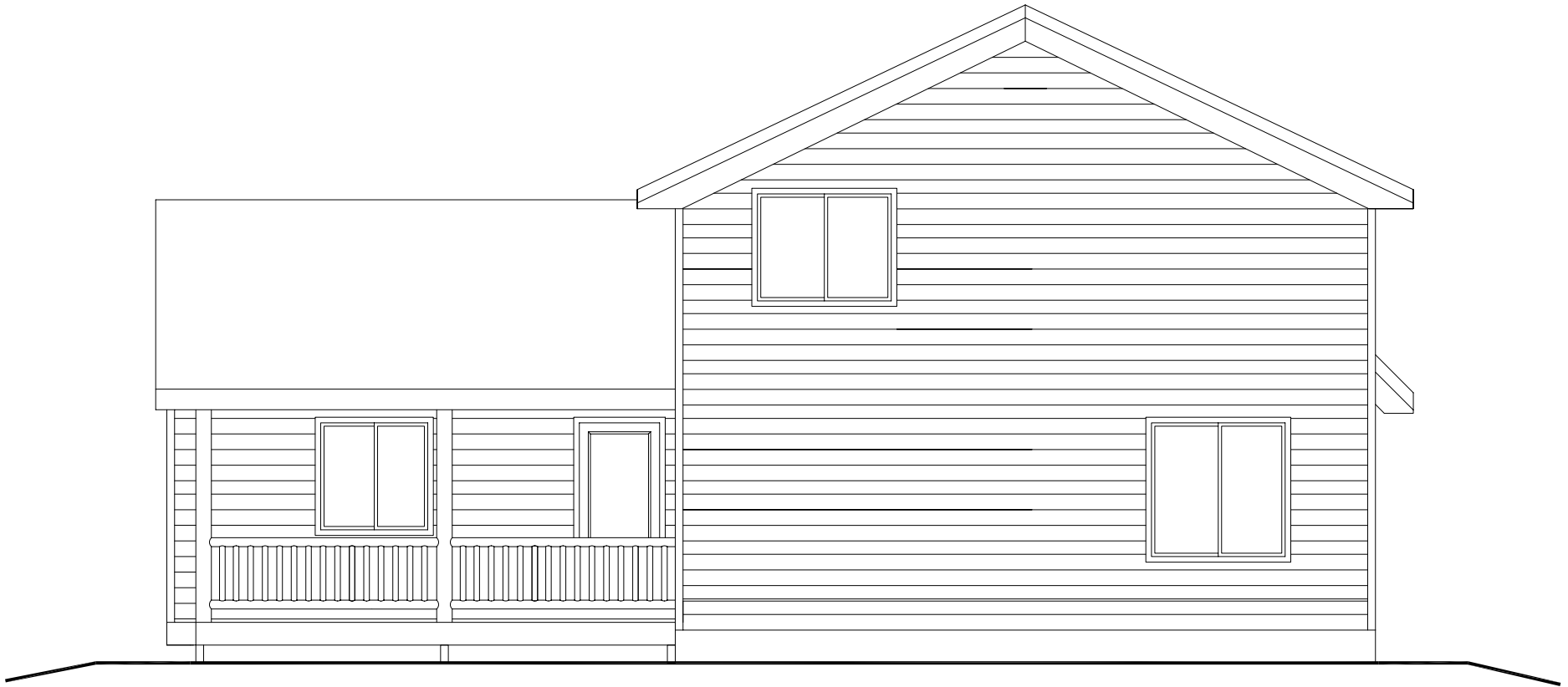

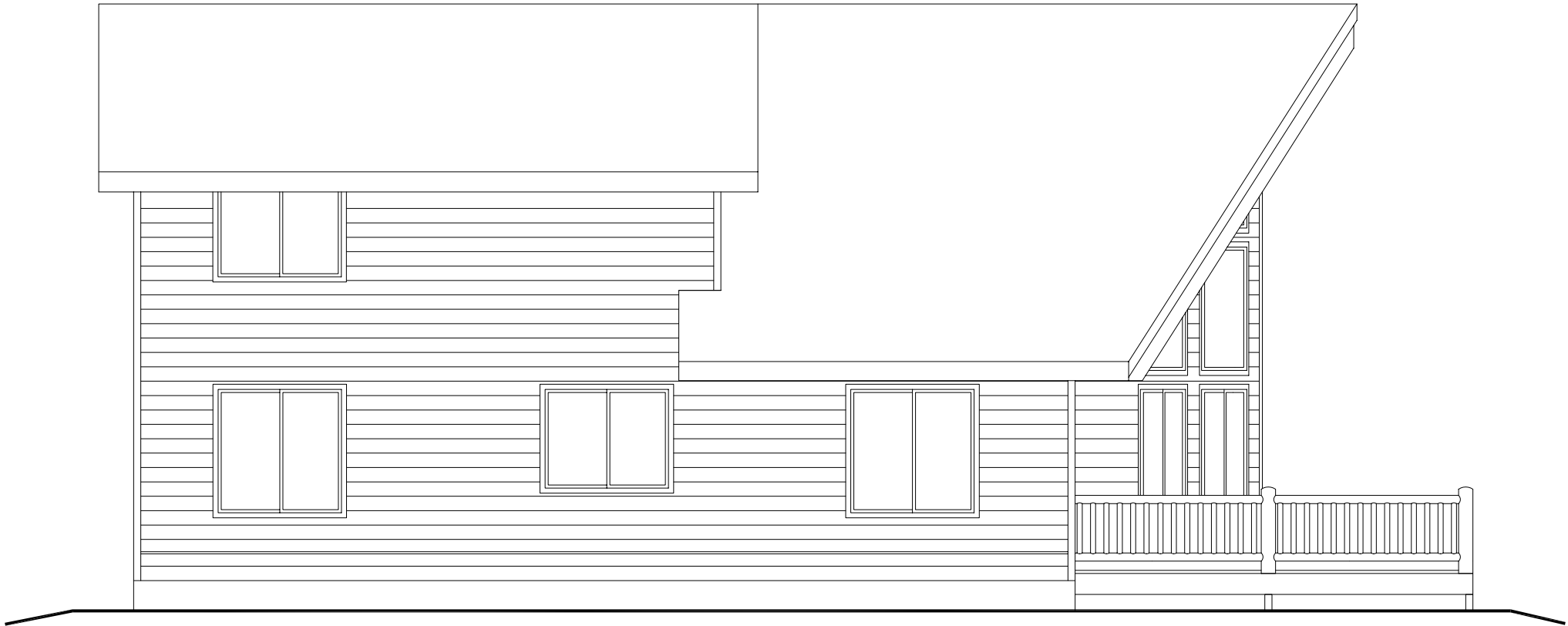
