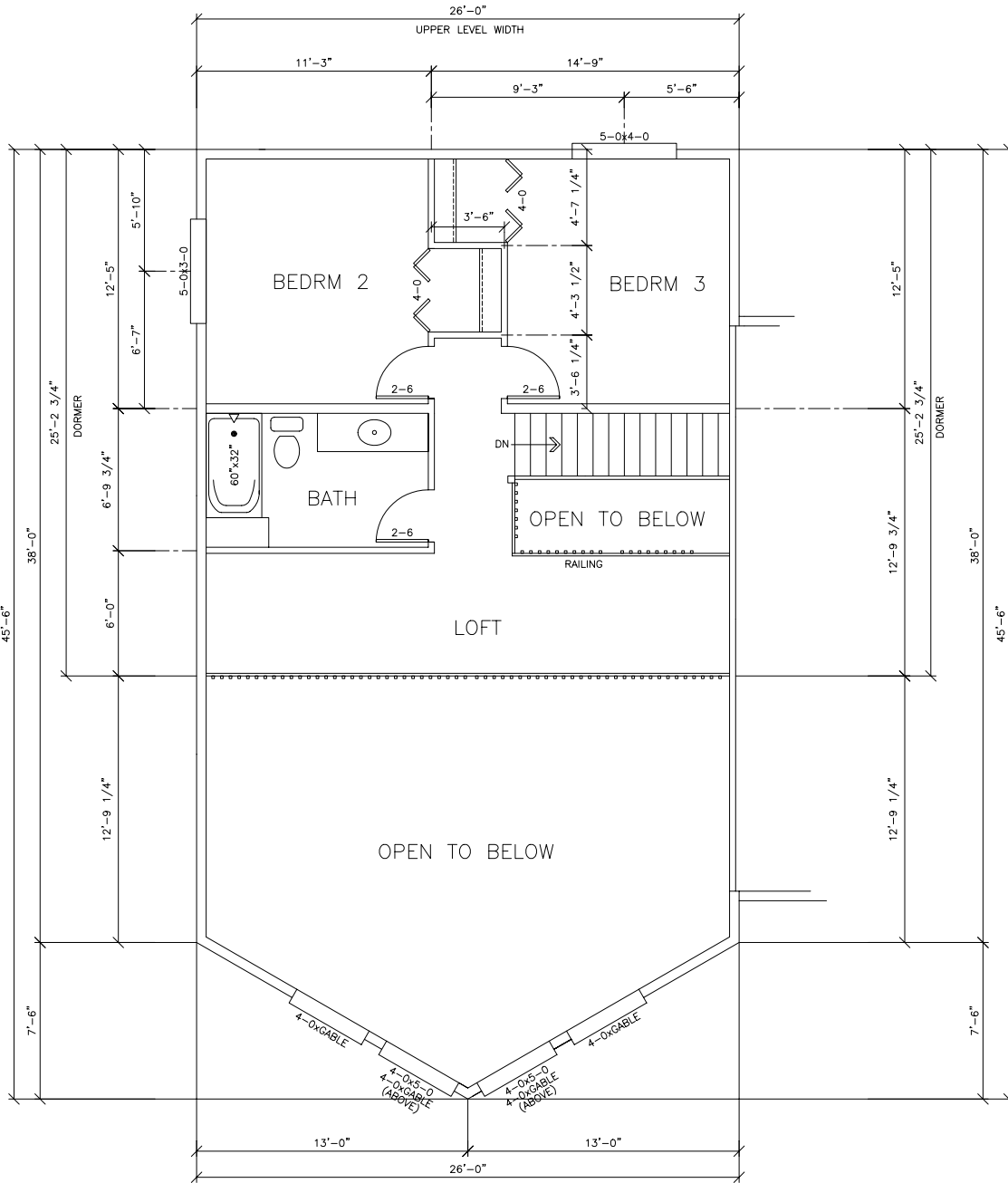


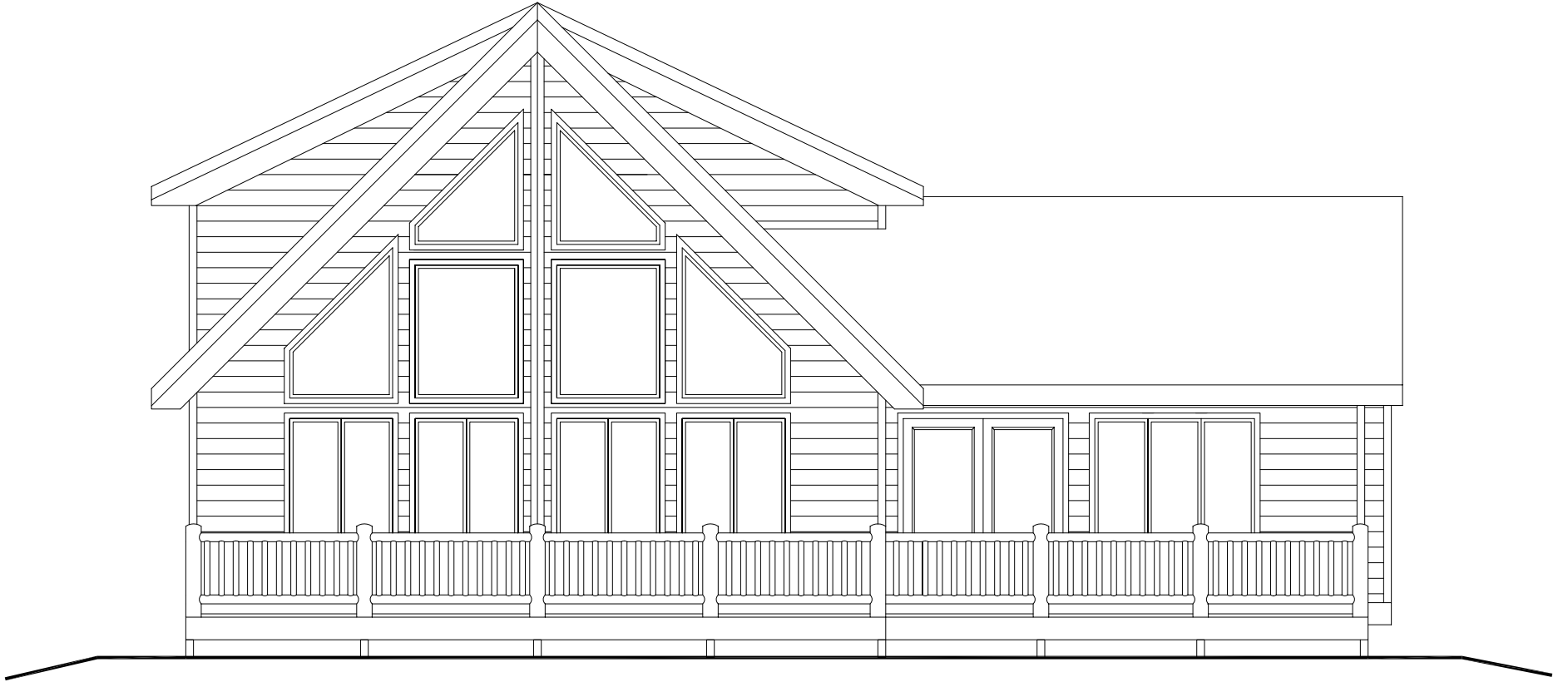

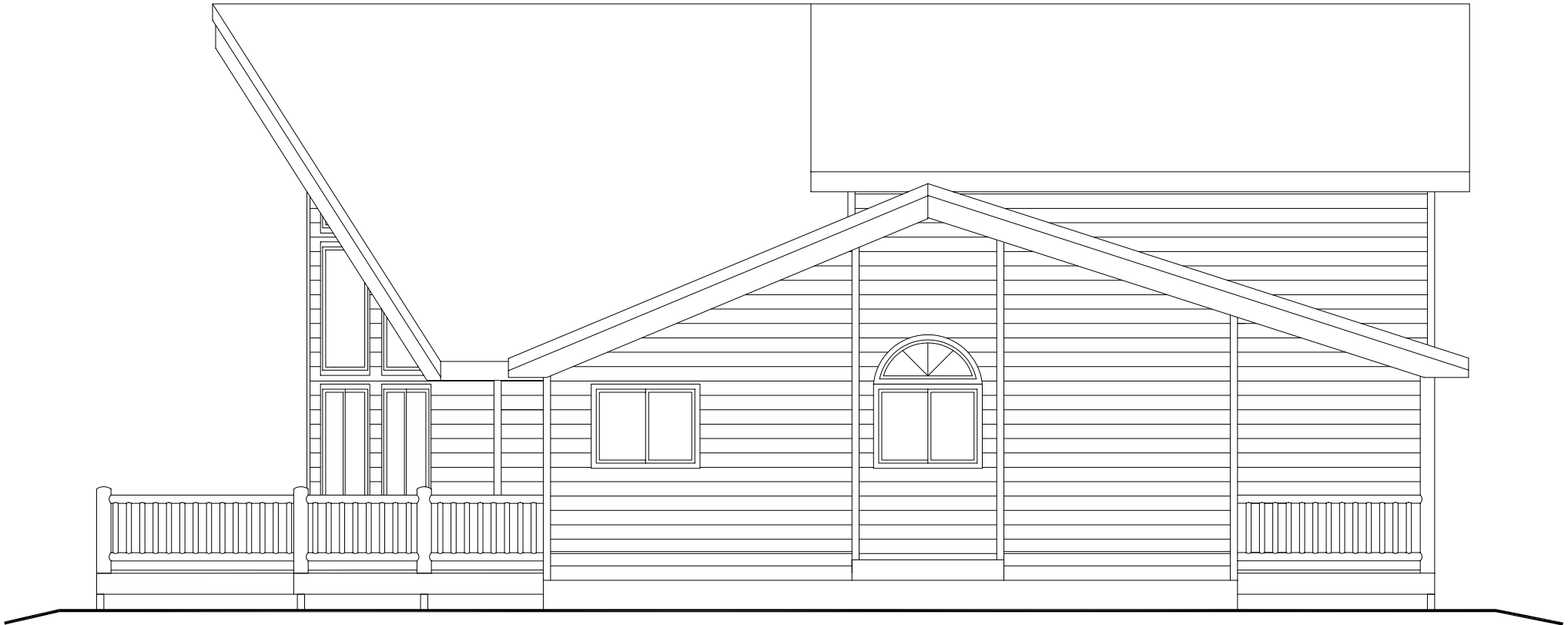

ELEVATION

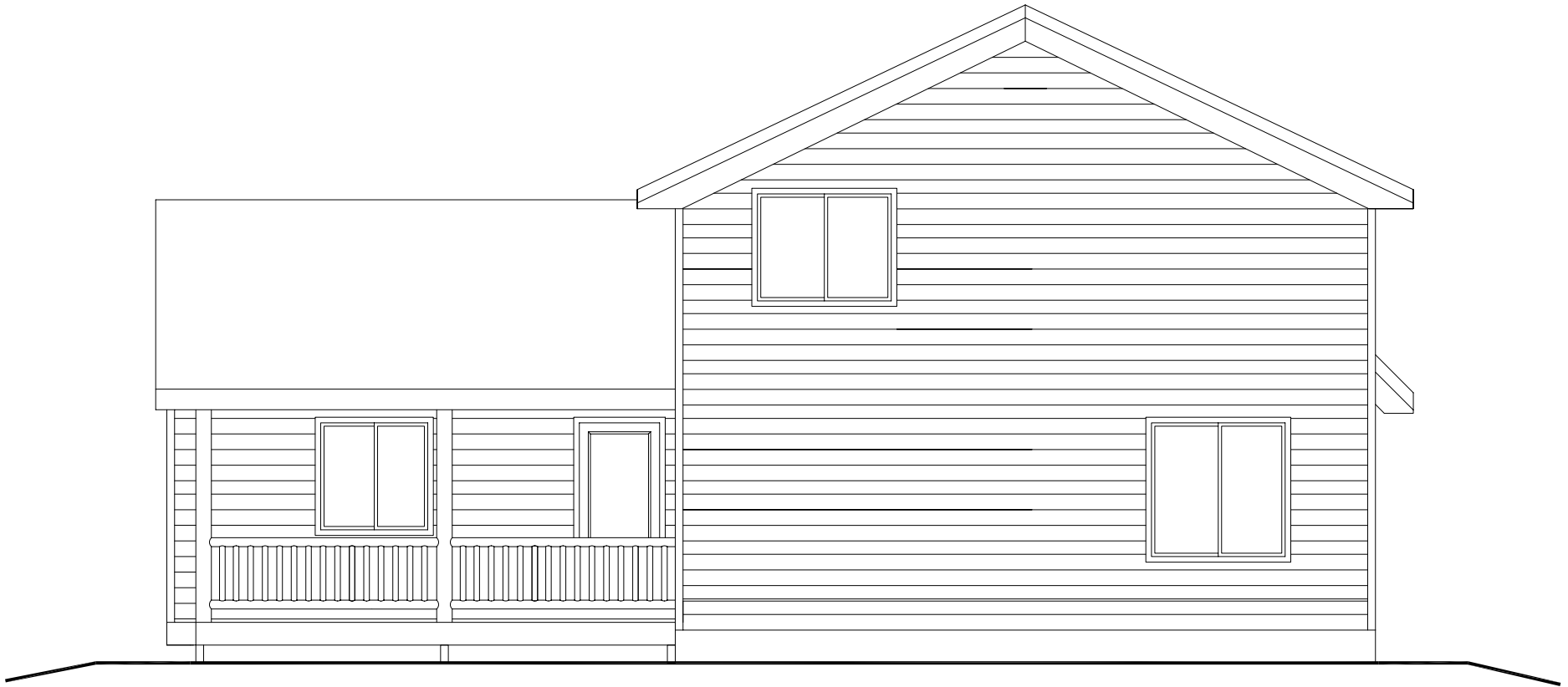

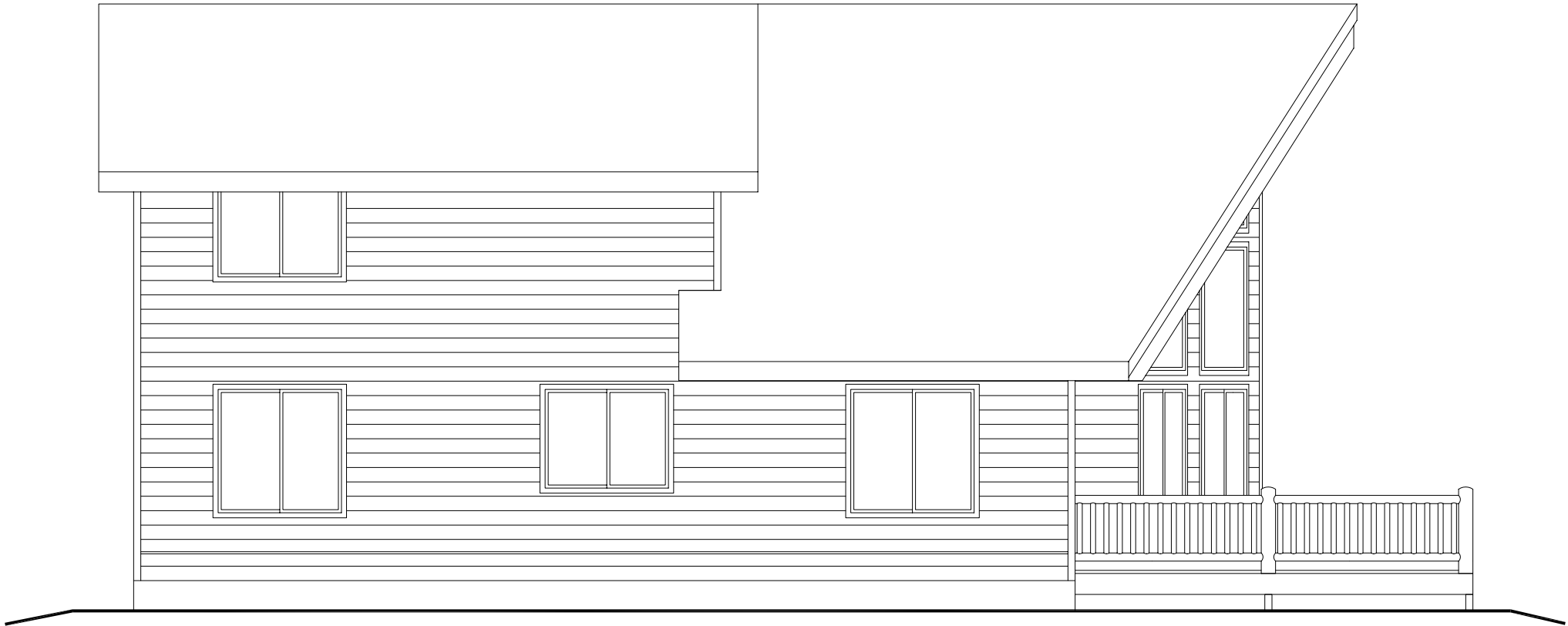
