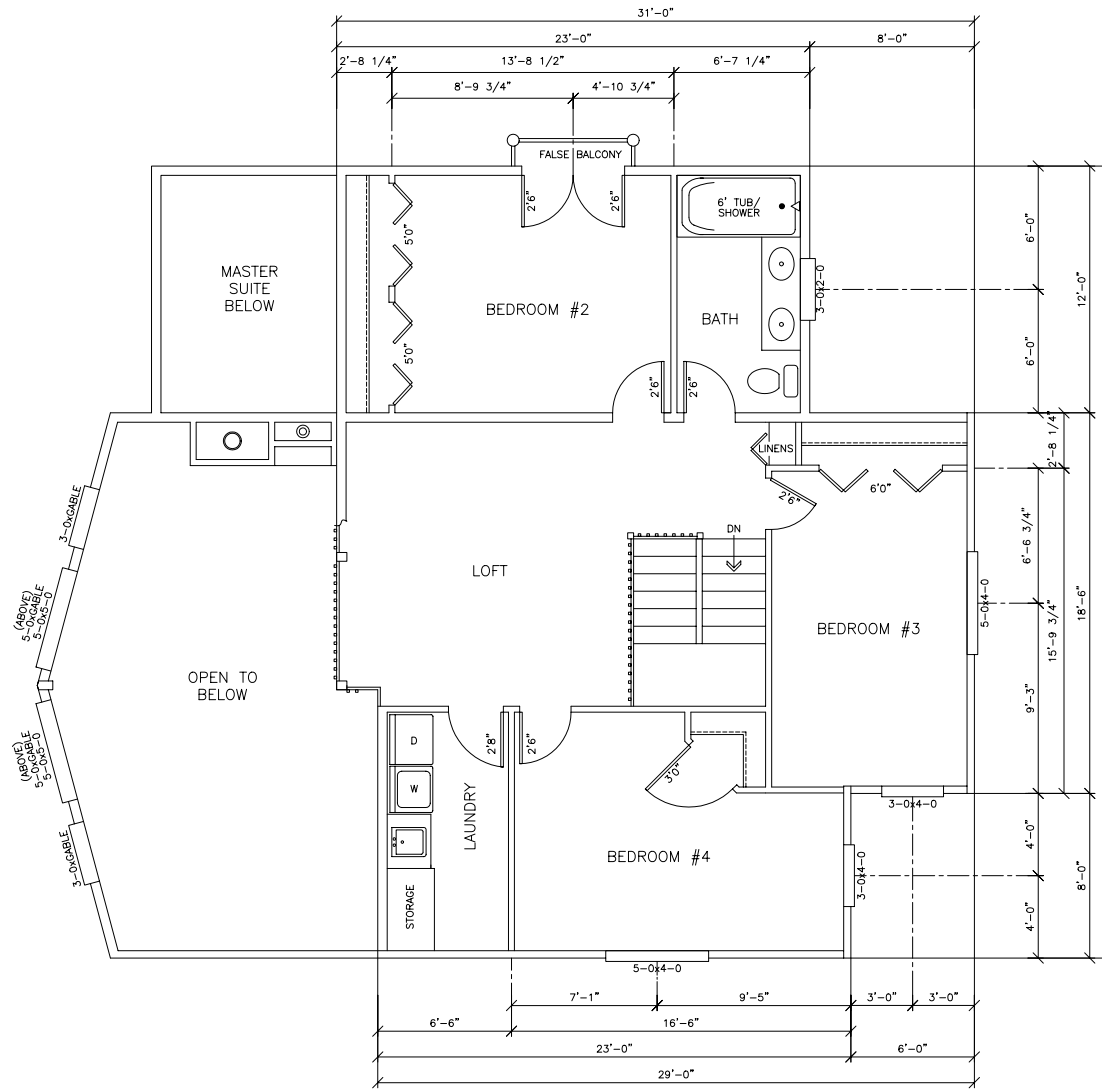

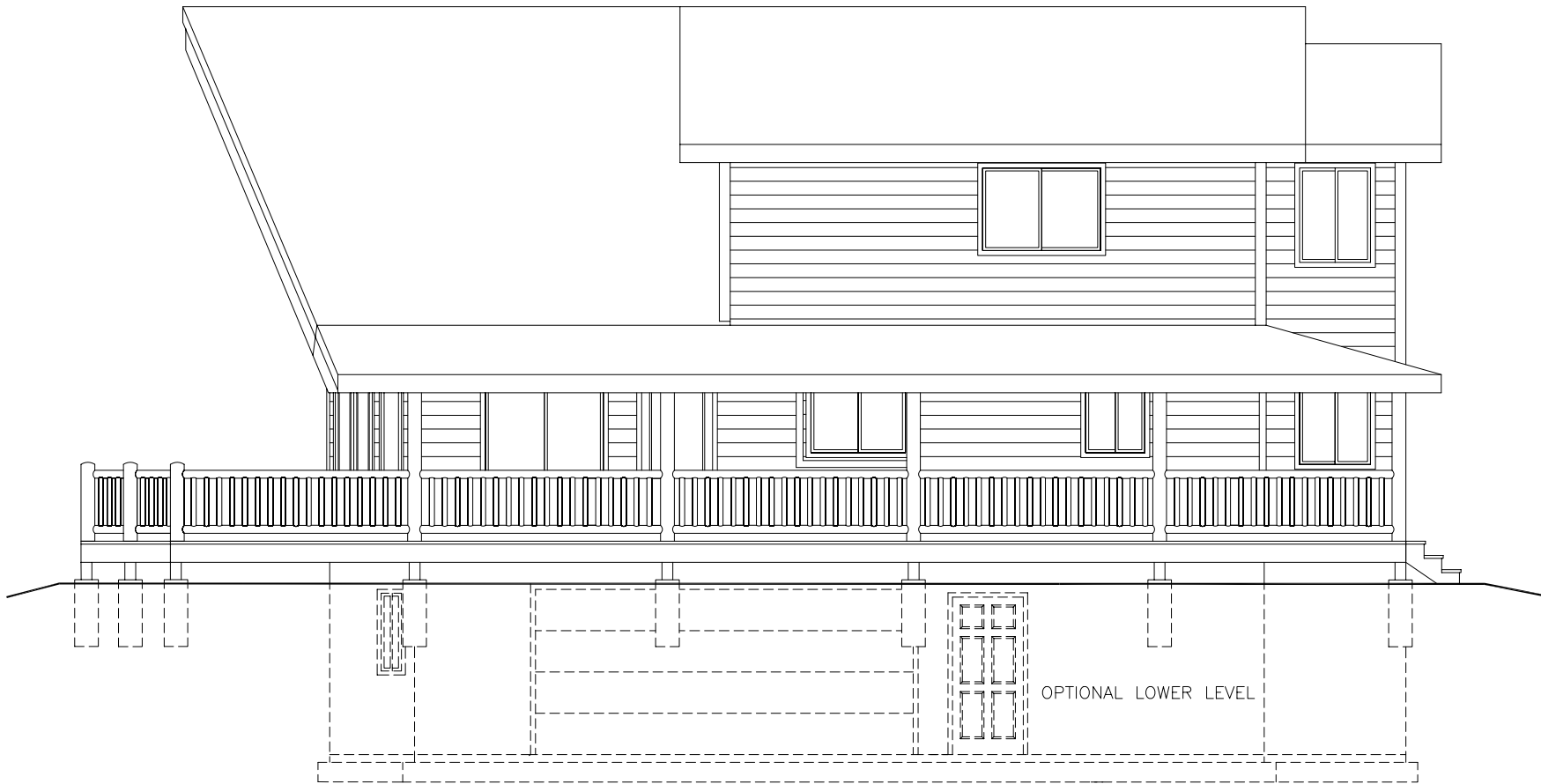
MONARCH STUDY PLAN

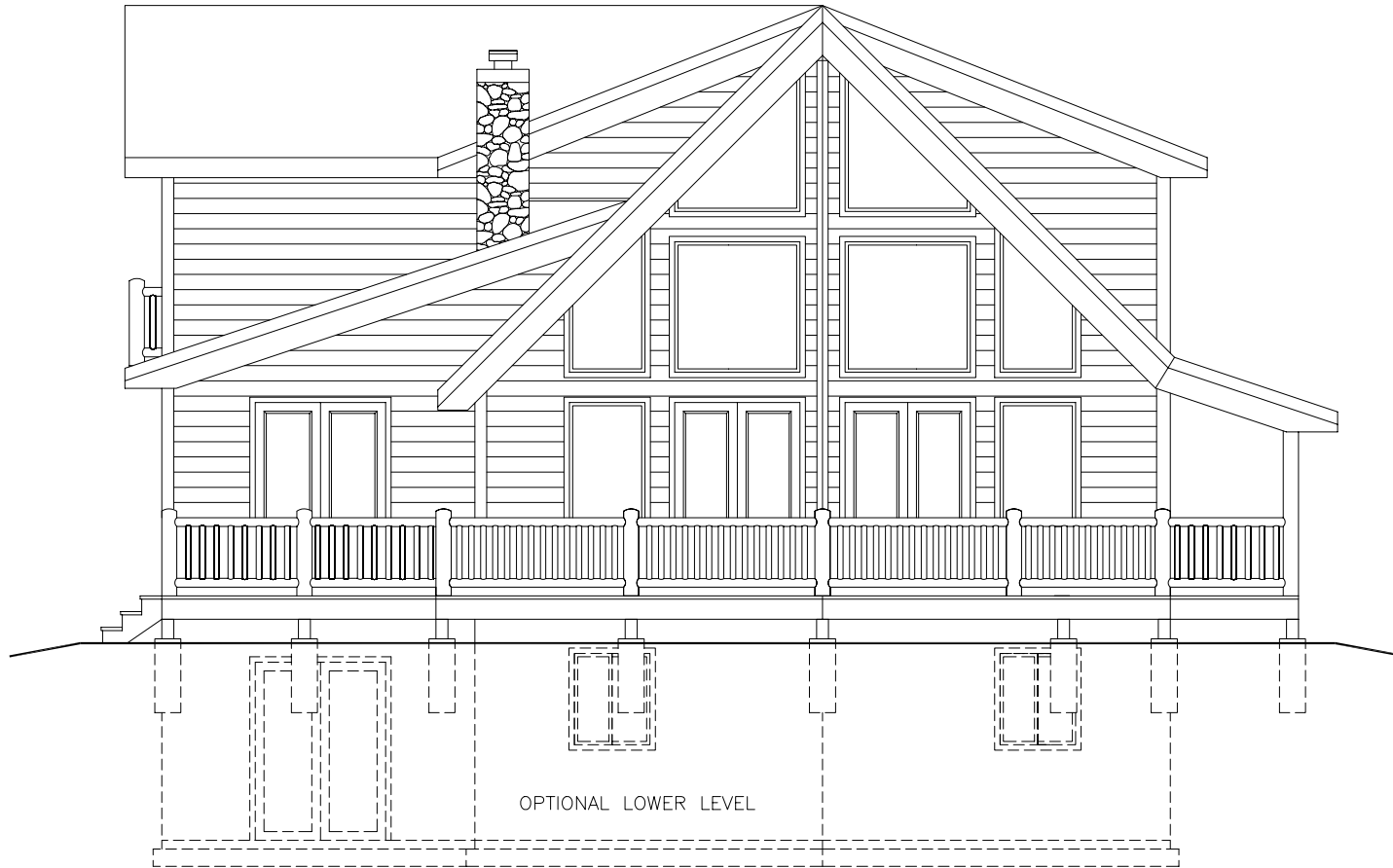
MONARCH STUDY PLAN

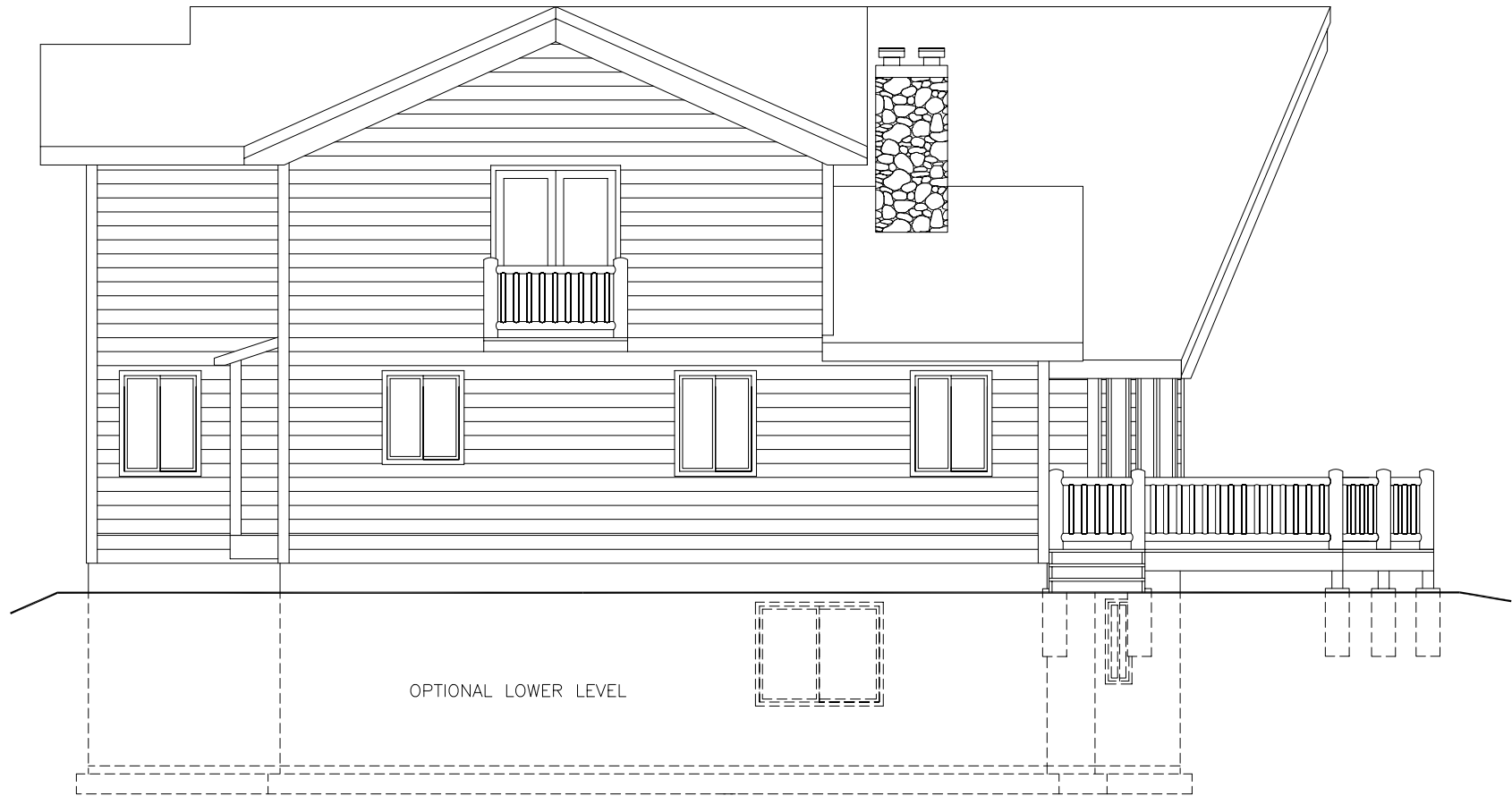
