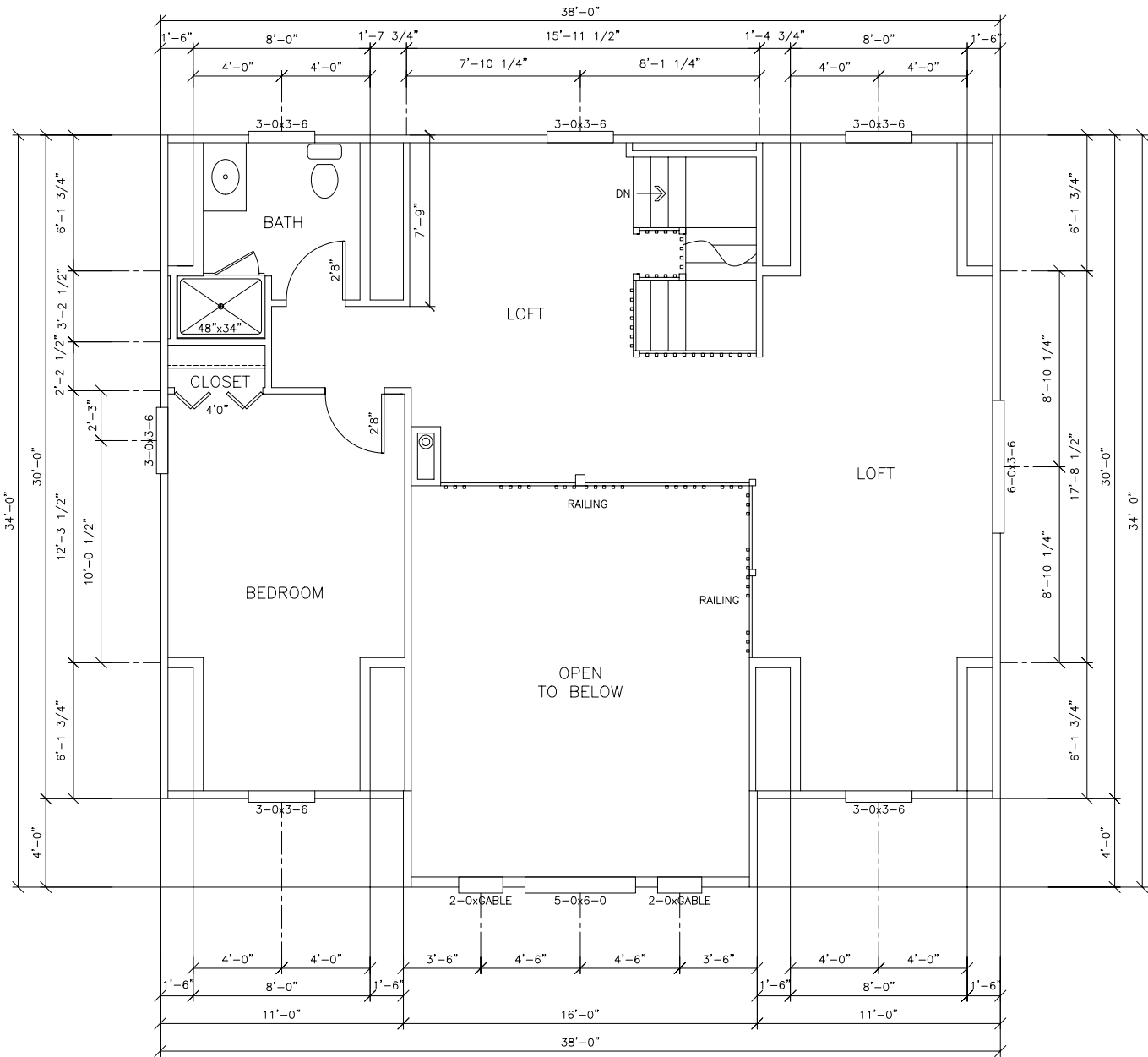

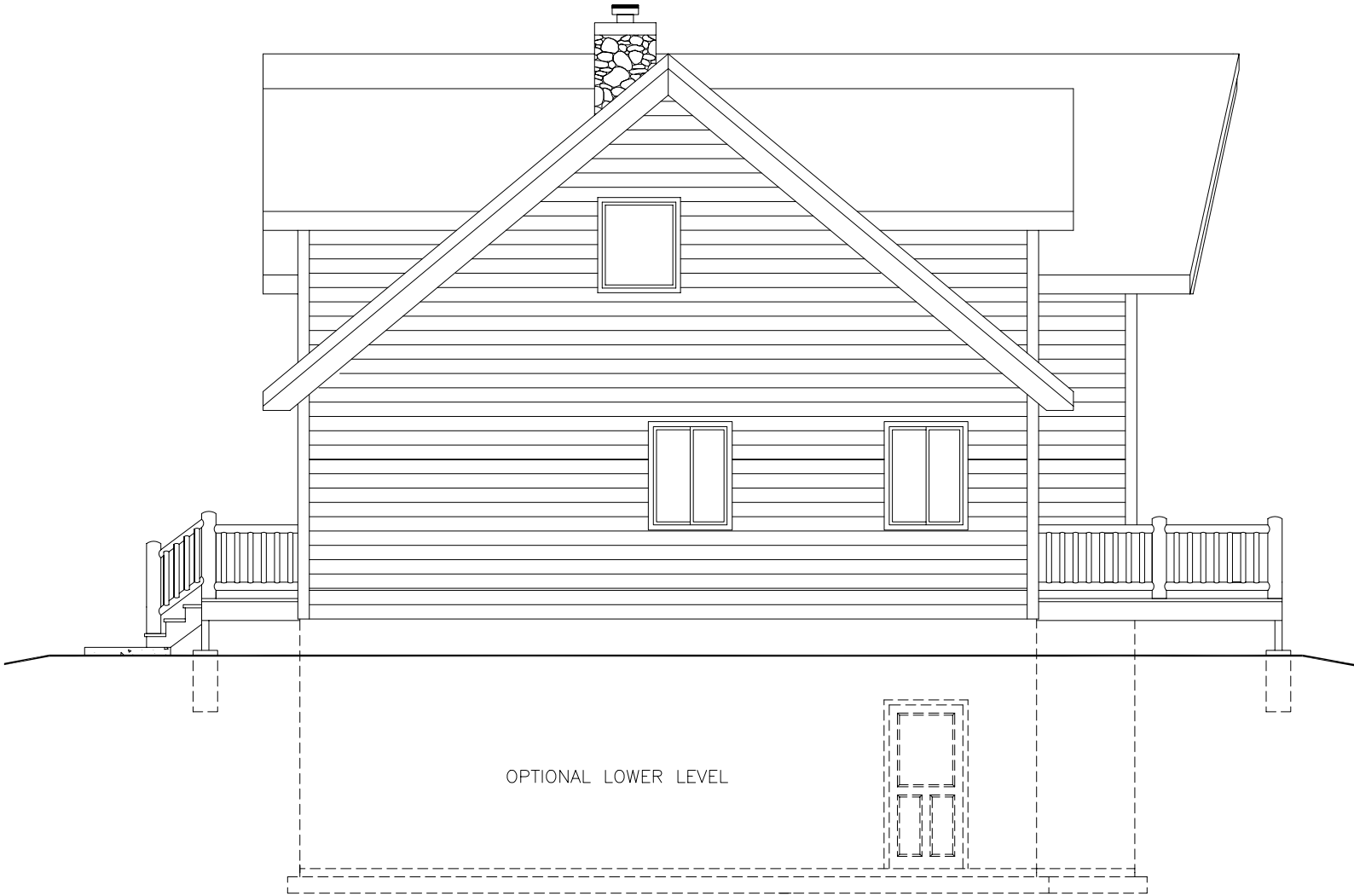

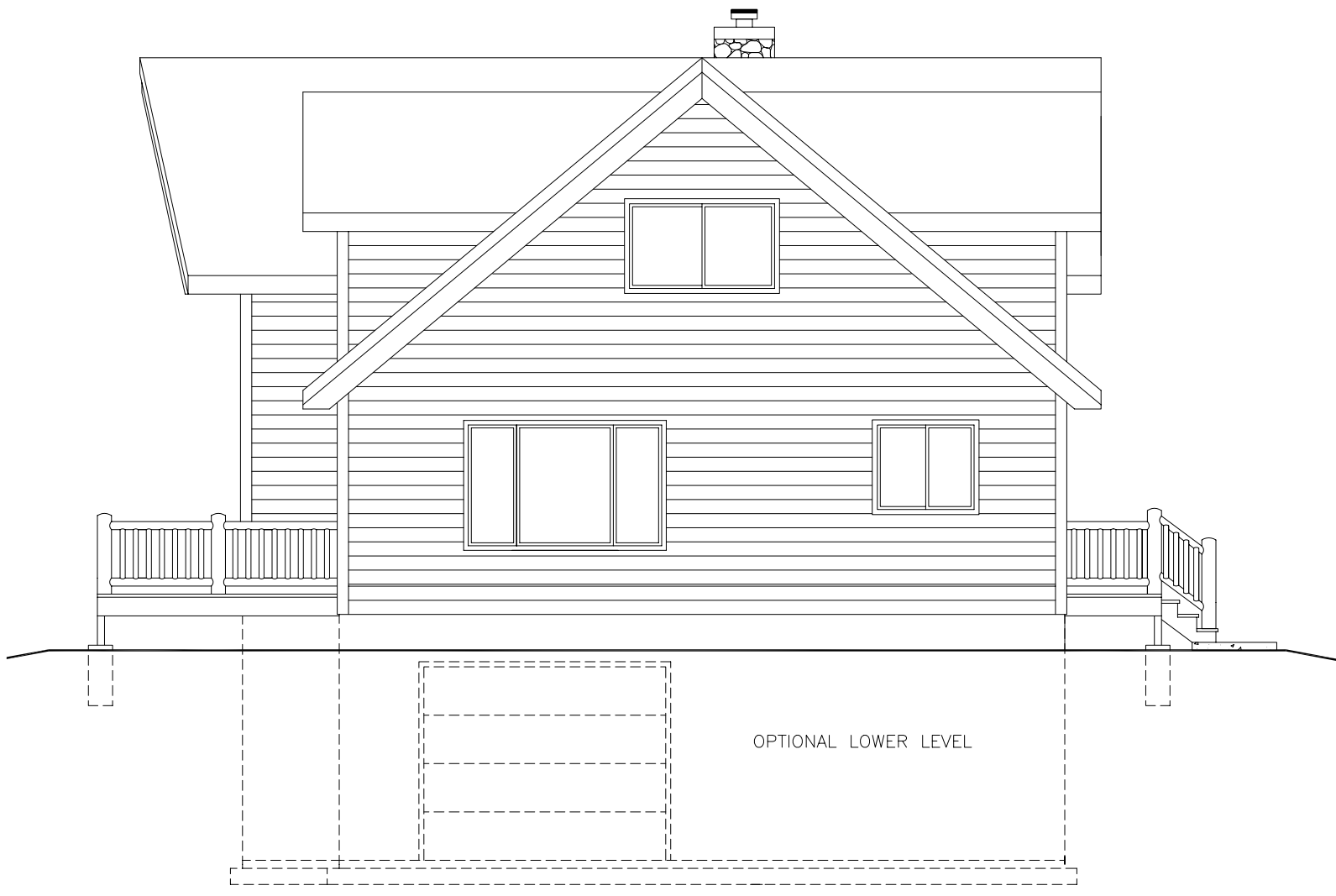
MT. BAKER STUDY PLAN
