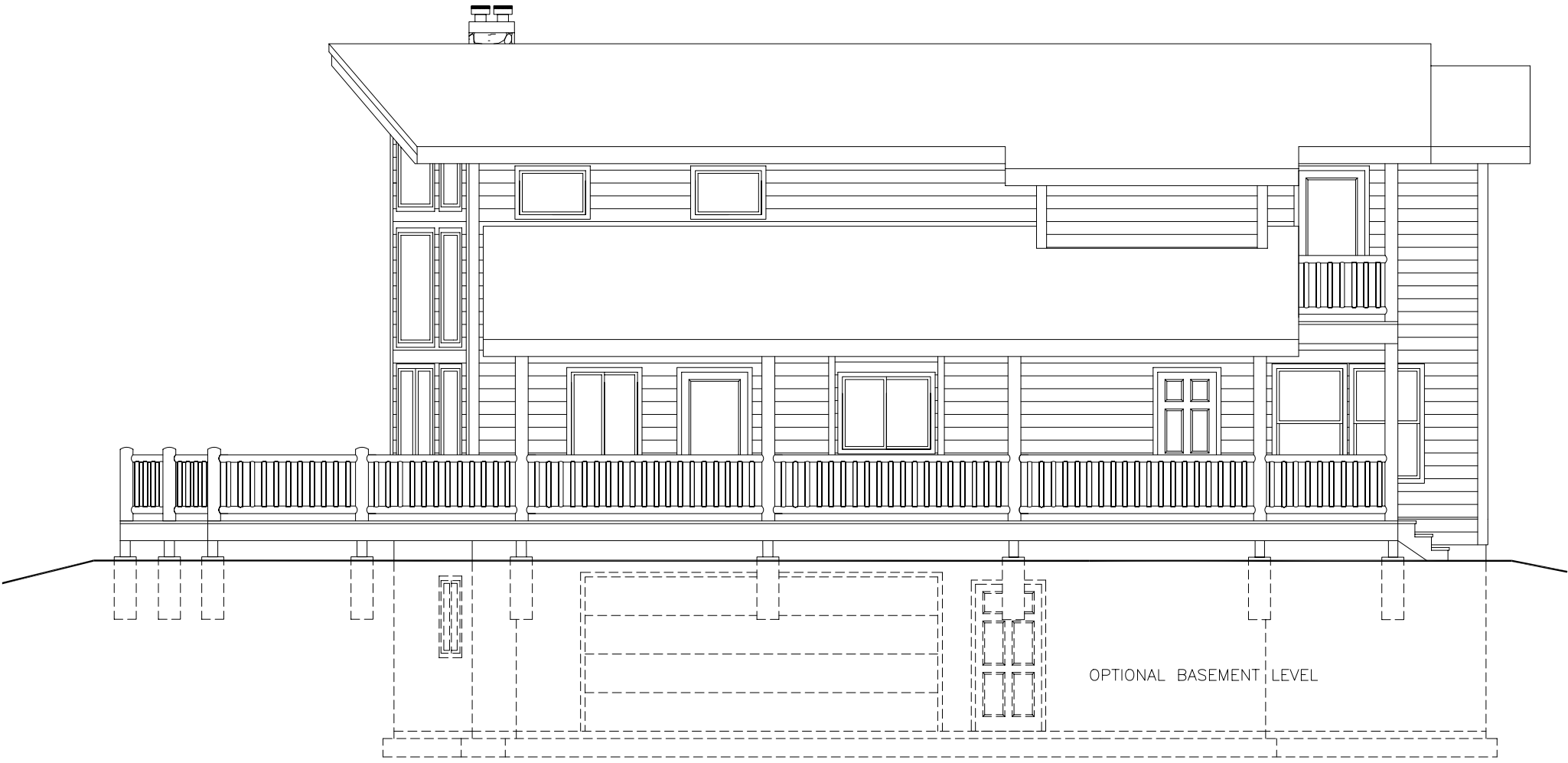

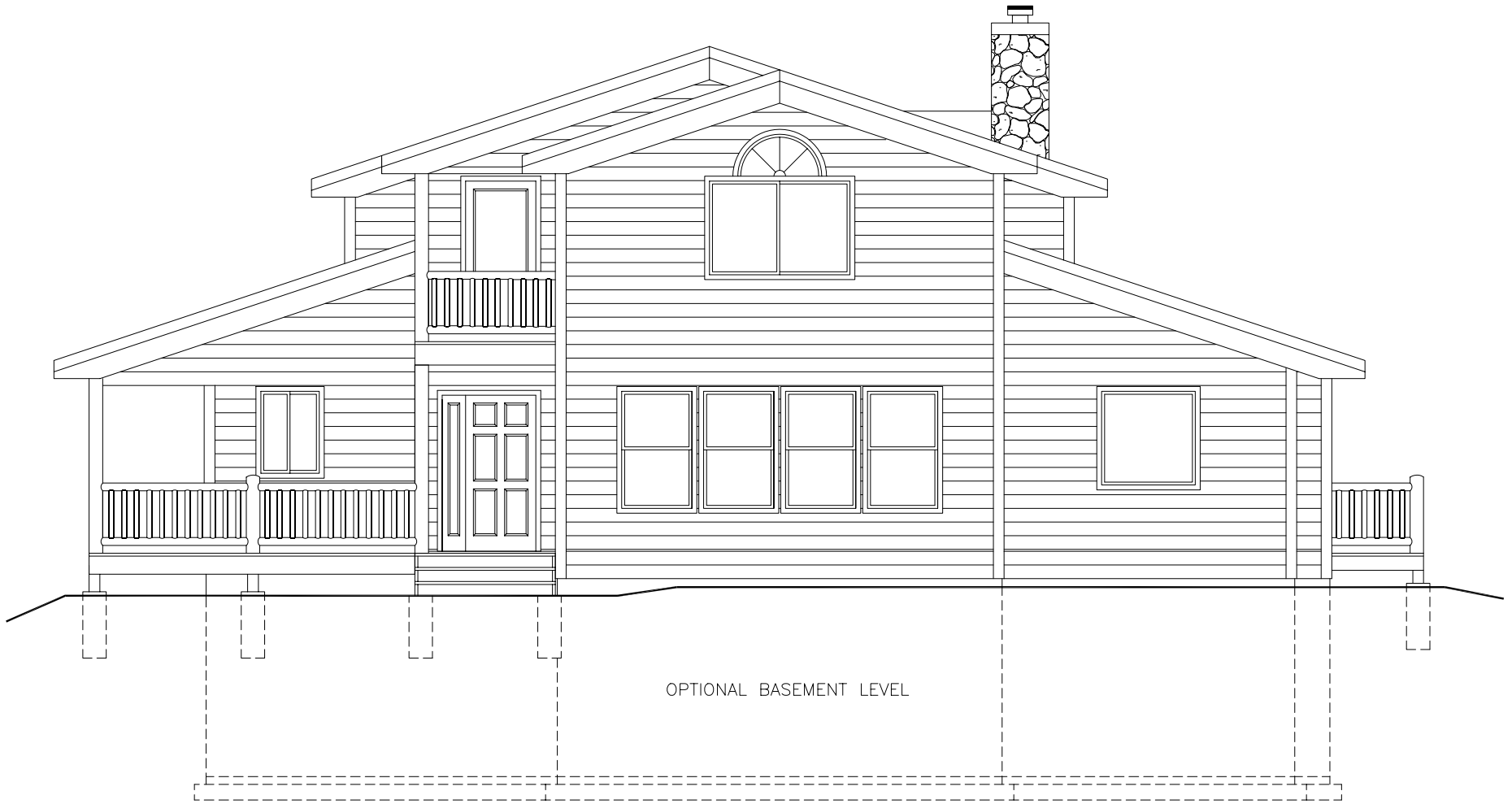
**SAN JUAN STUDY PLAN**

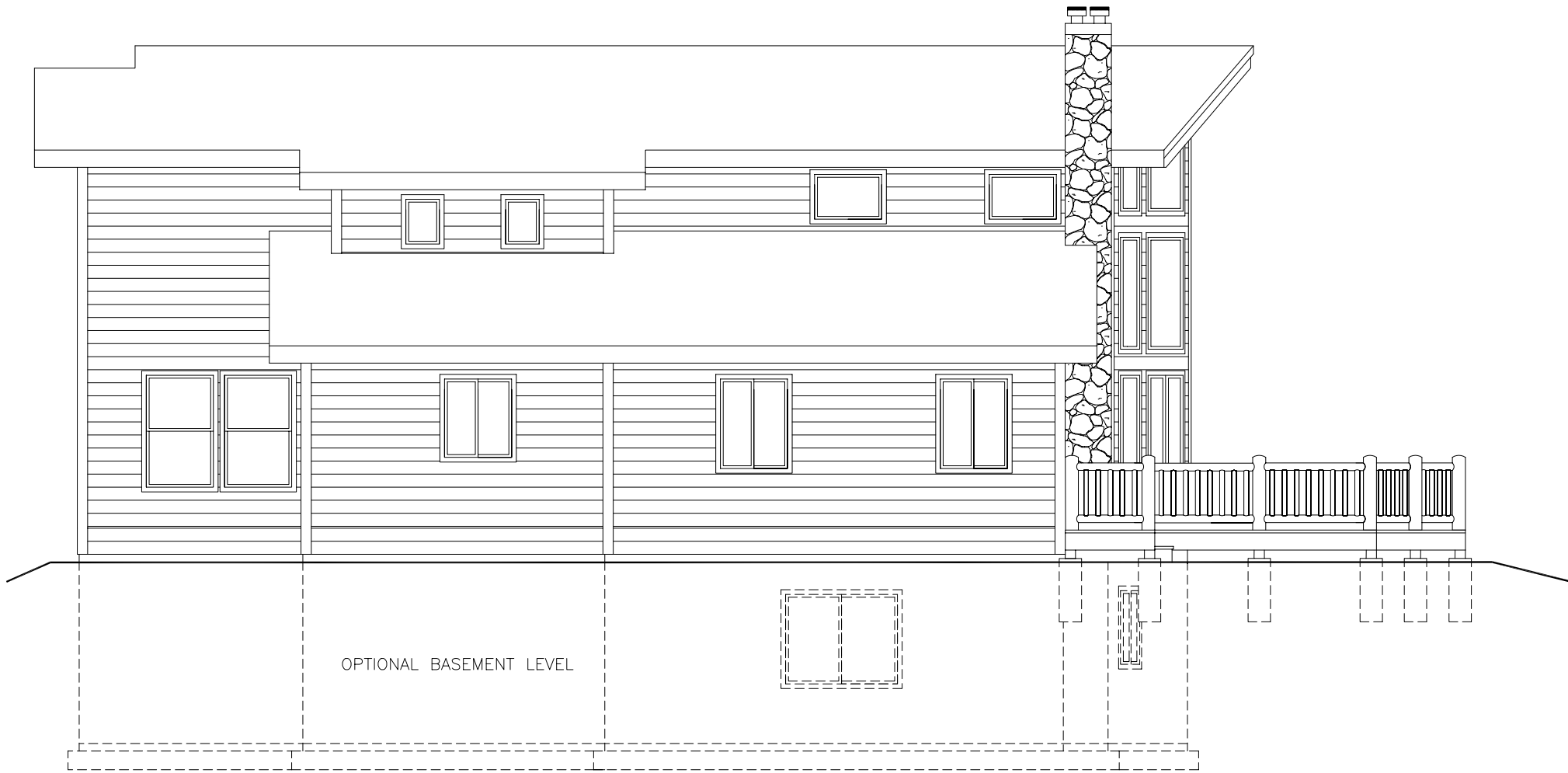
