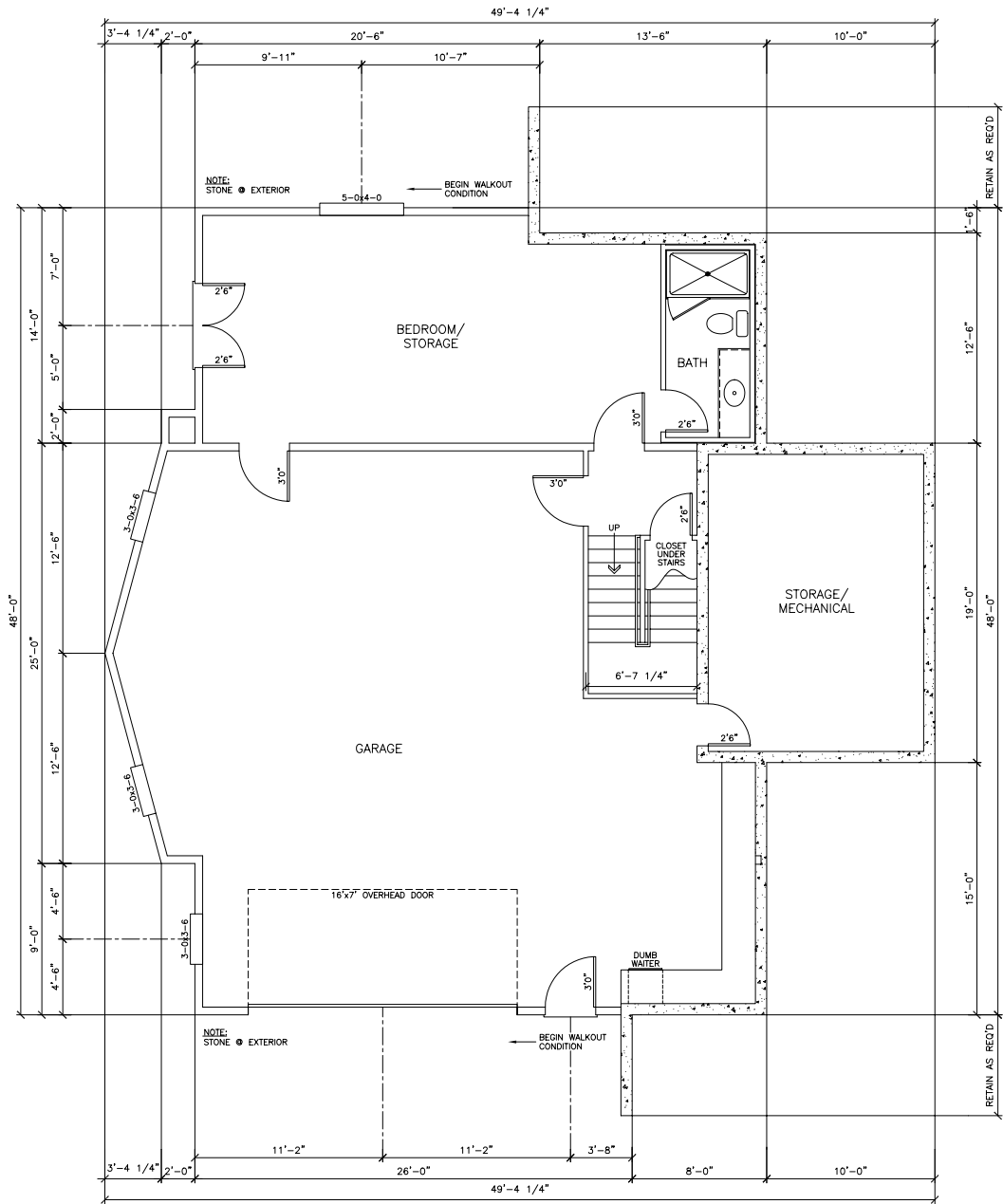

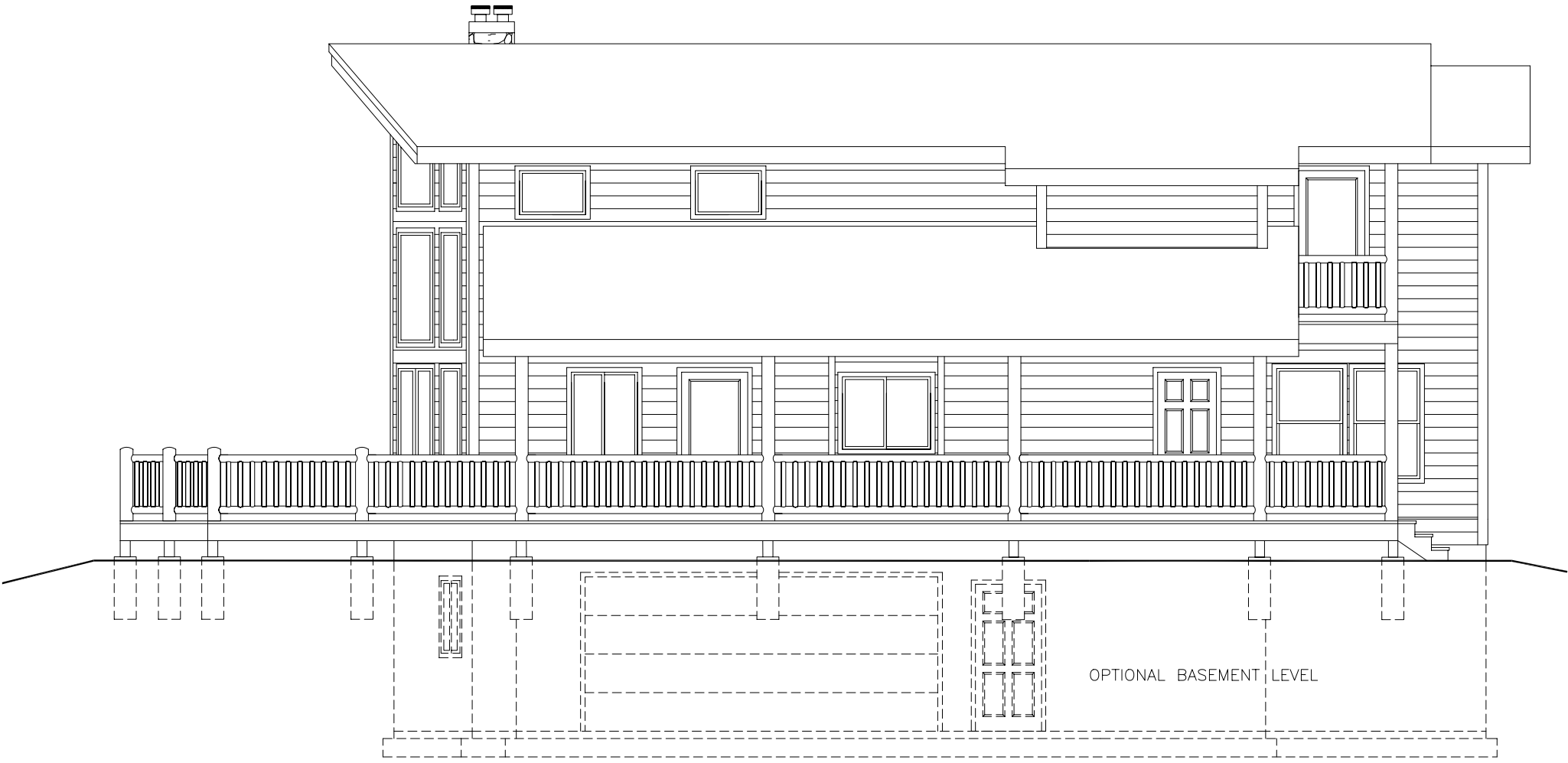

SAN JUAN STUDY PLAN

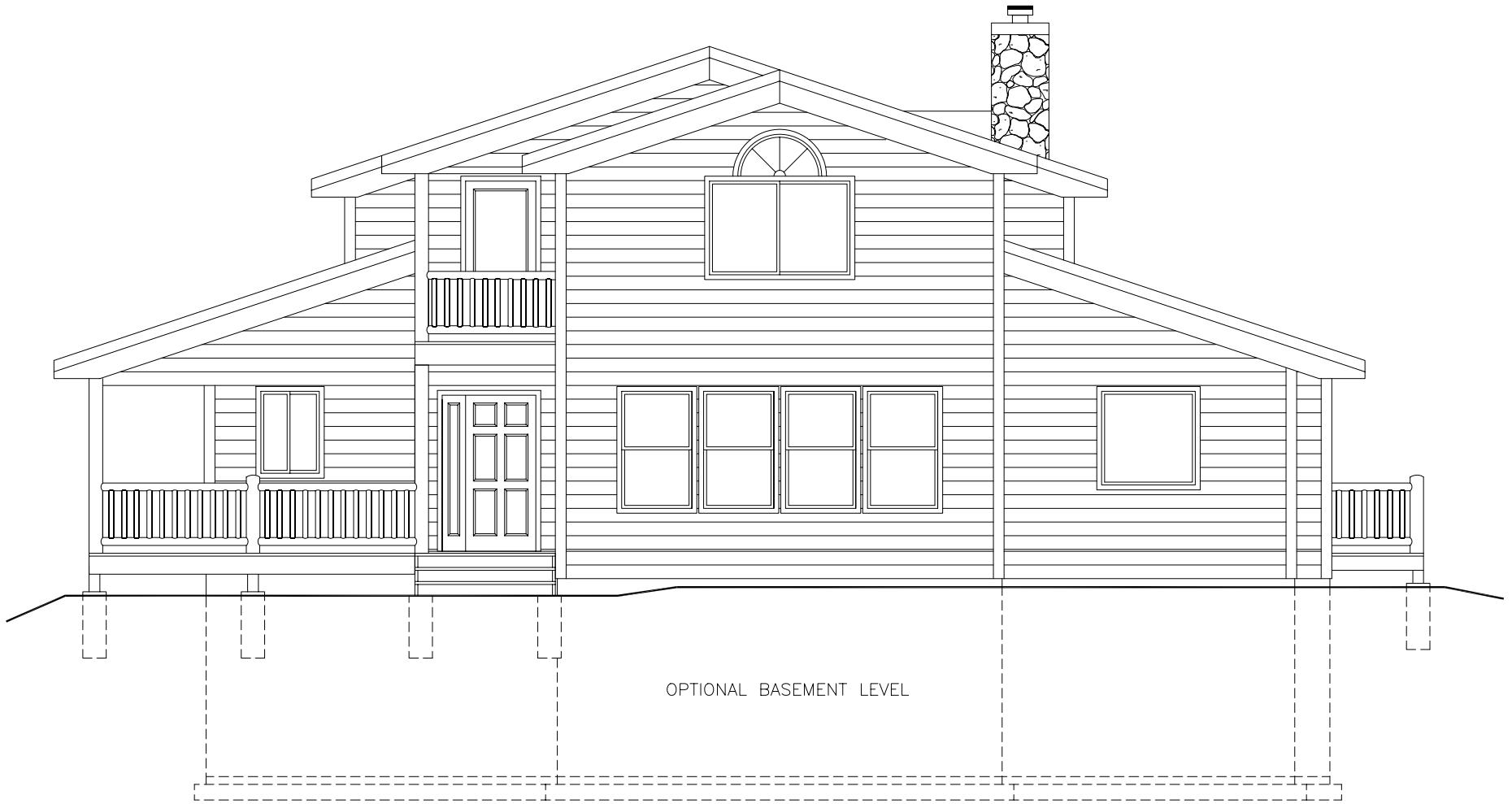

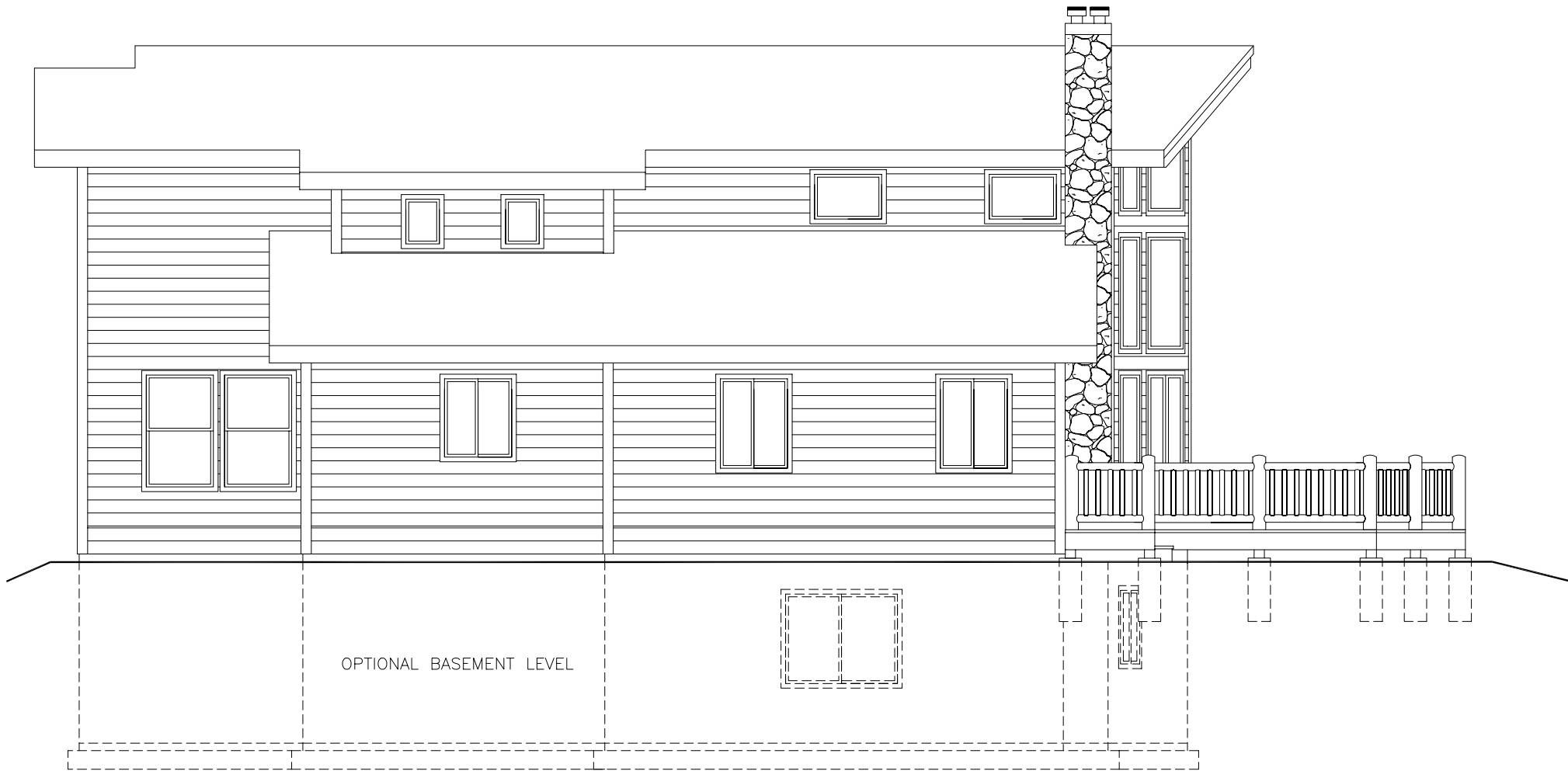
