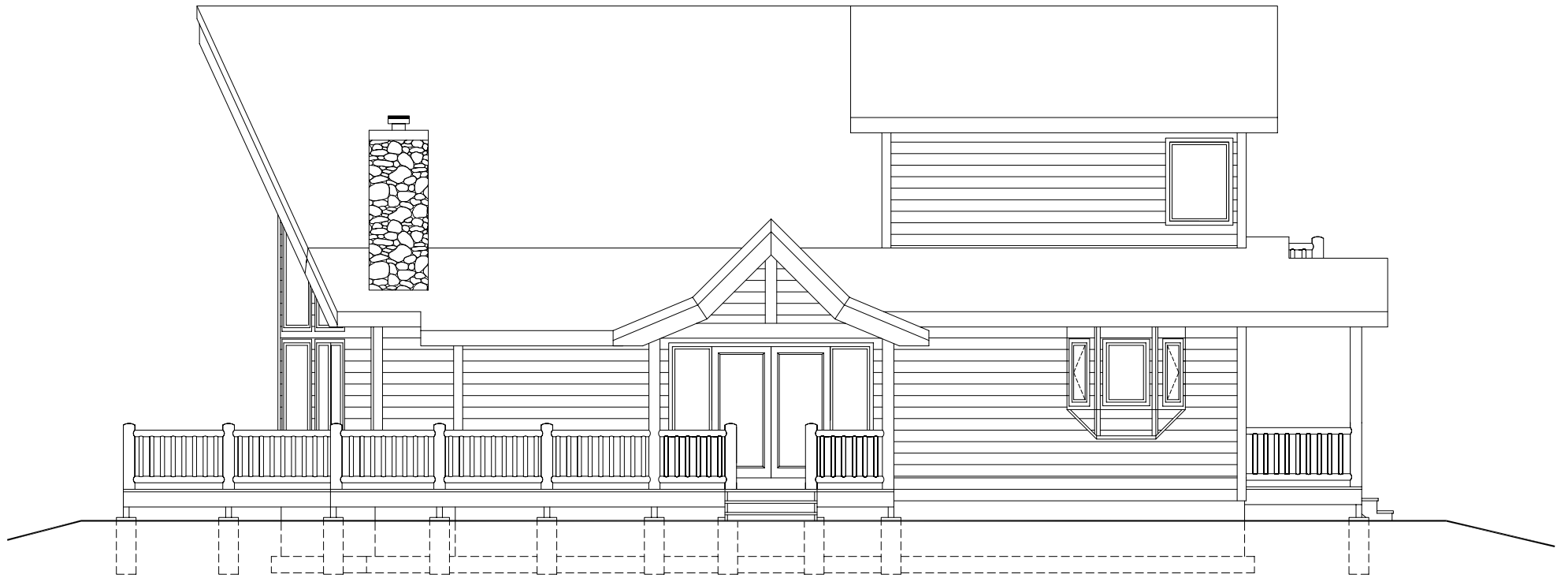

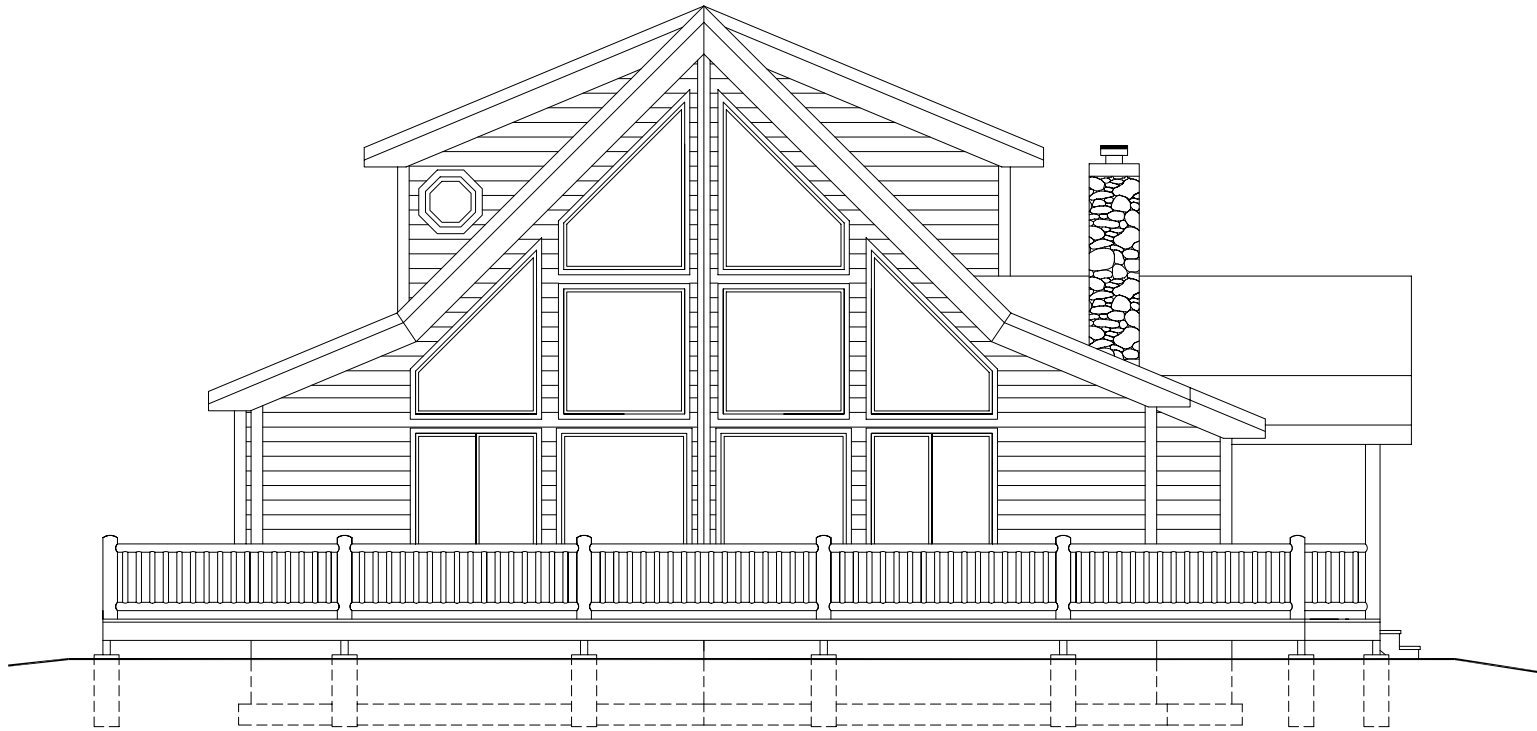

ELEVATION



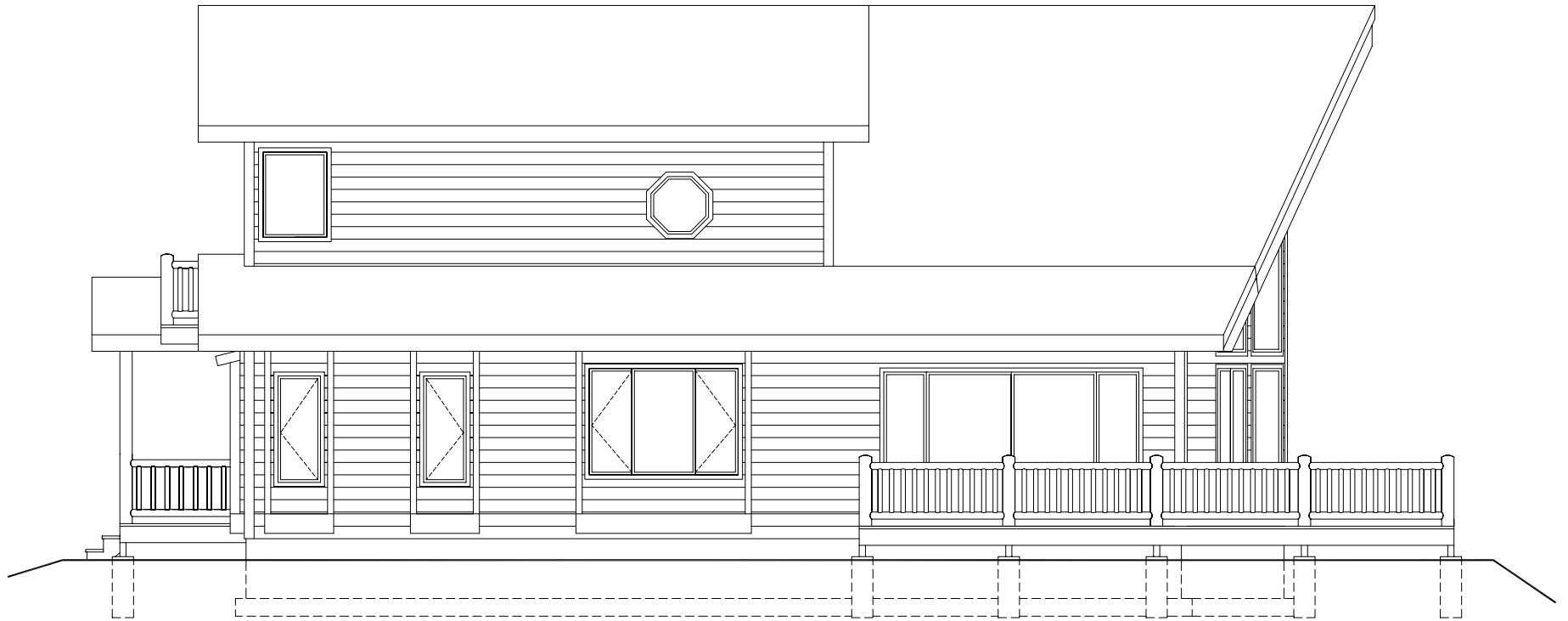
