

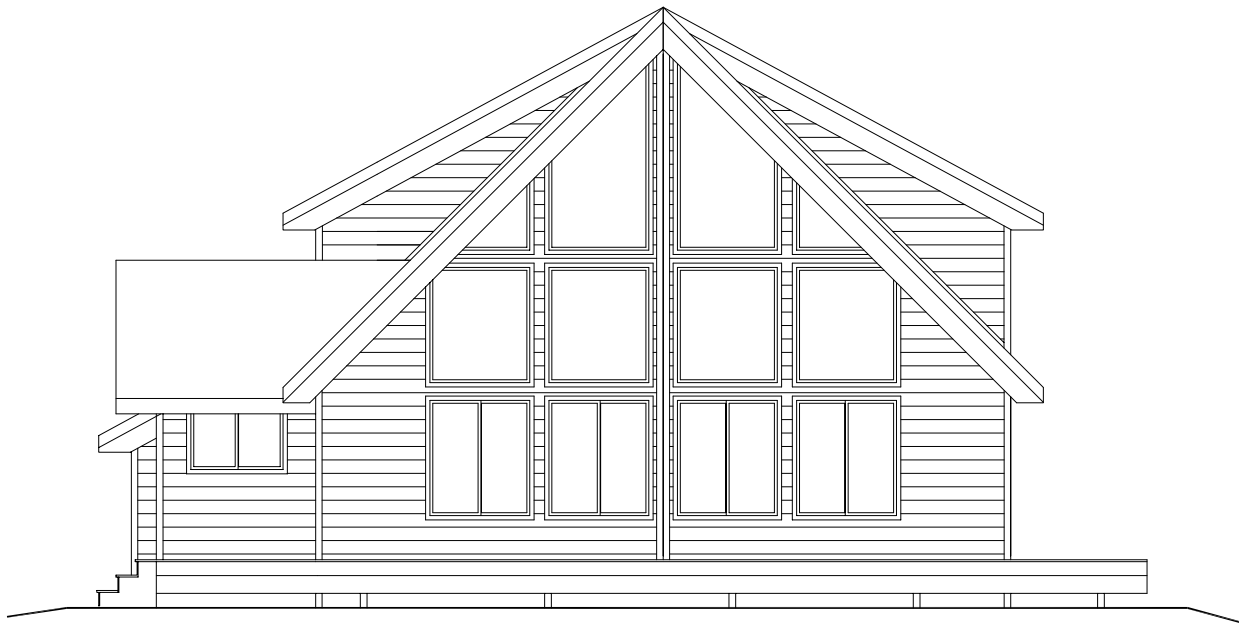

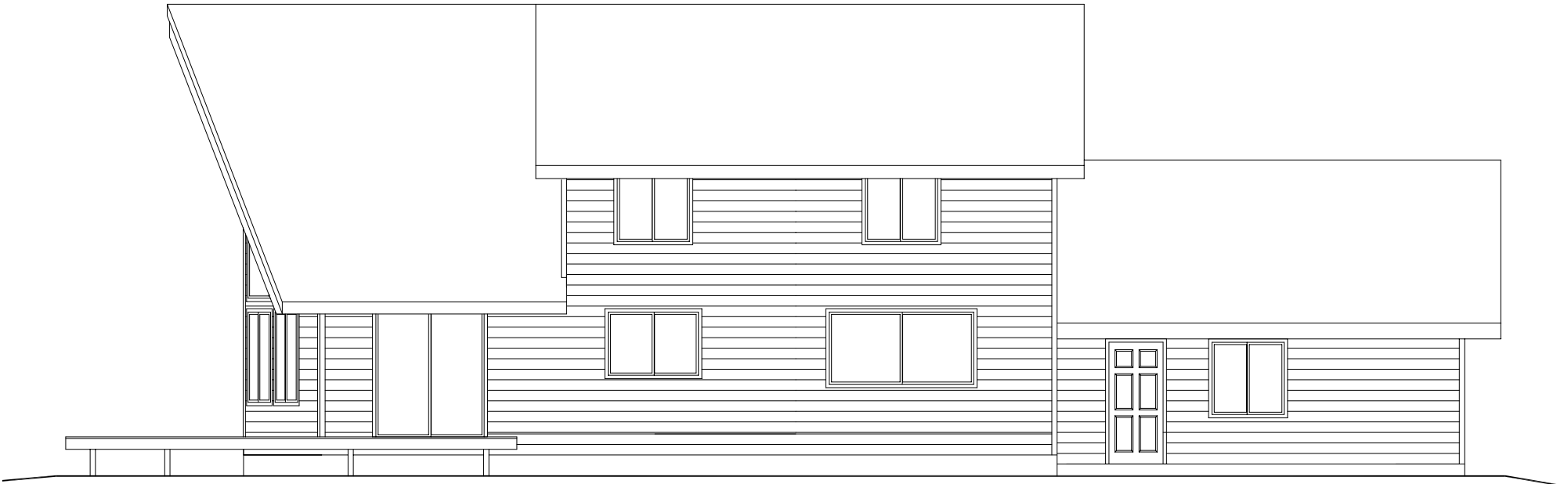

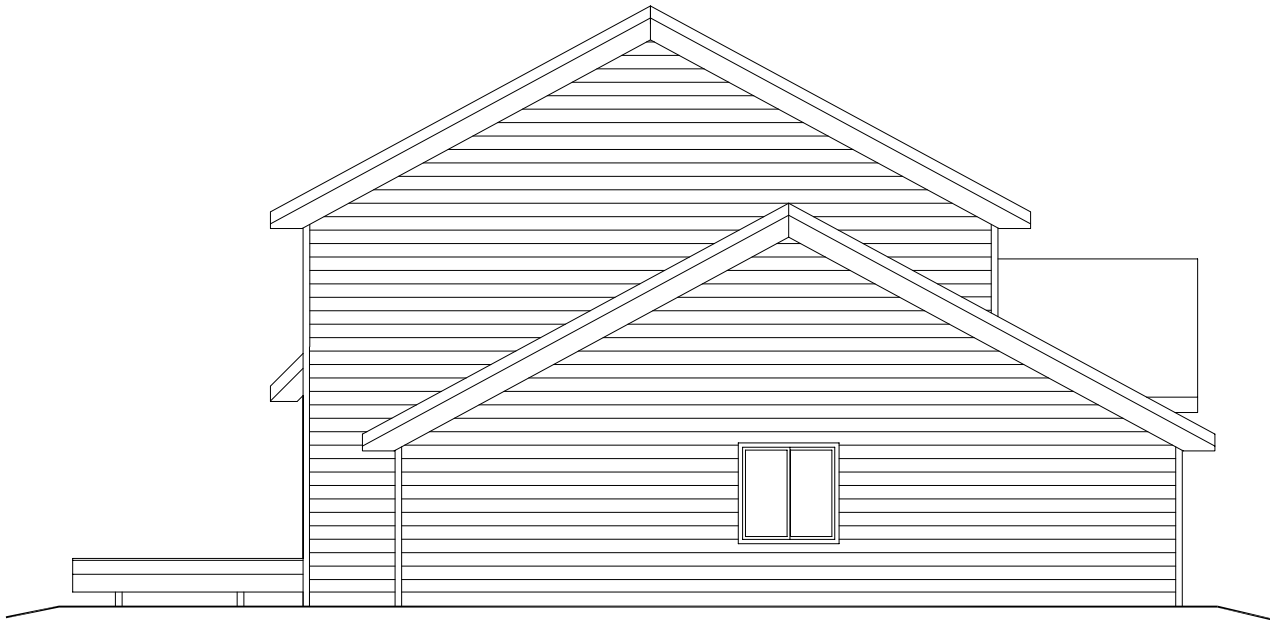
TIMBERLINE STUDY PLAN
