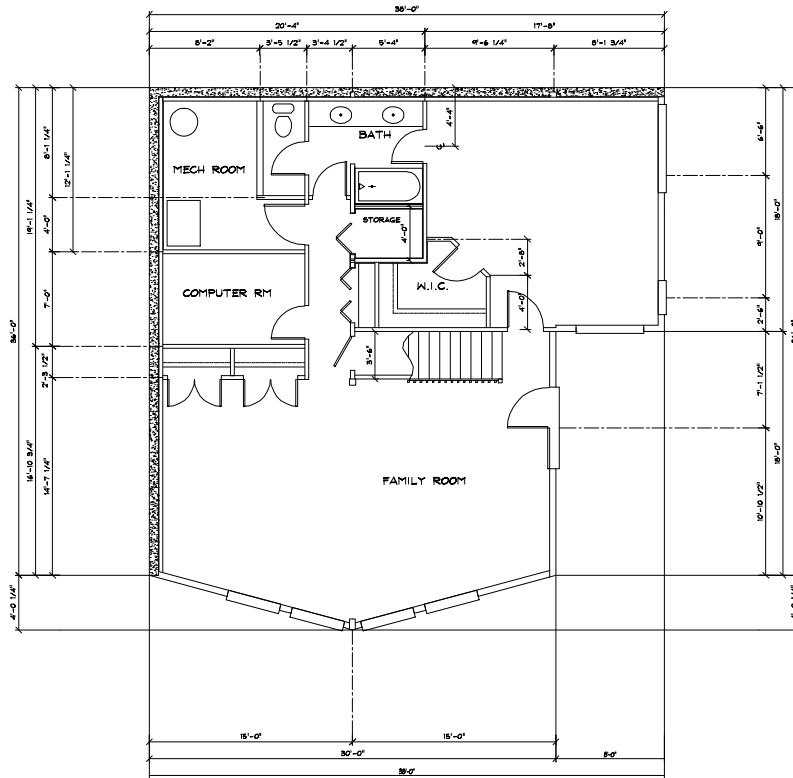

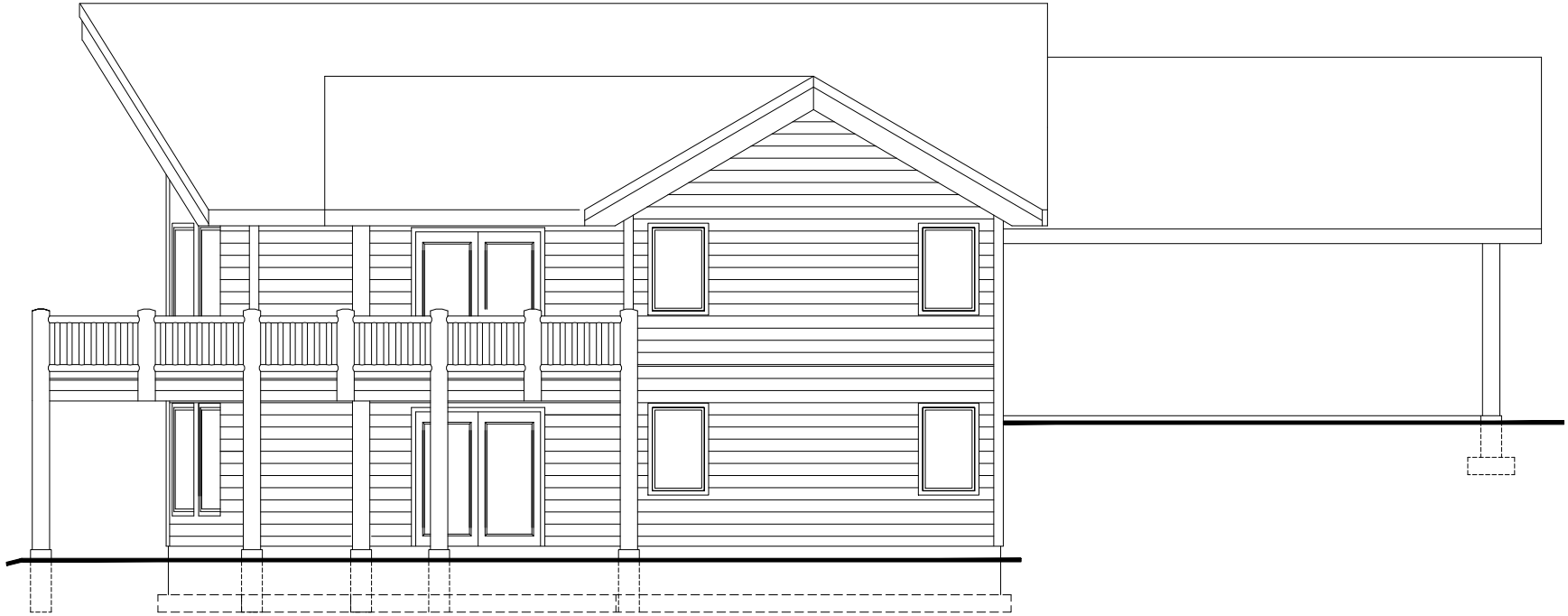

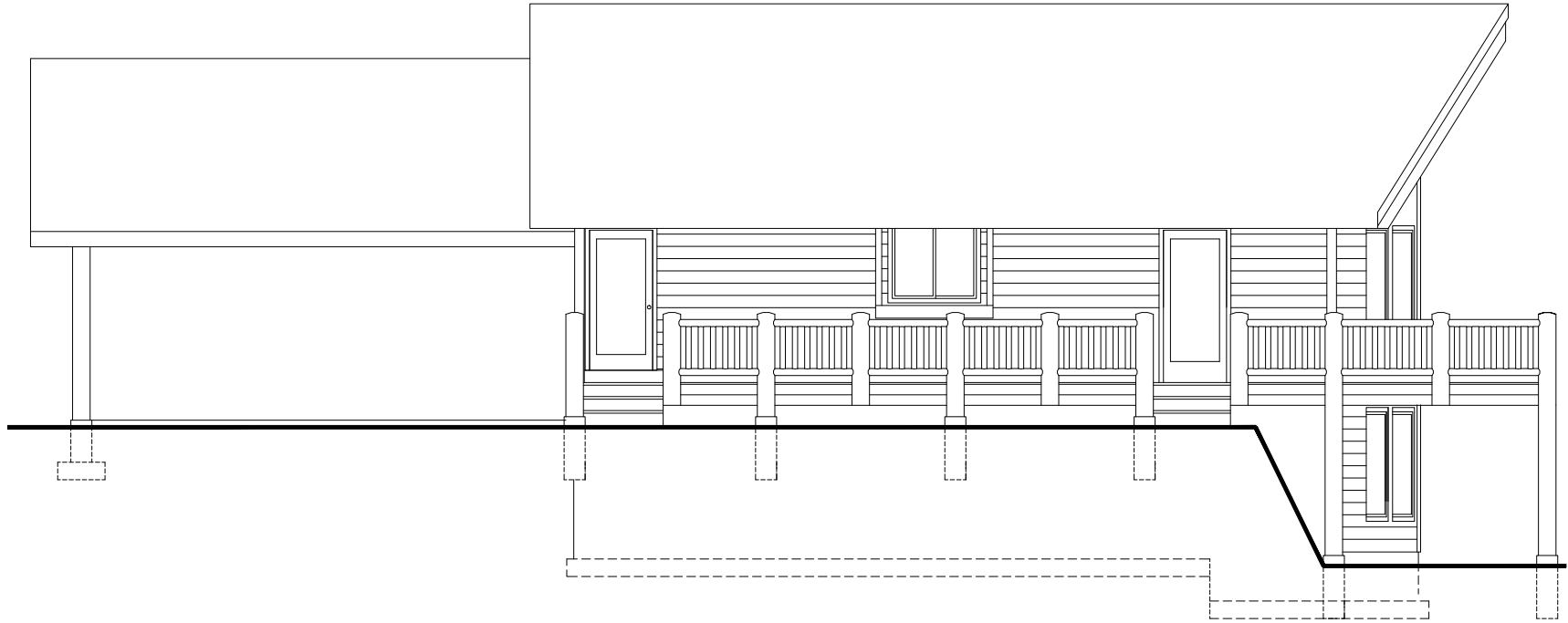

ELEVATION



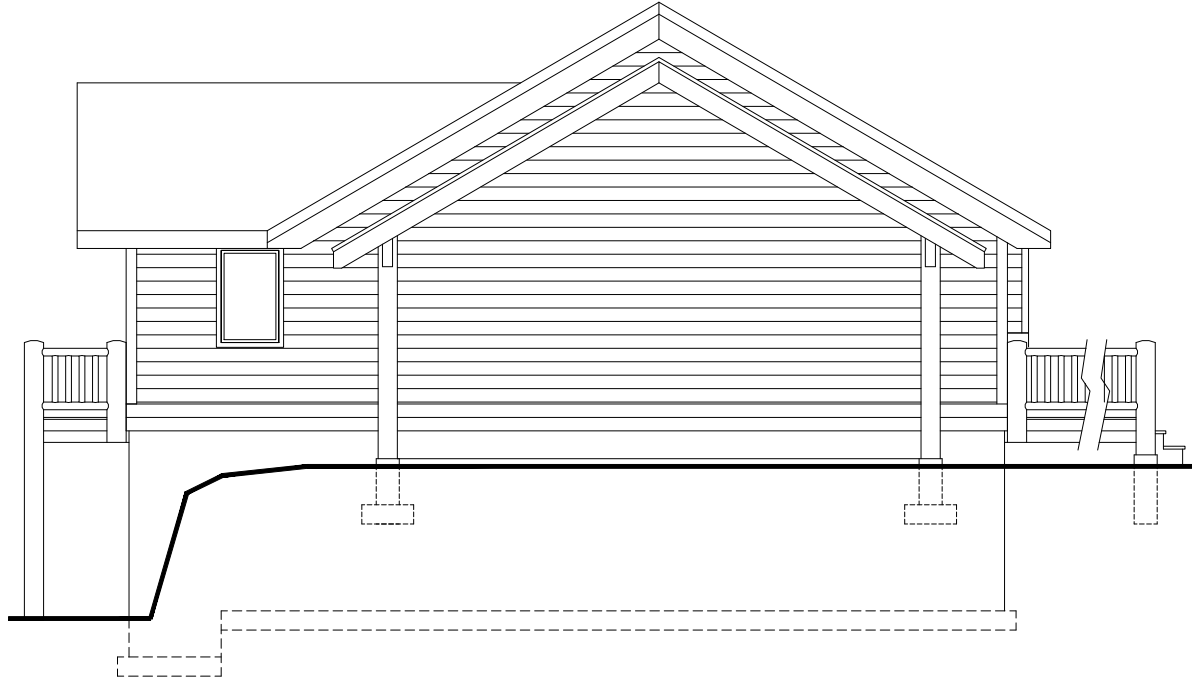
