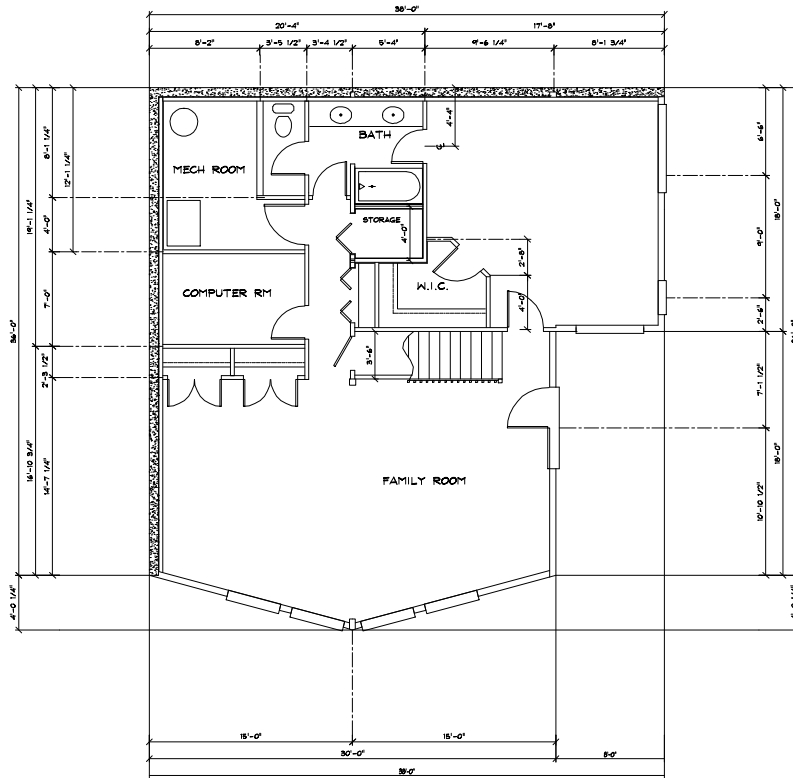

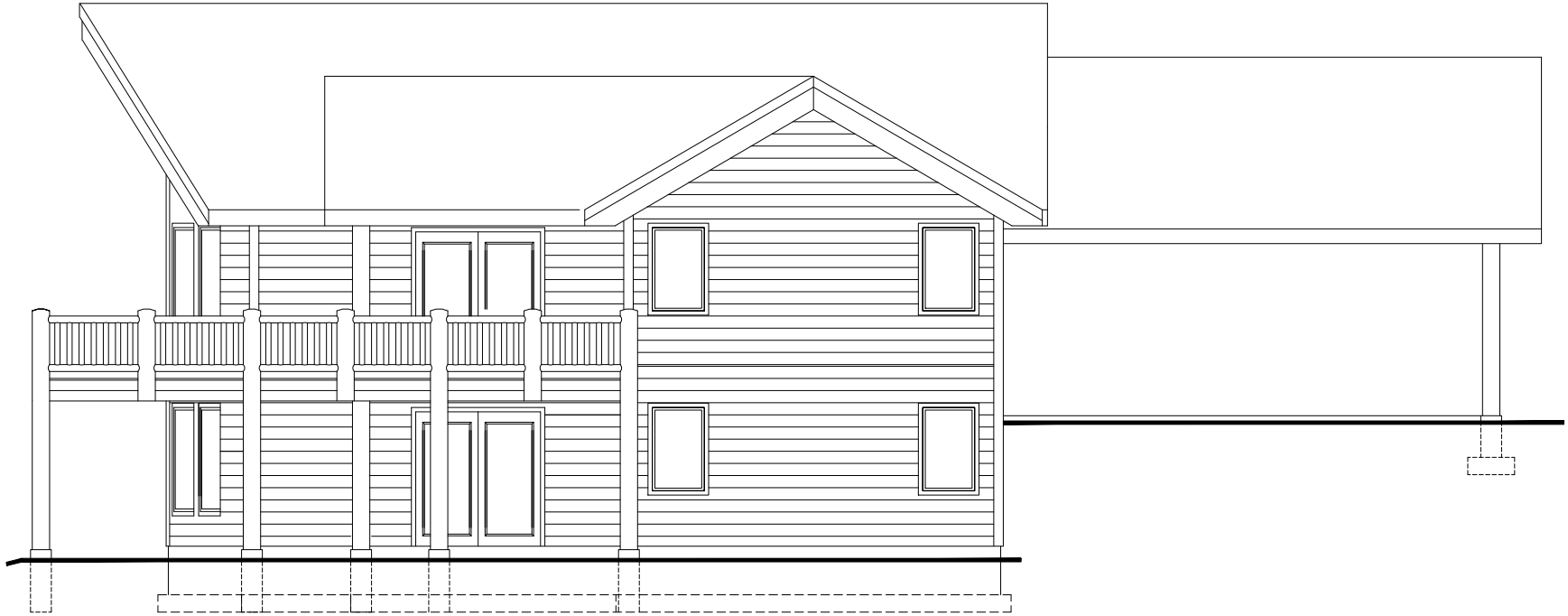

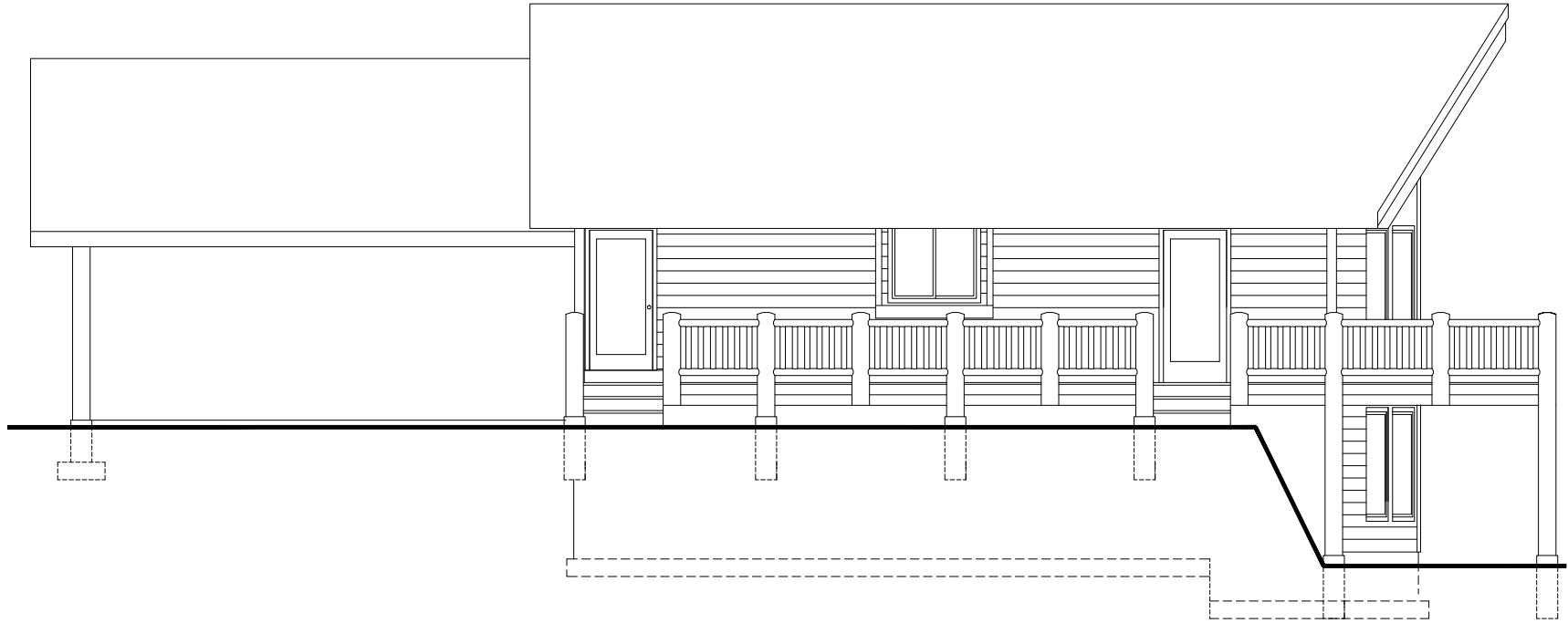

ELEVATION



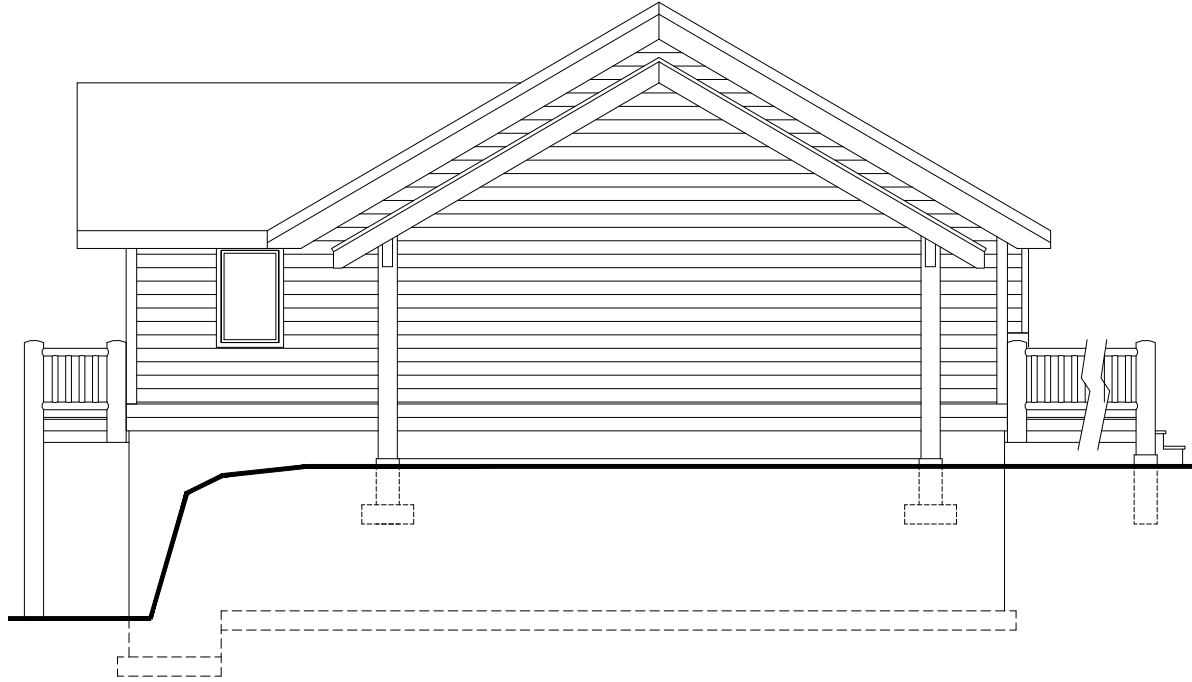
