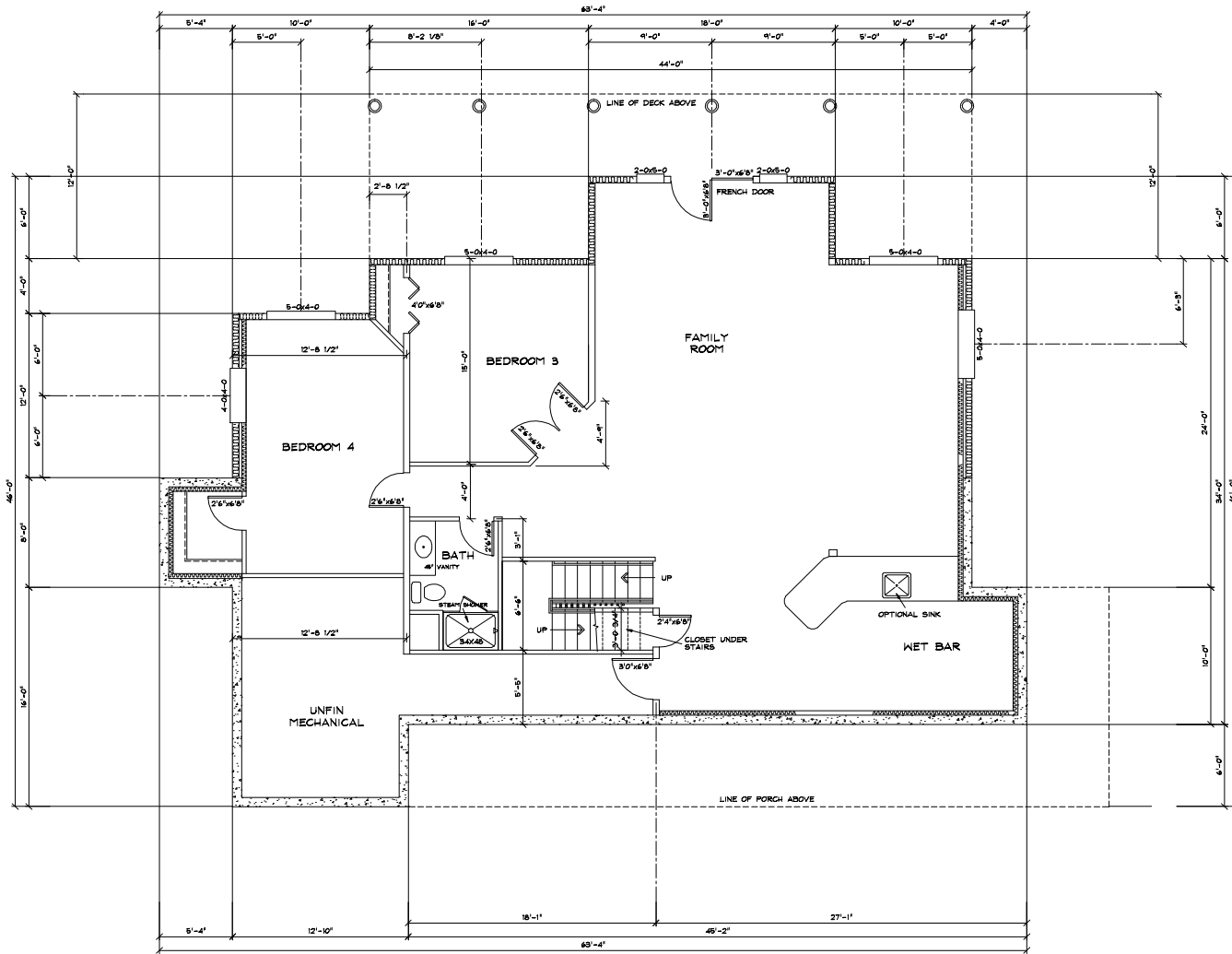


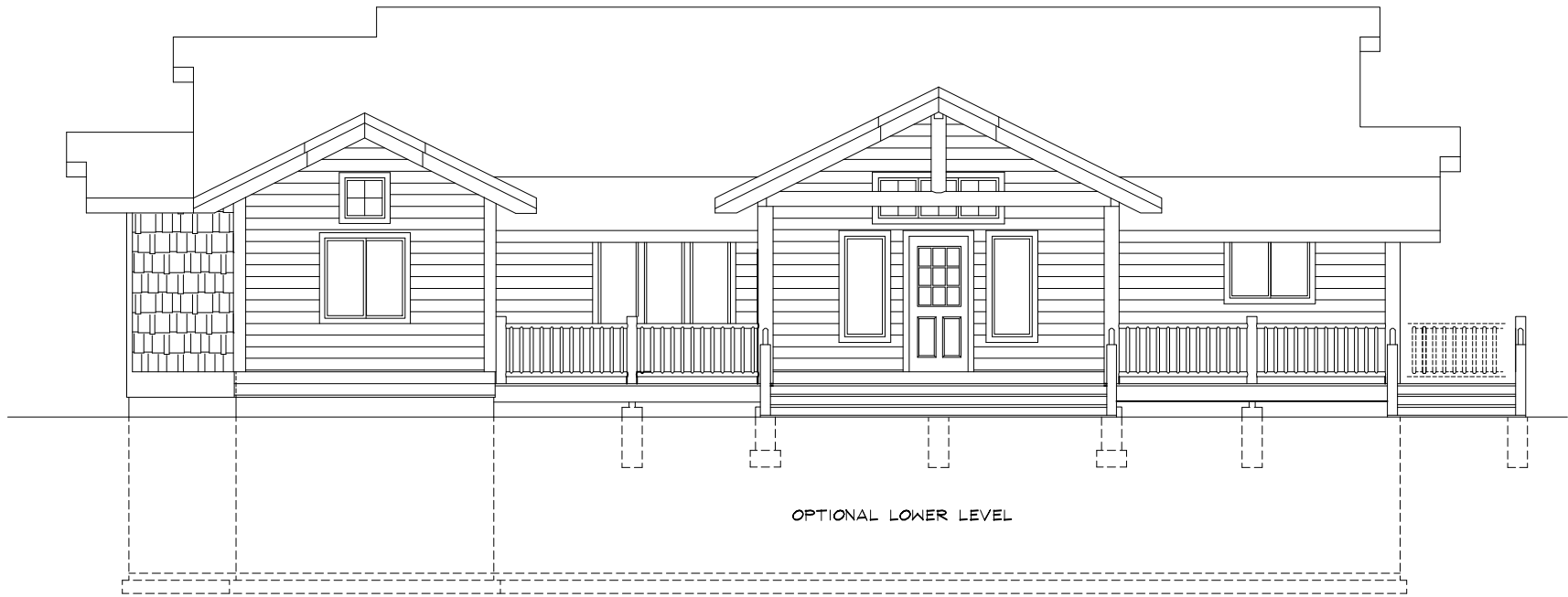

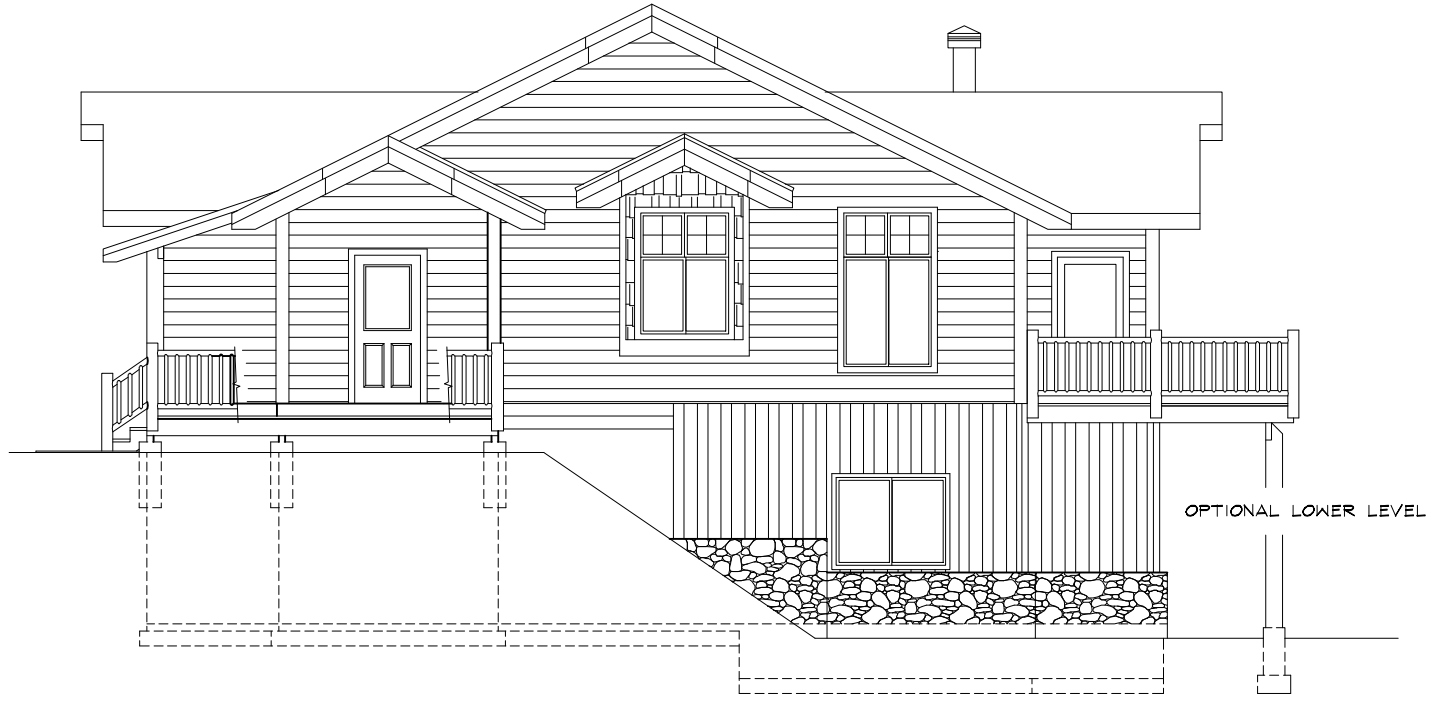

ELEVATION



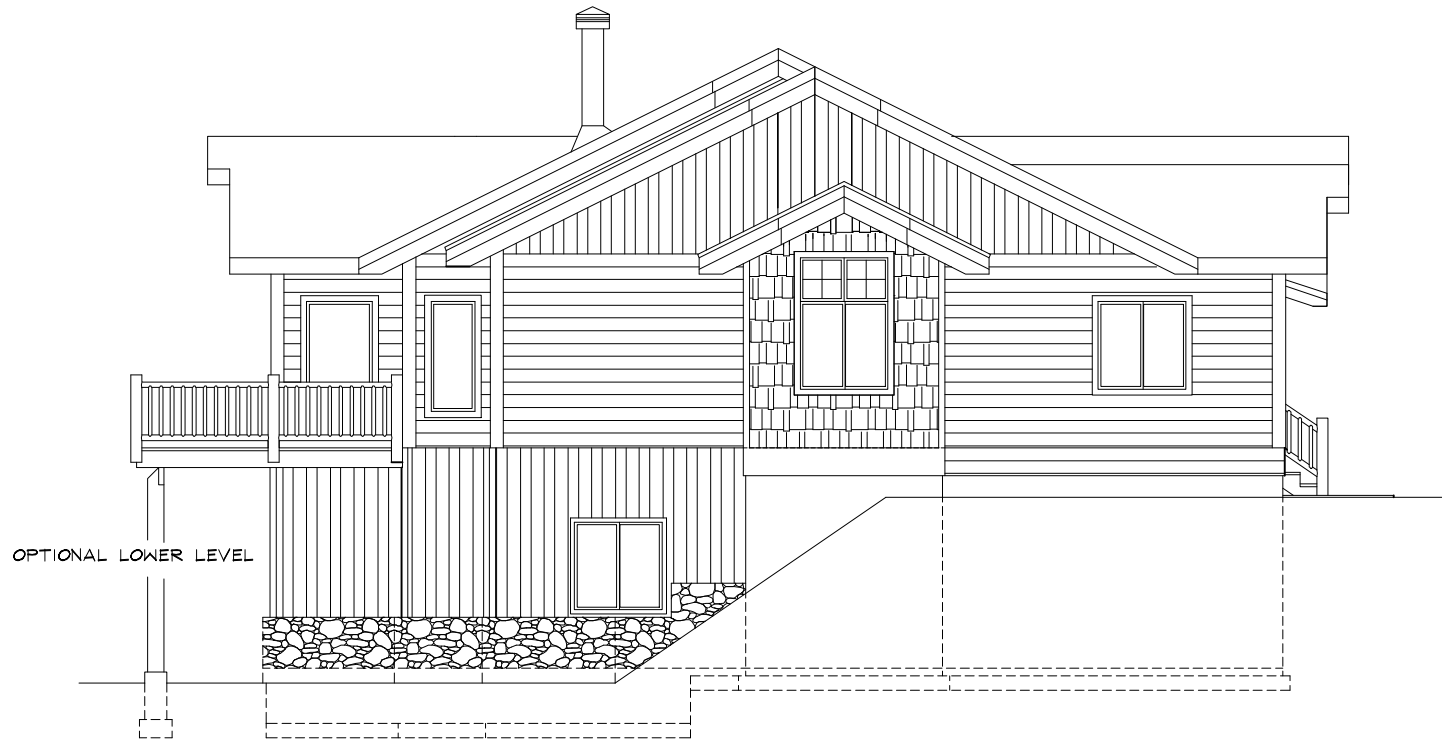
