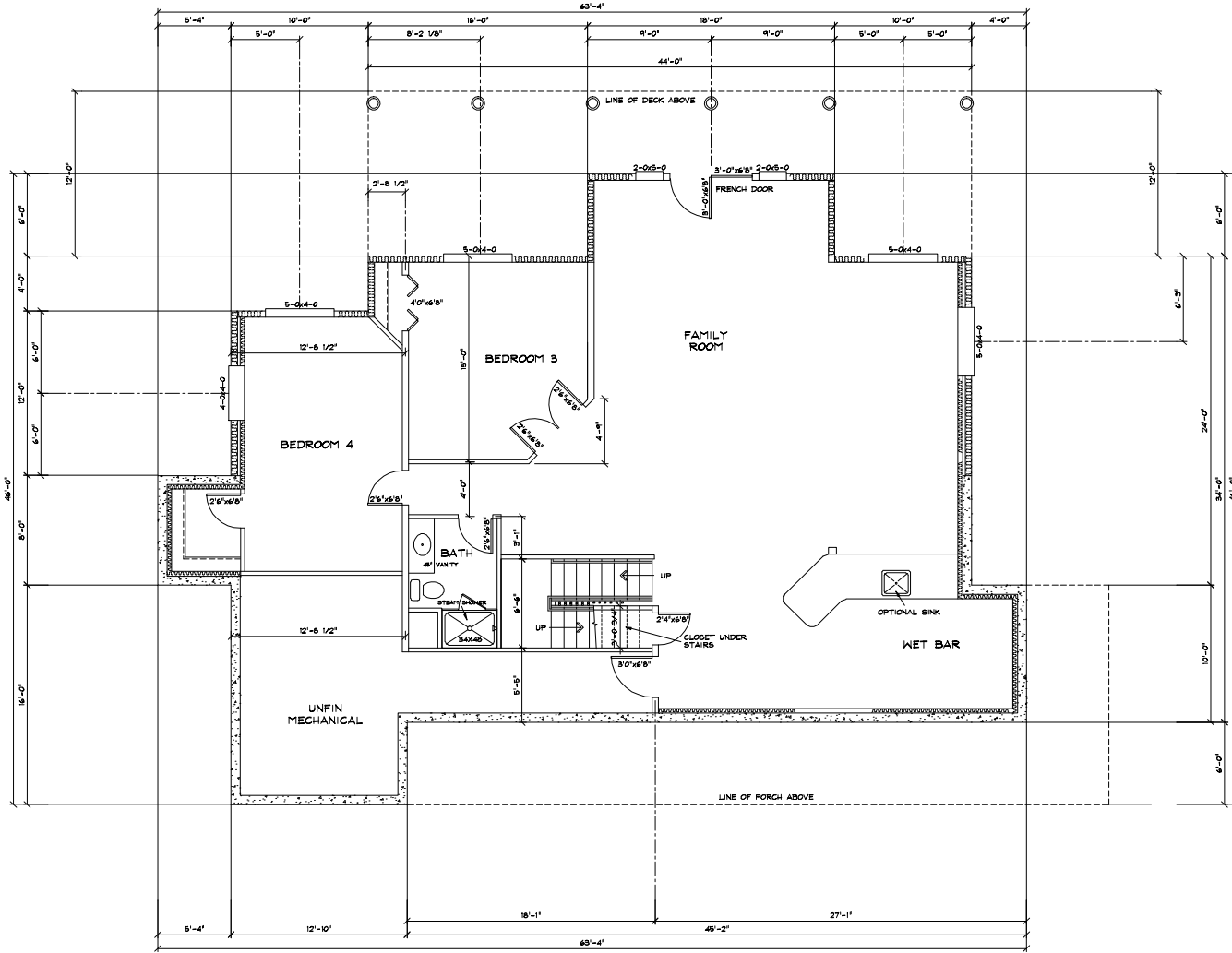


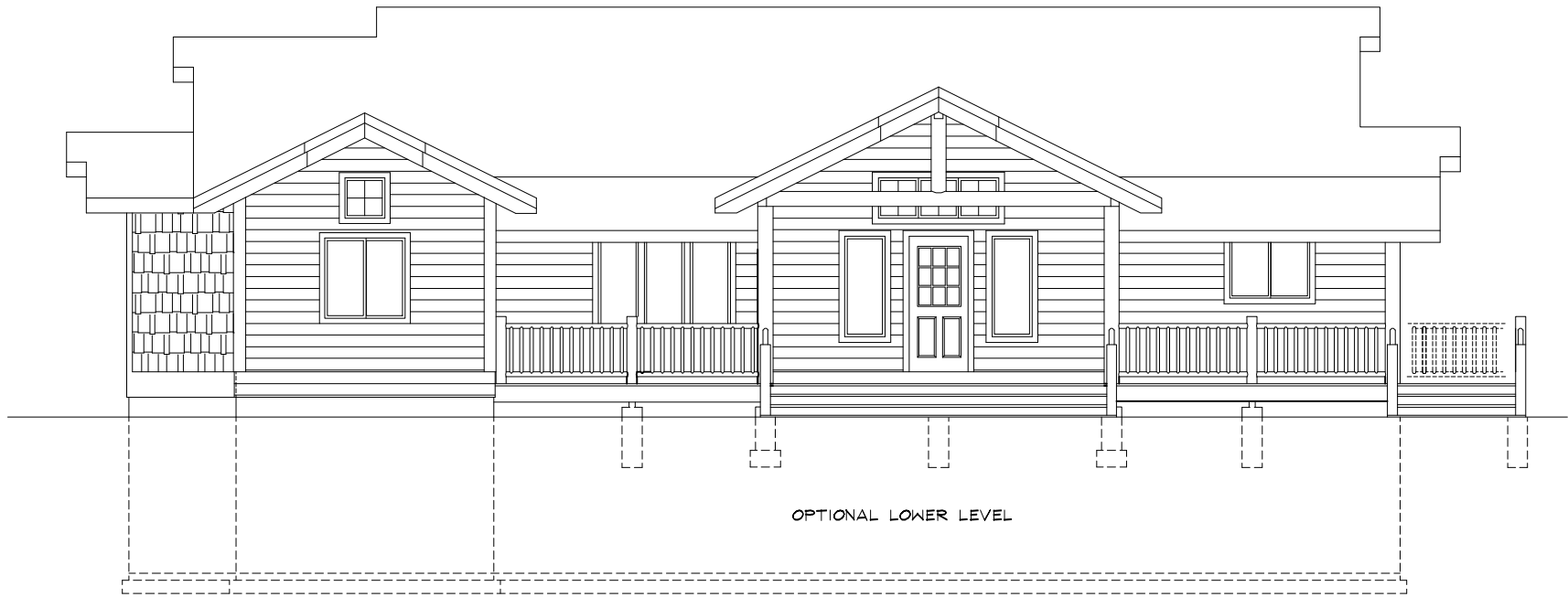

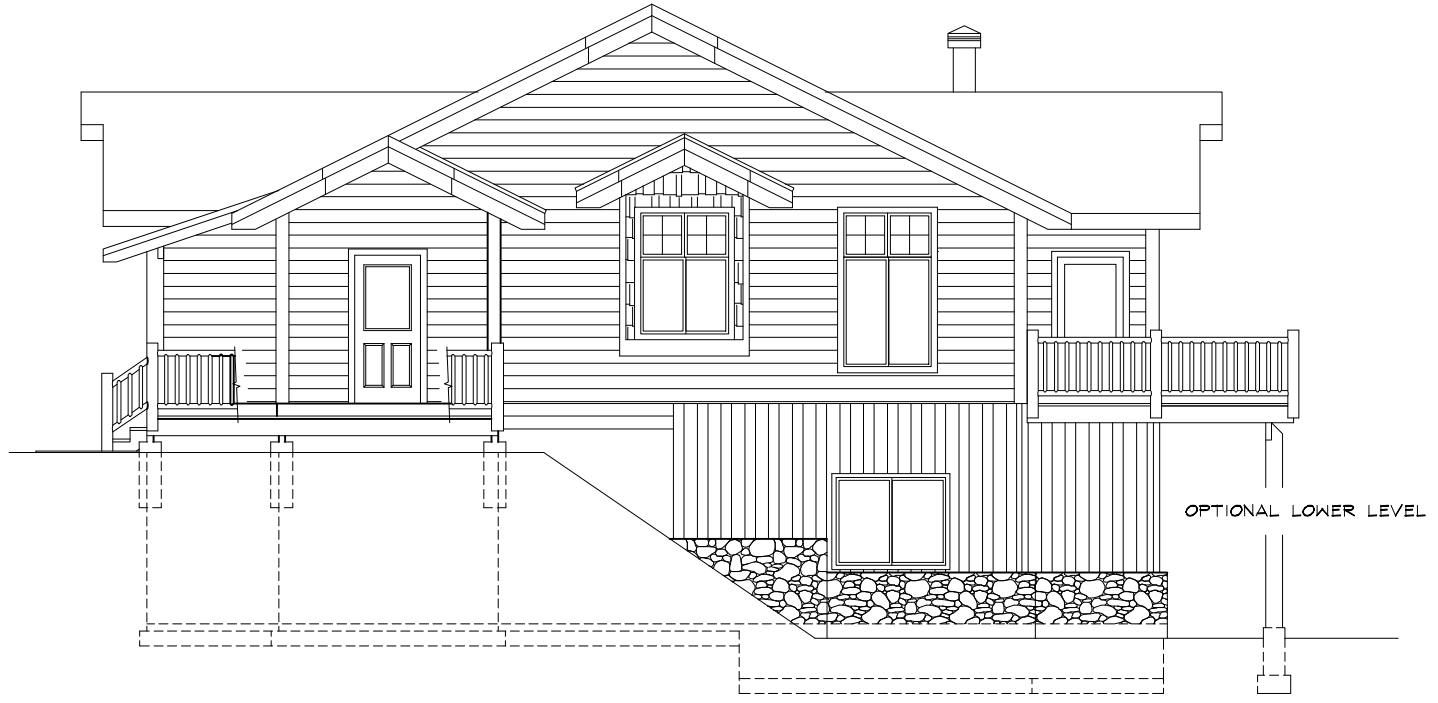

ELEVATION



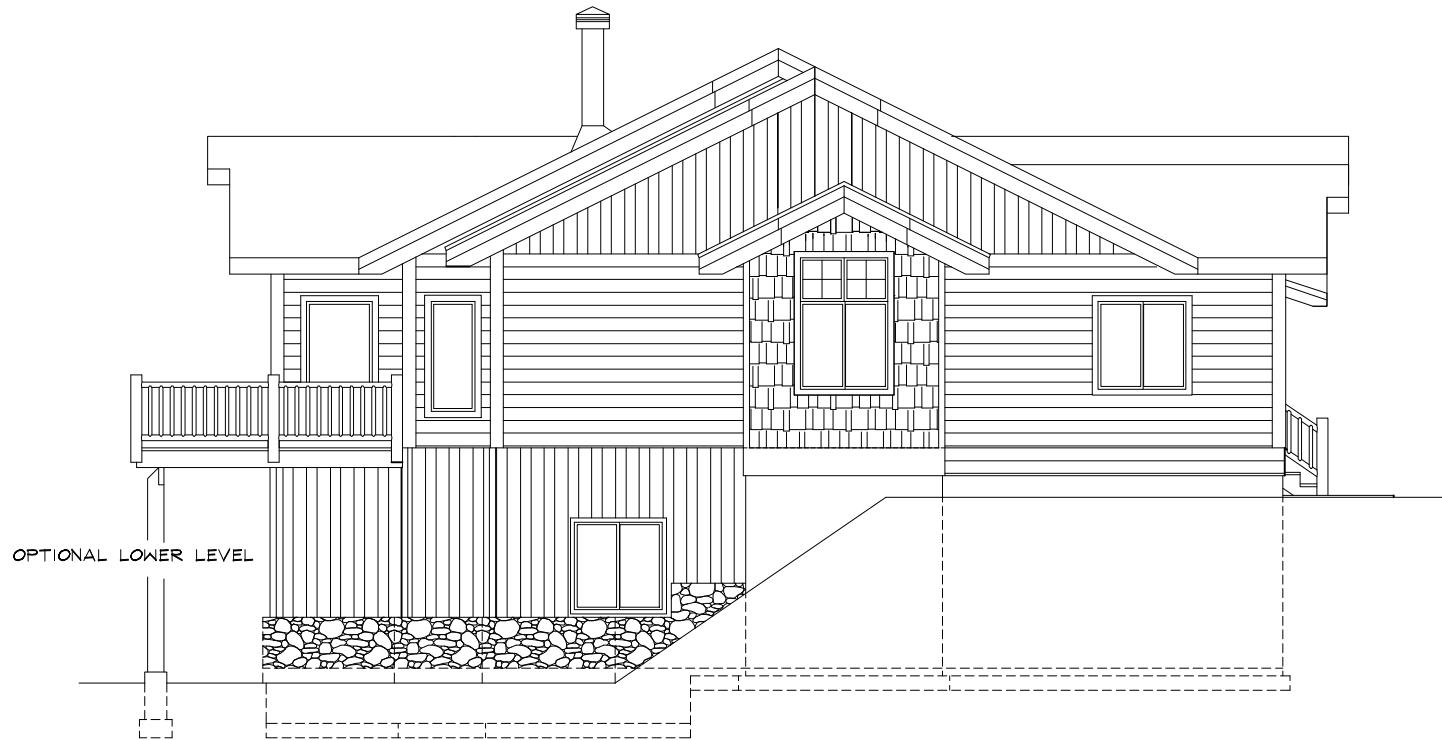
