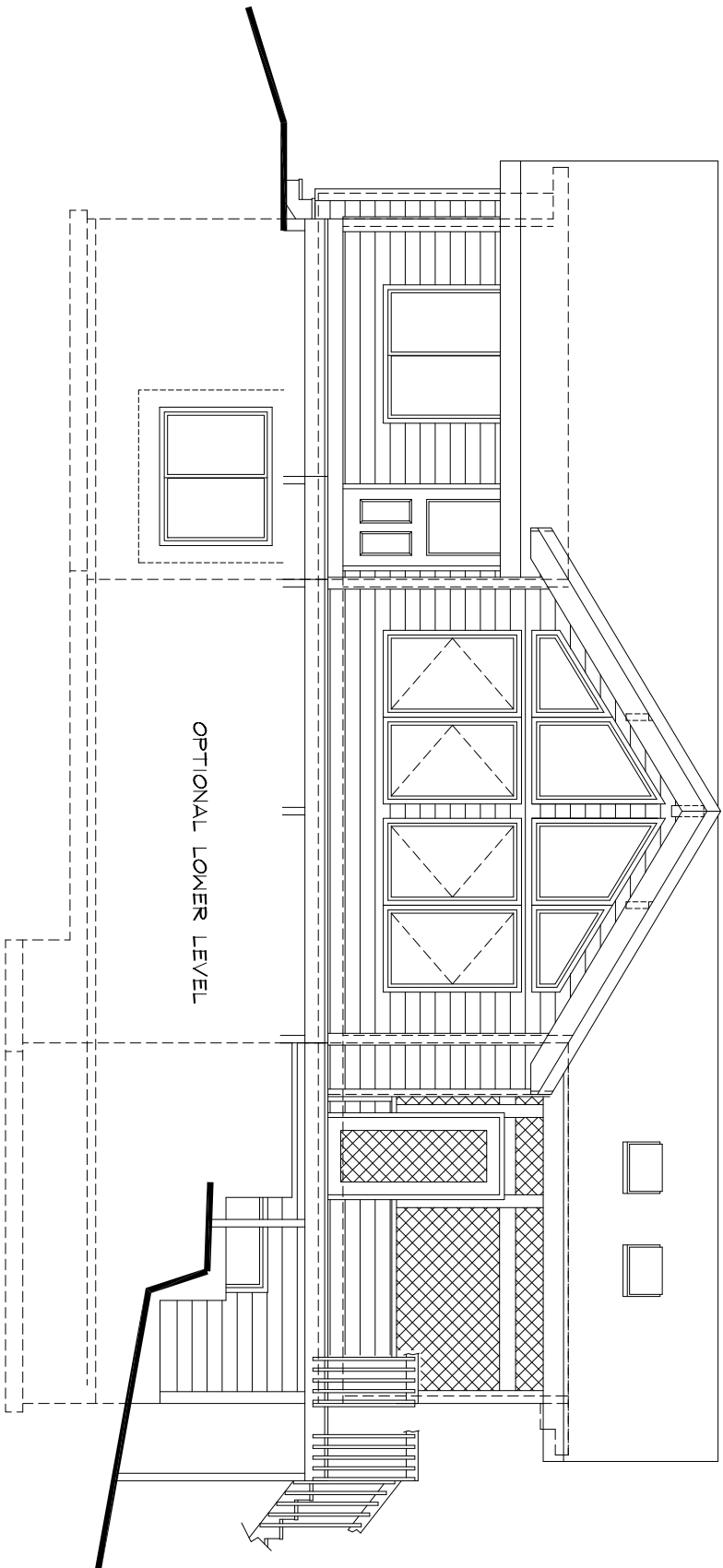

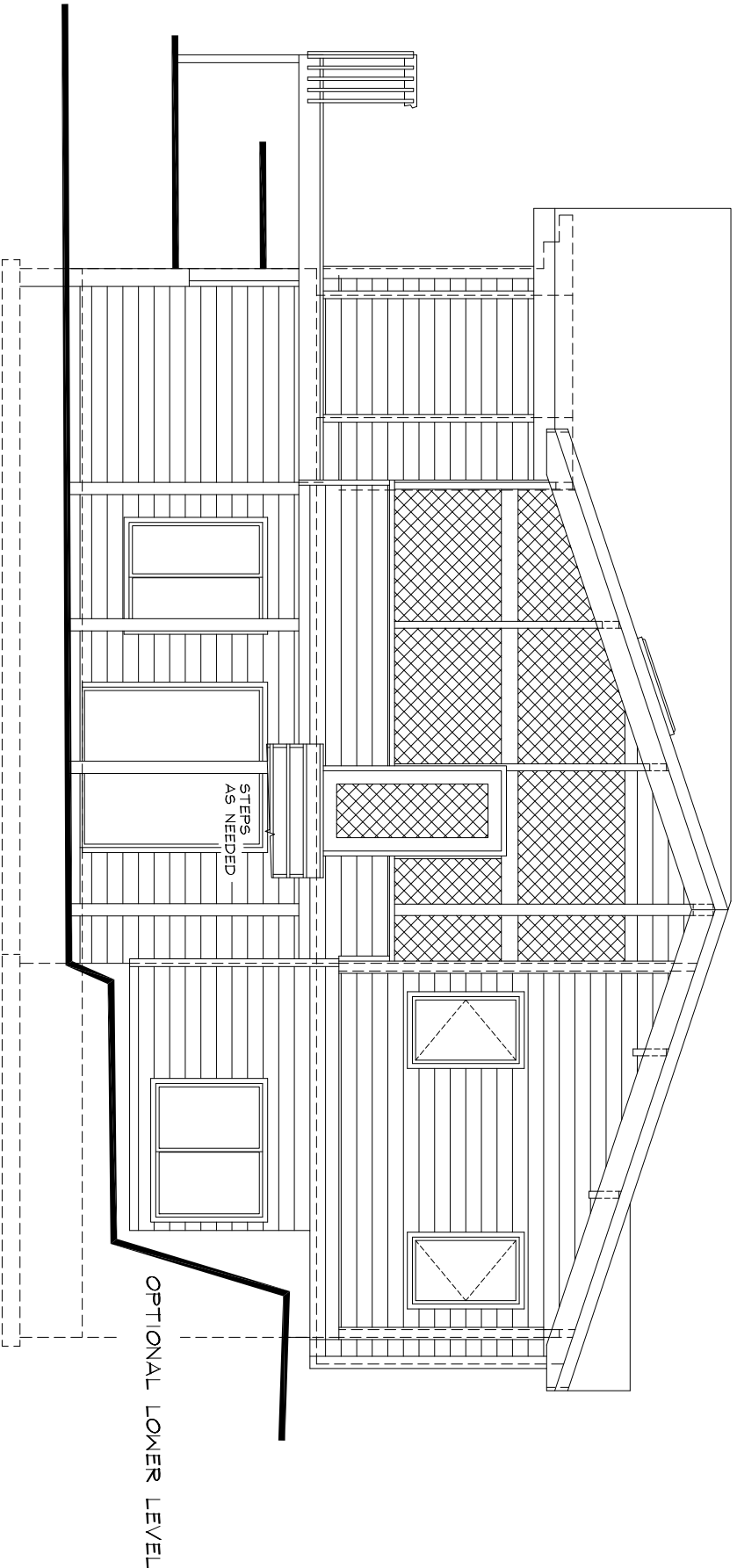
MEADOWLARK STUDY PLAN

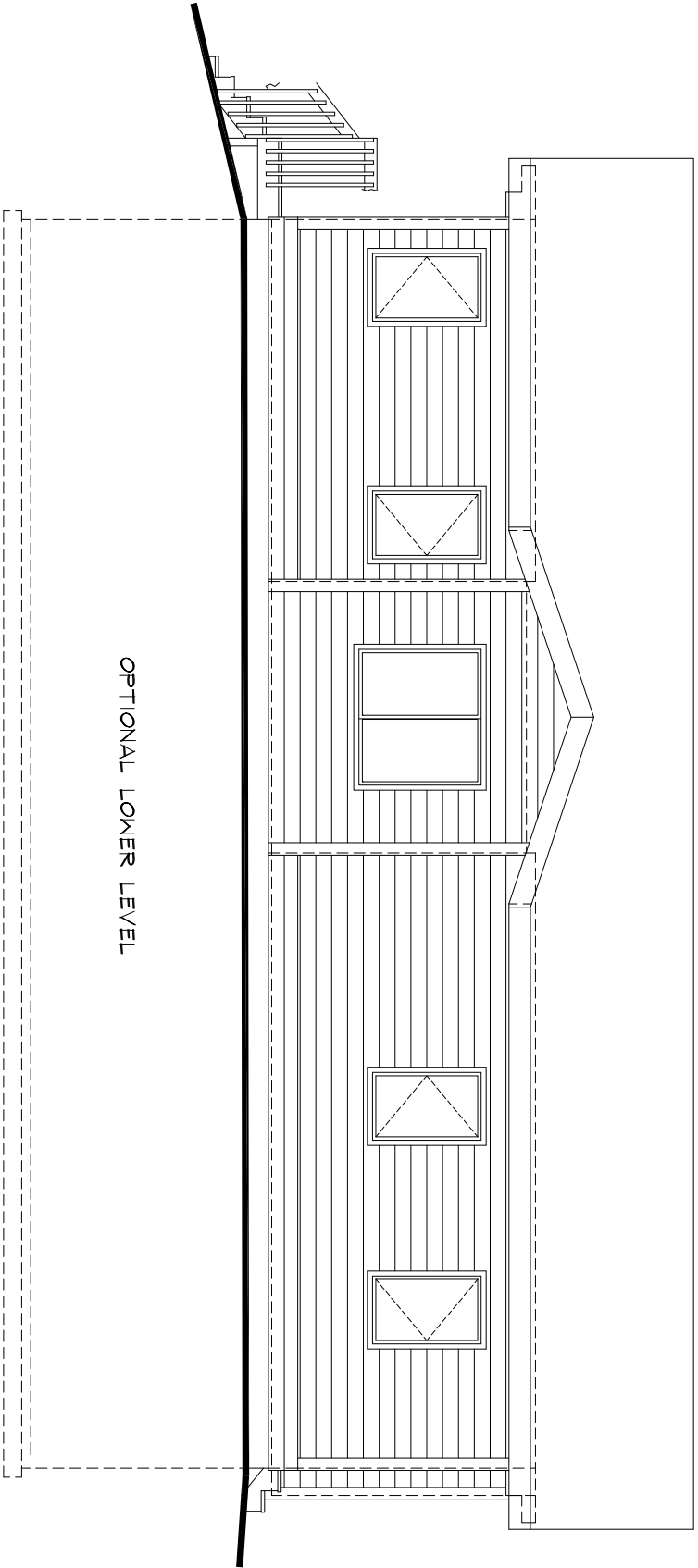

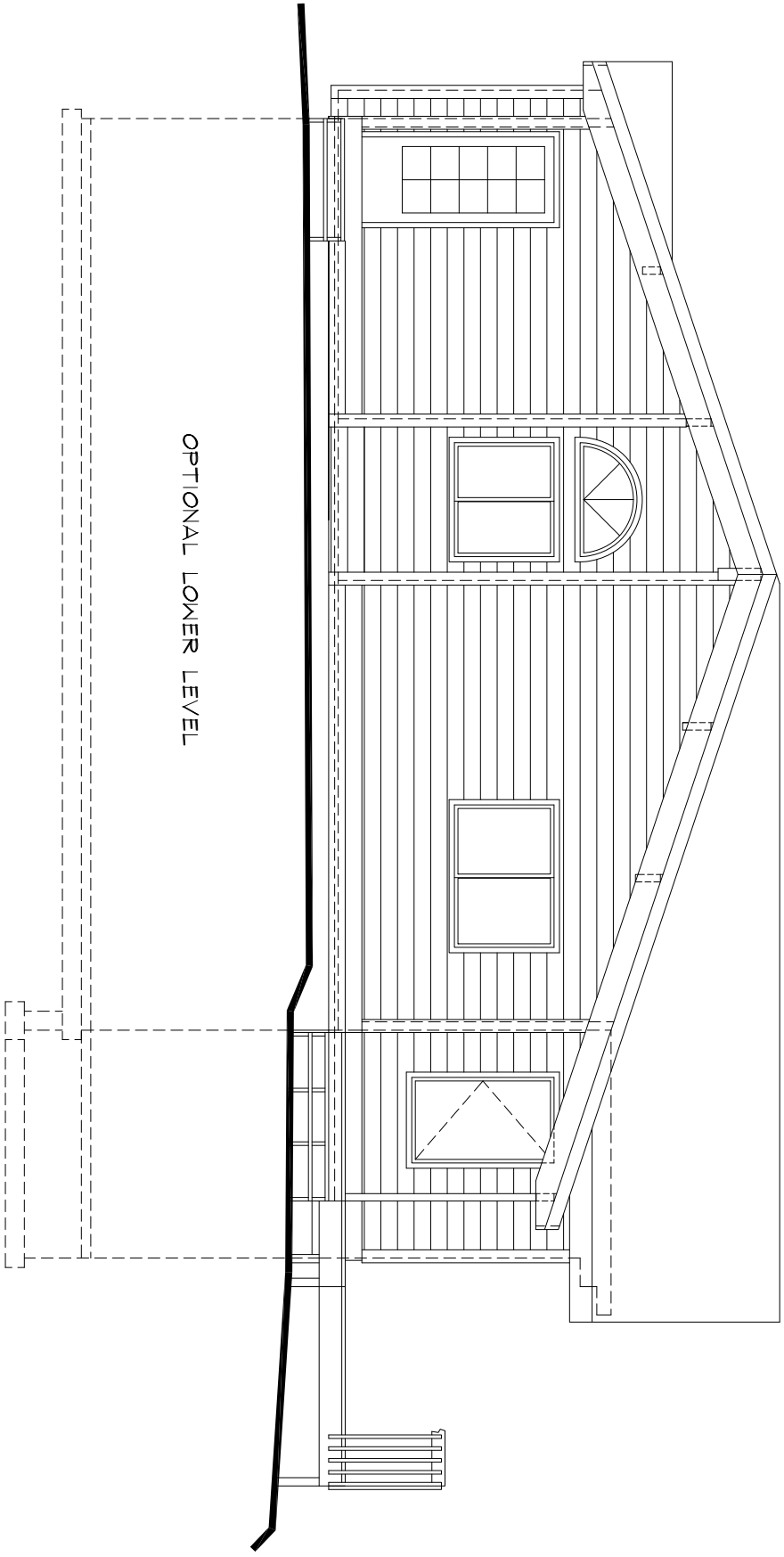
MEADOWLARK STUDY PLAN
