

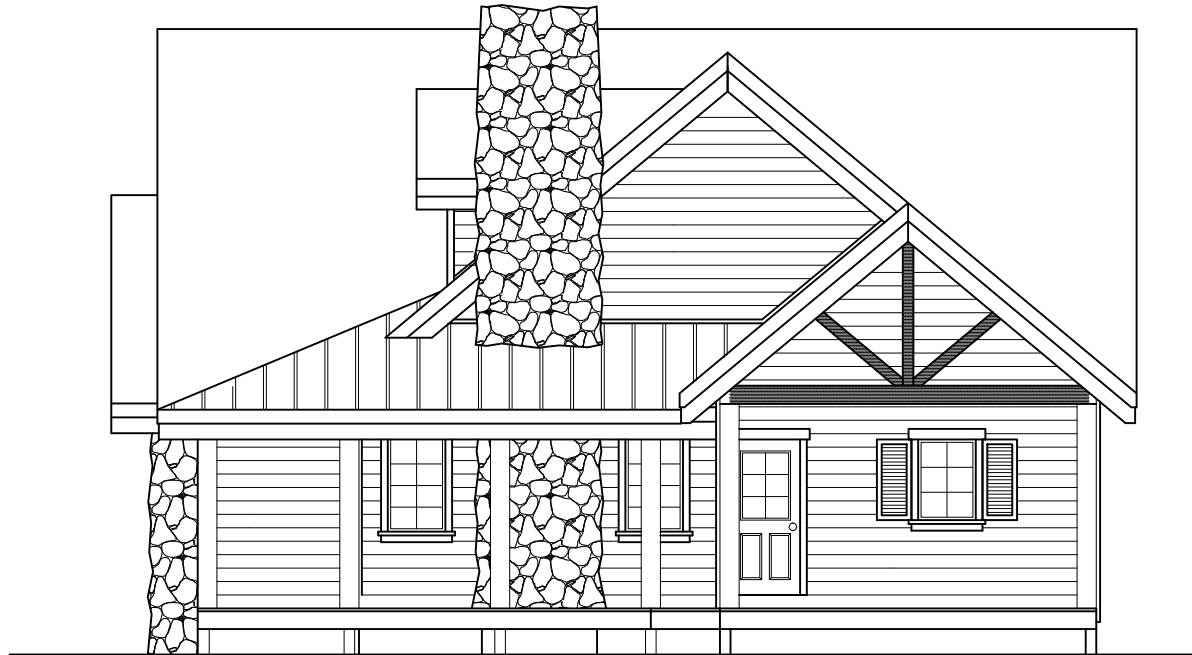

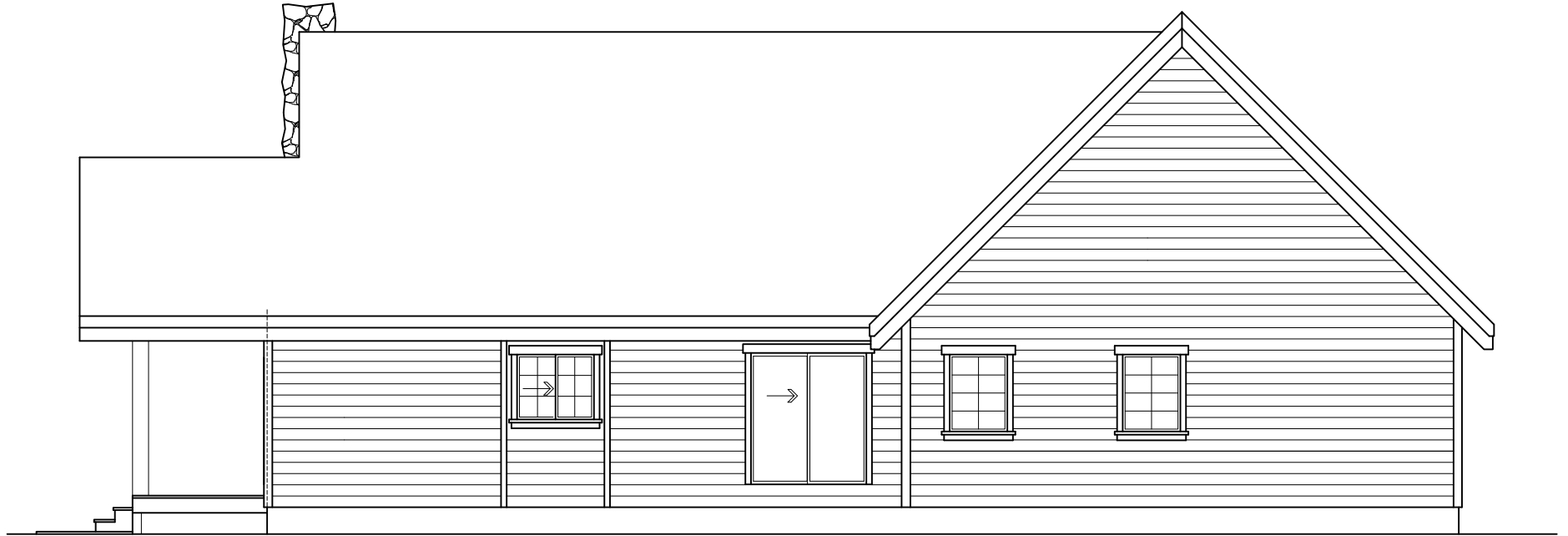

ELEVATION



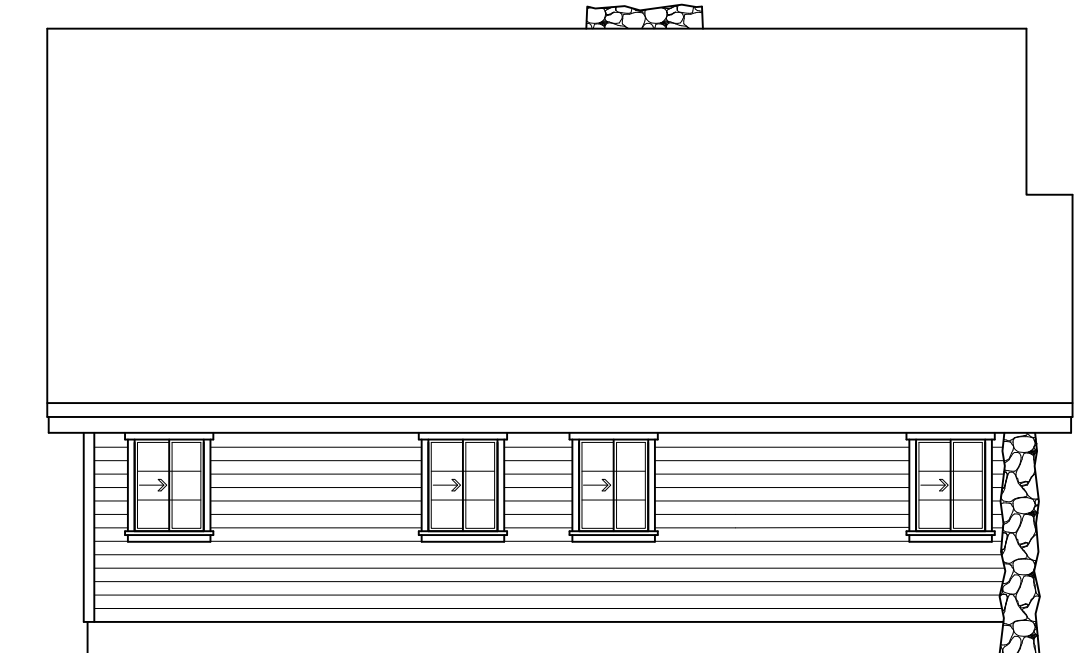
