

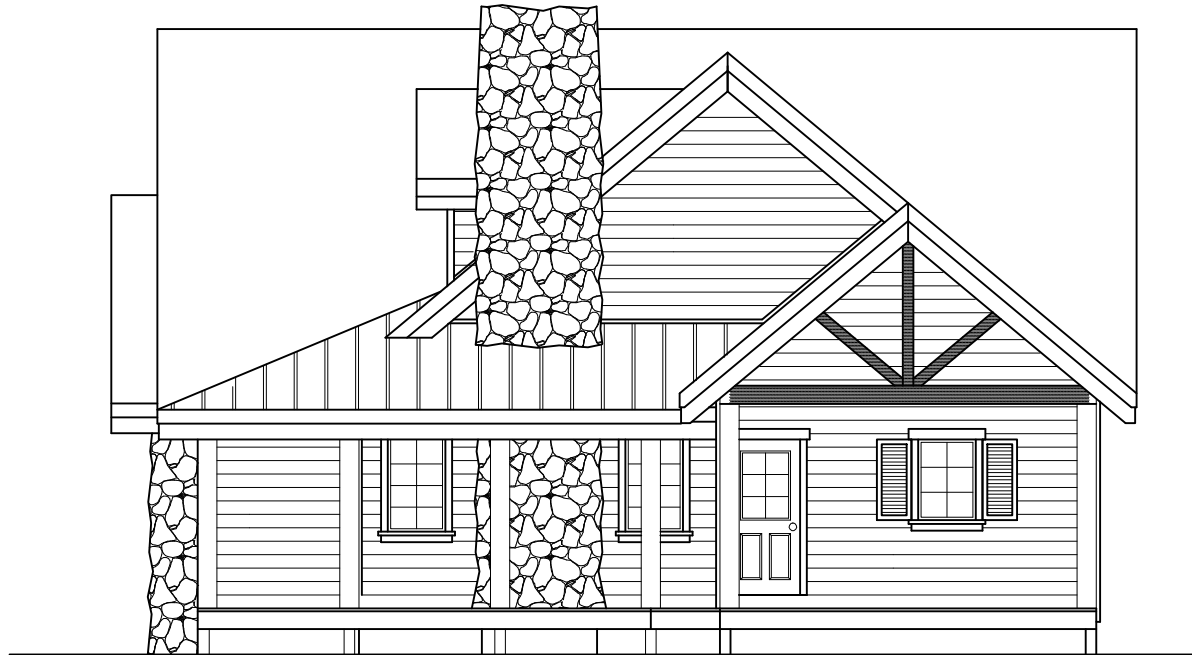

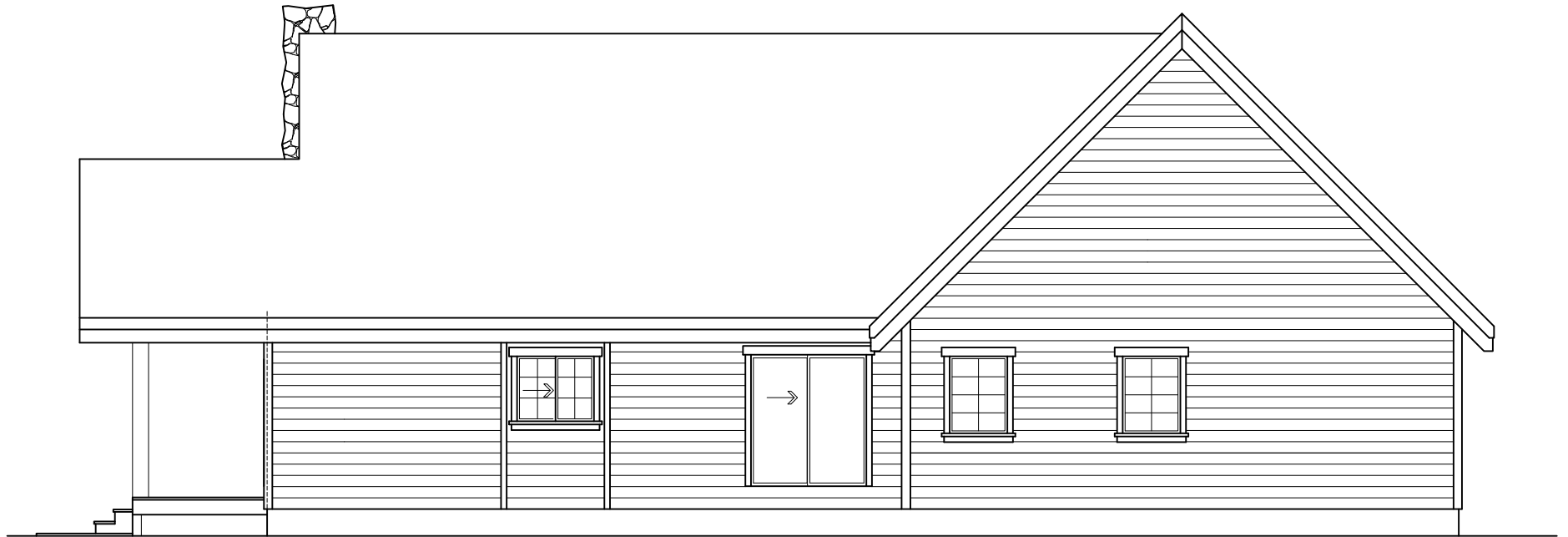

ELEVATION



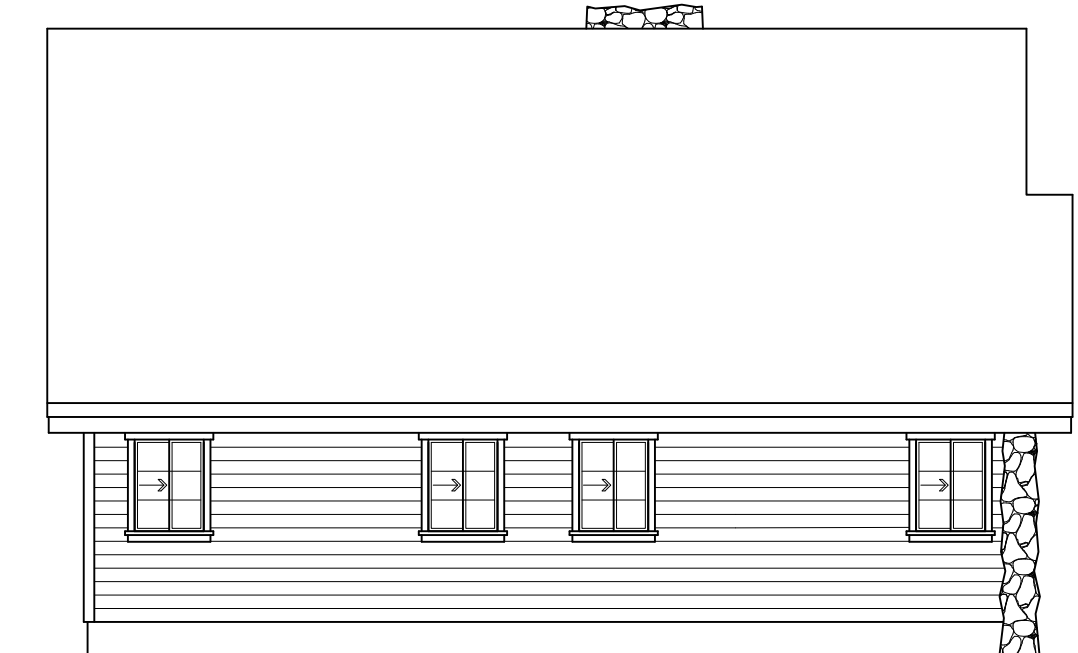
