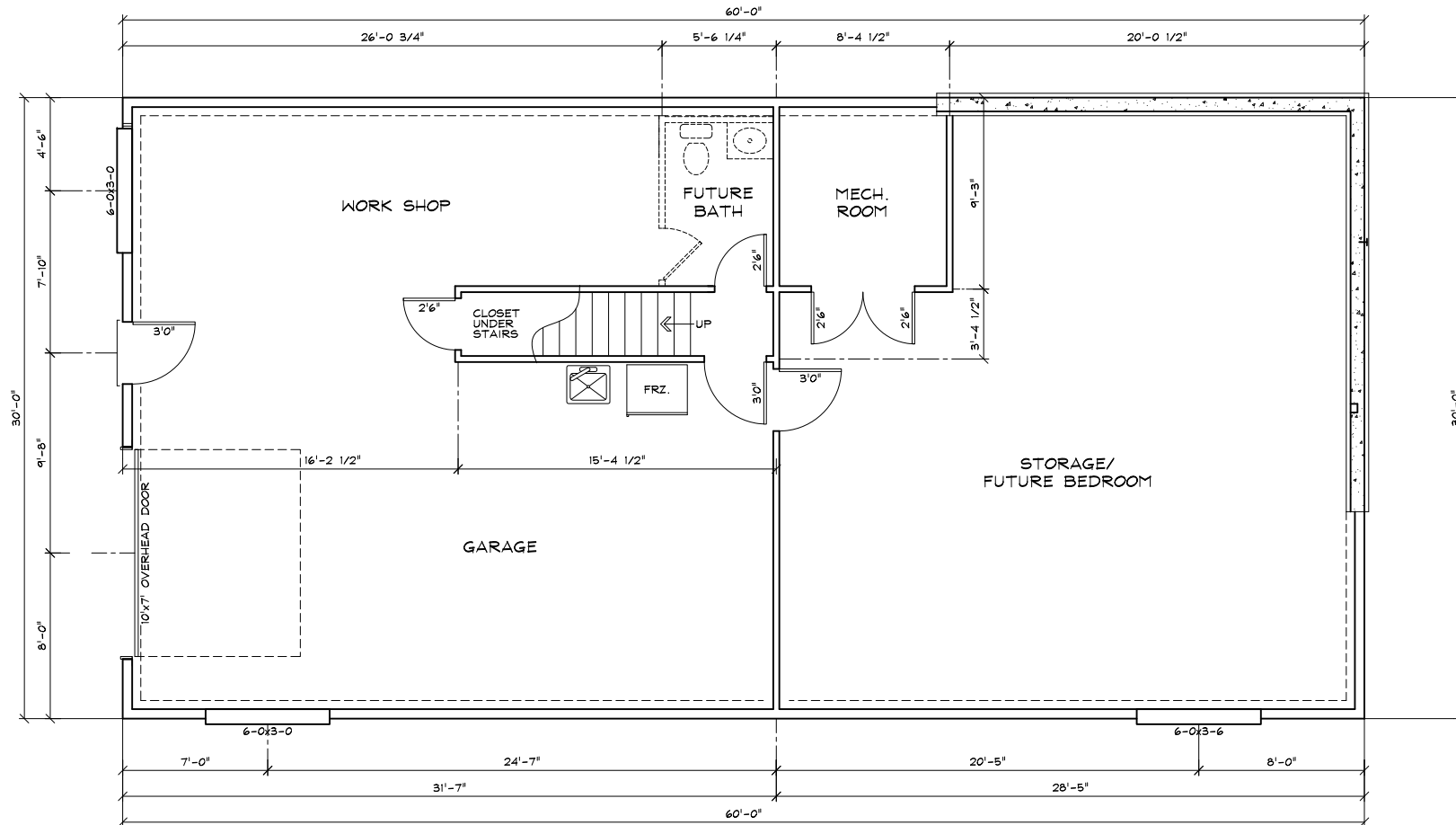

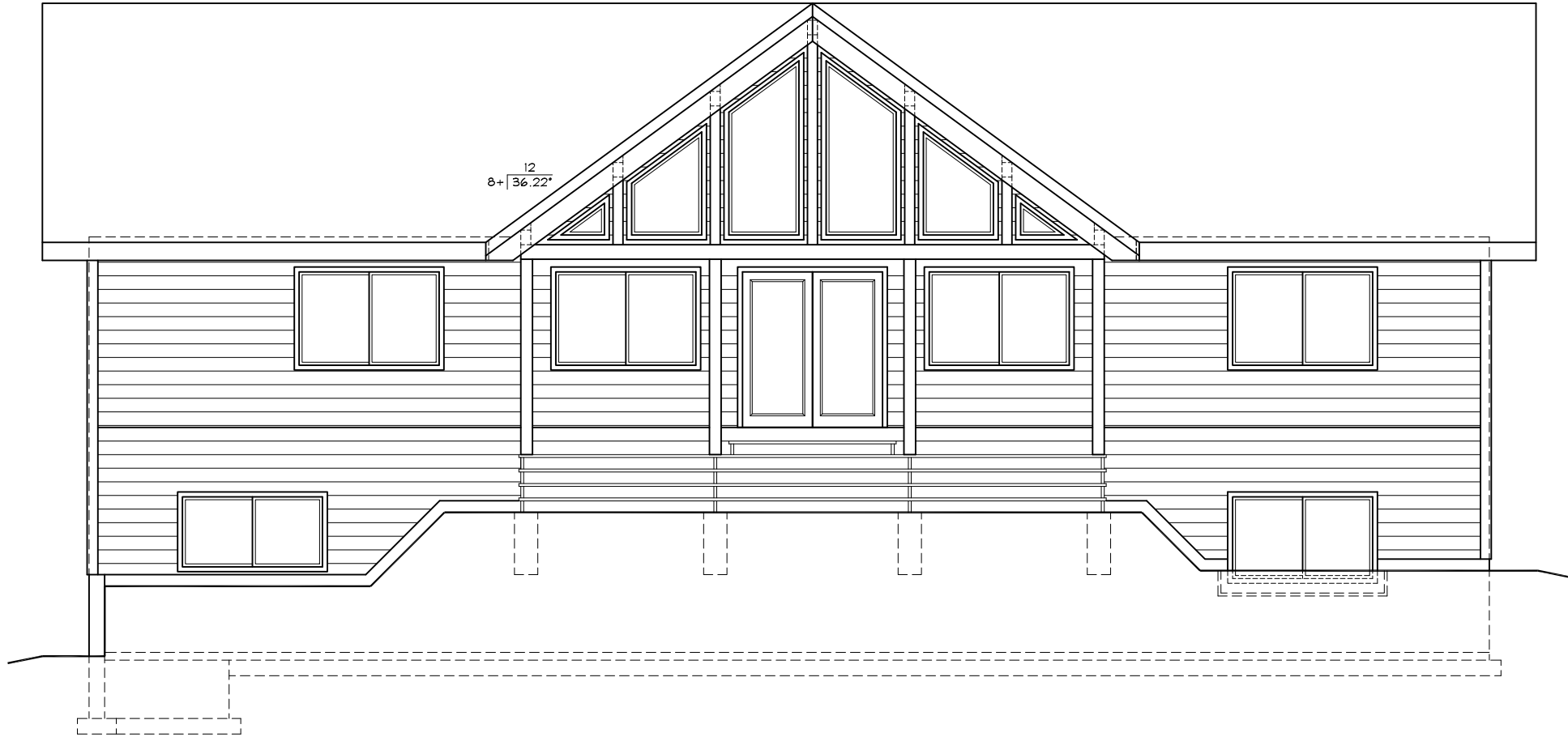
**AVON STUDY PLAN**

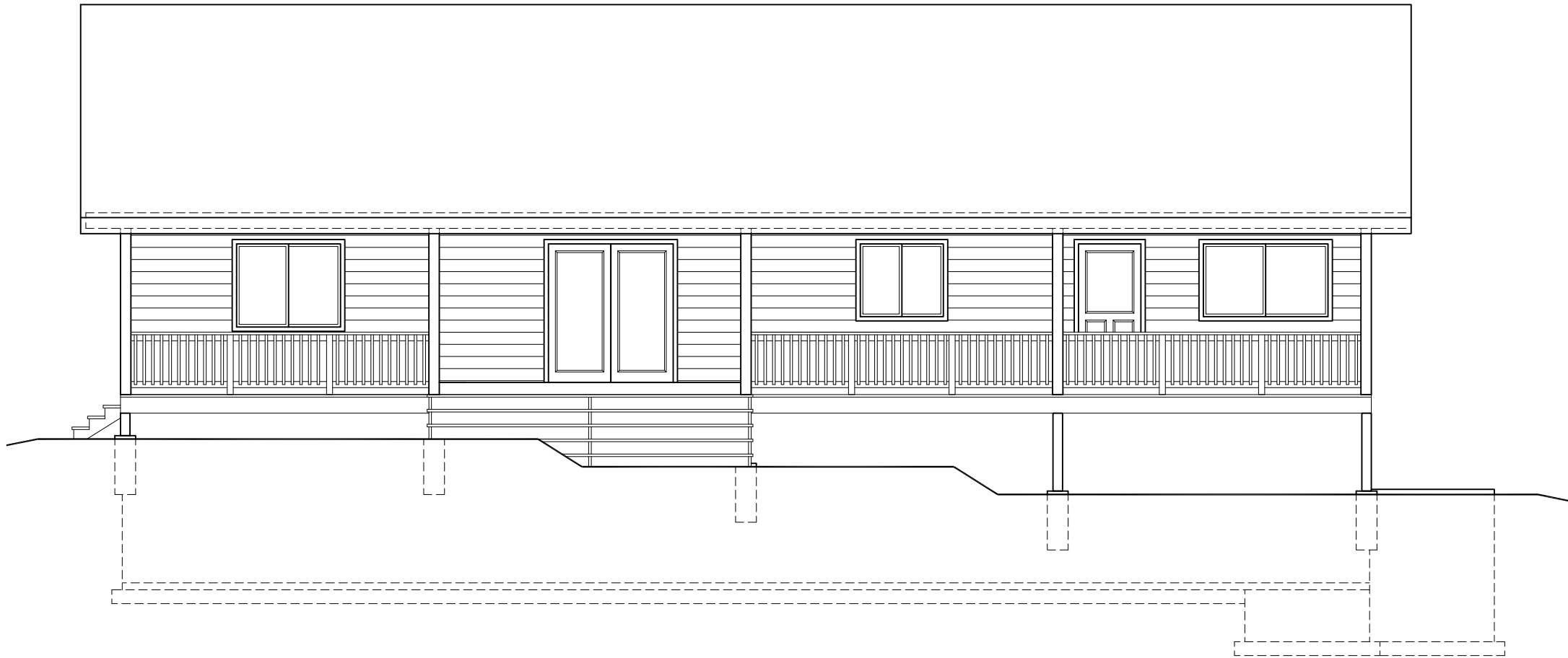
## AVON STUDY PLAN

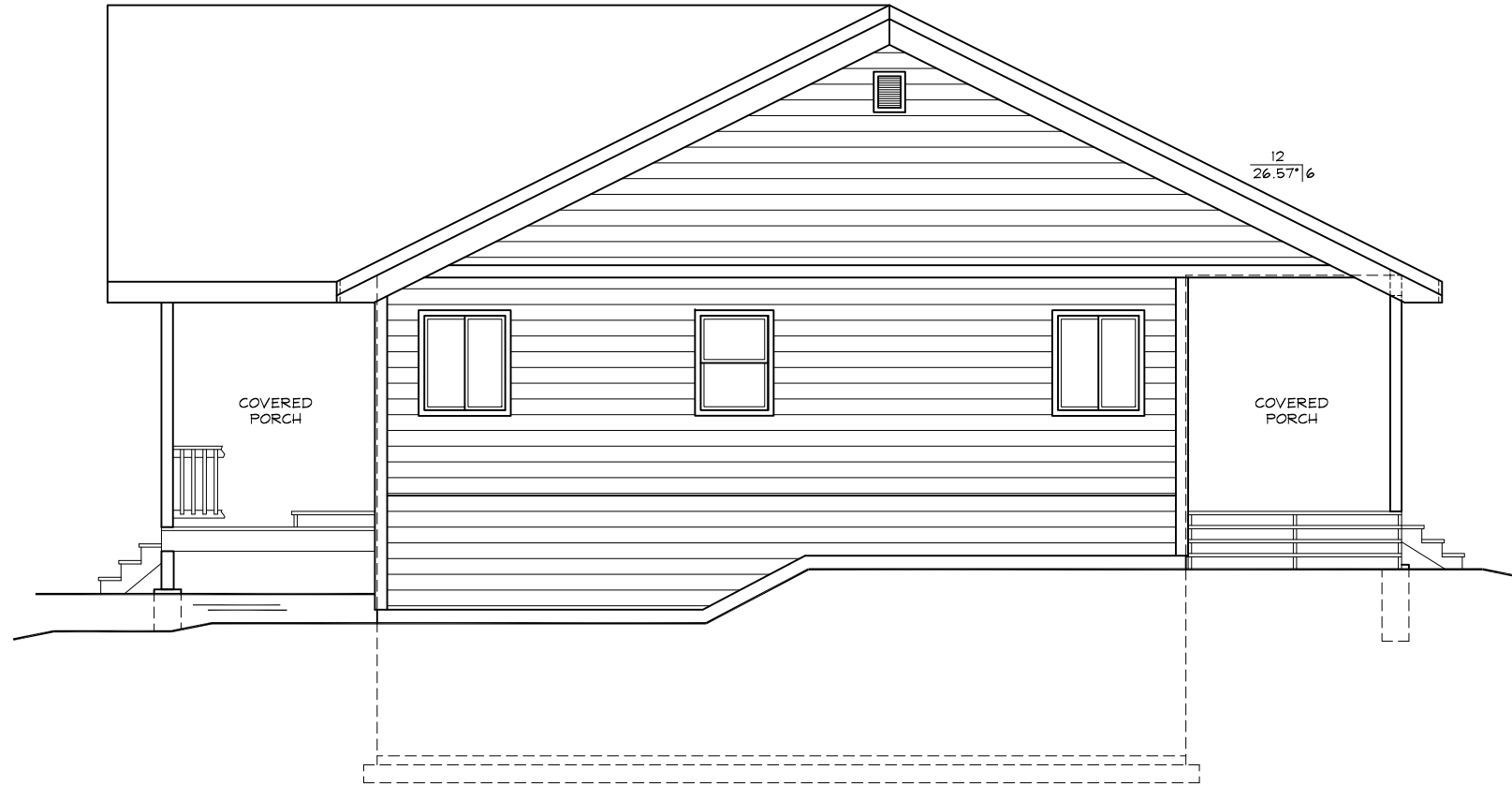
