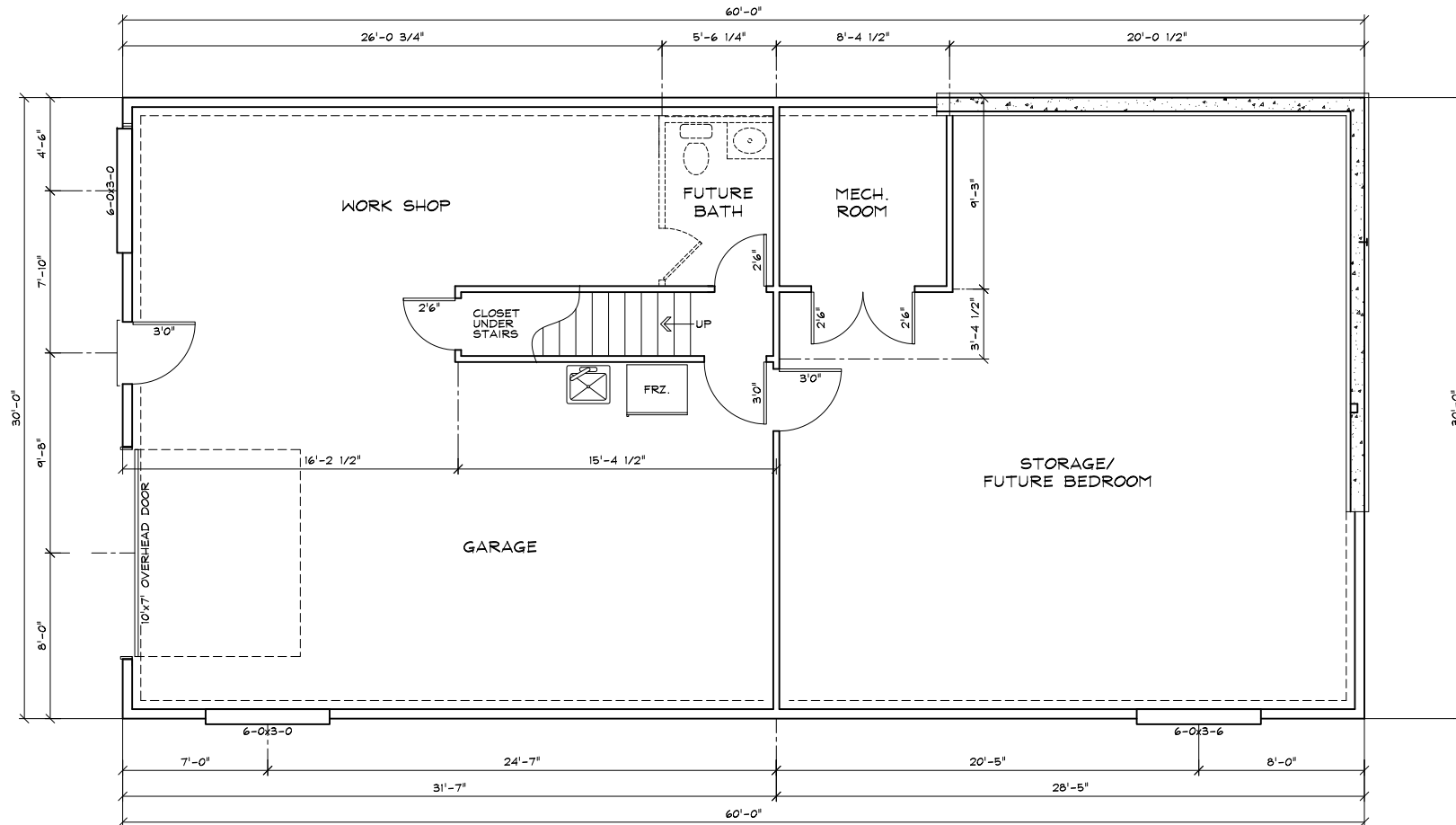

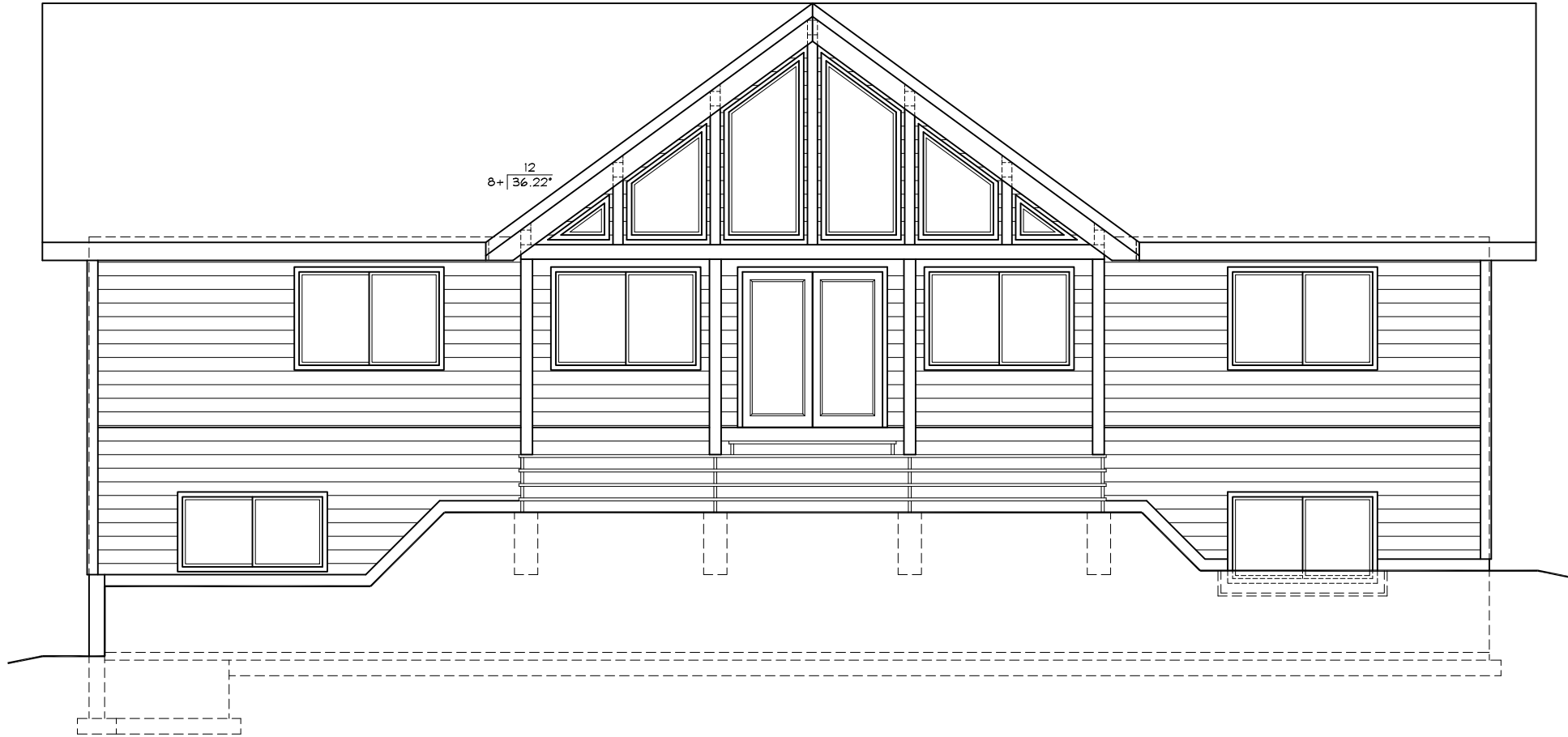
AVON STUDY PLAN

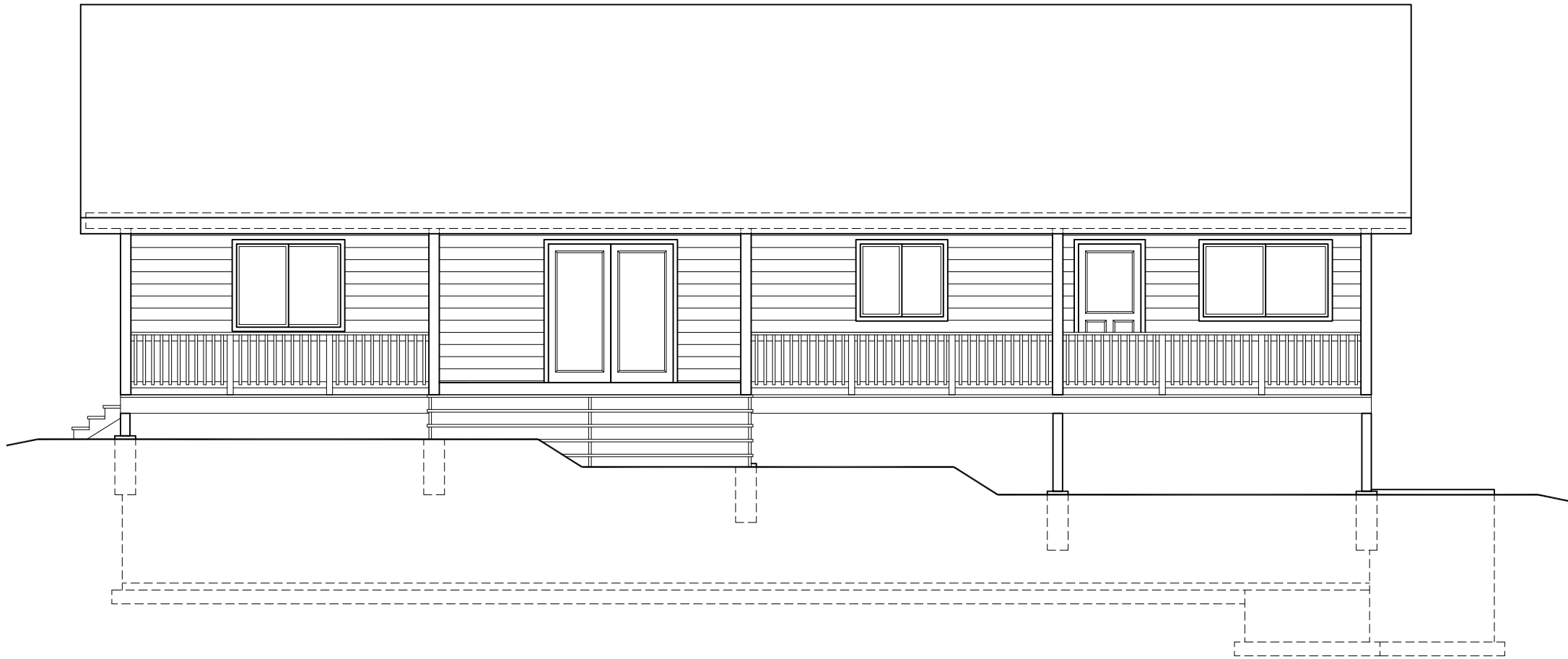
OPTIONAL LOWER LEVEL

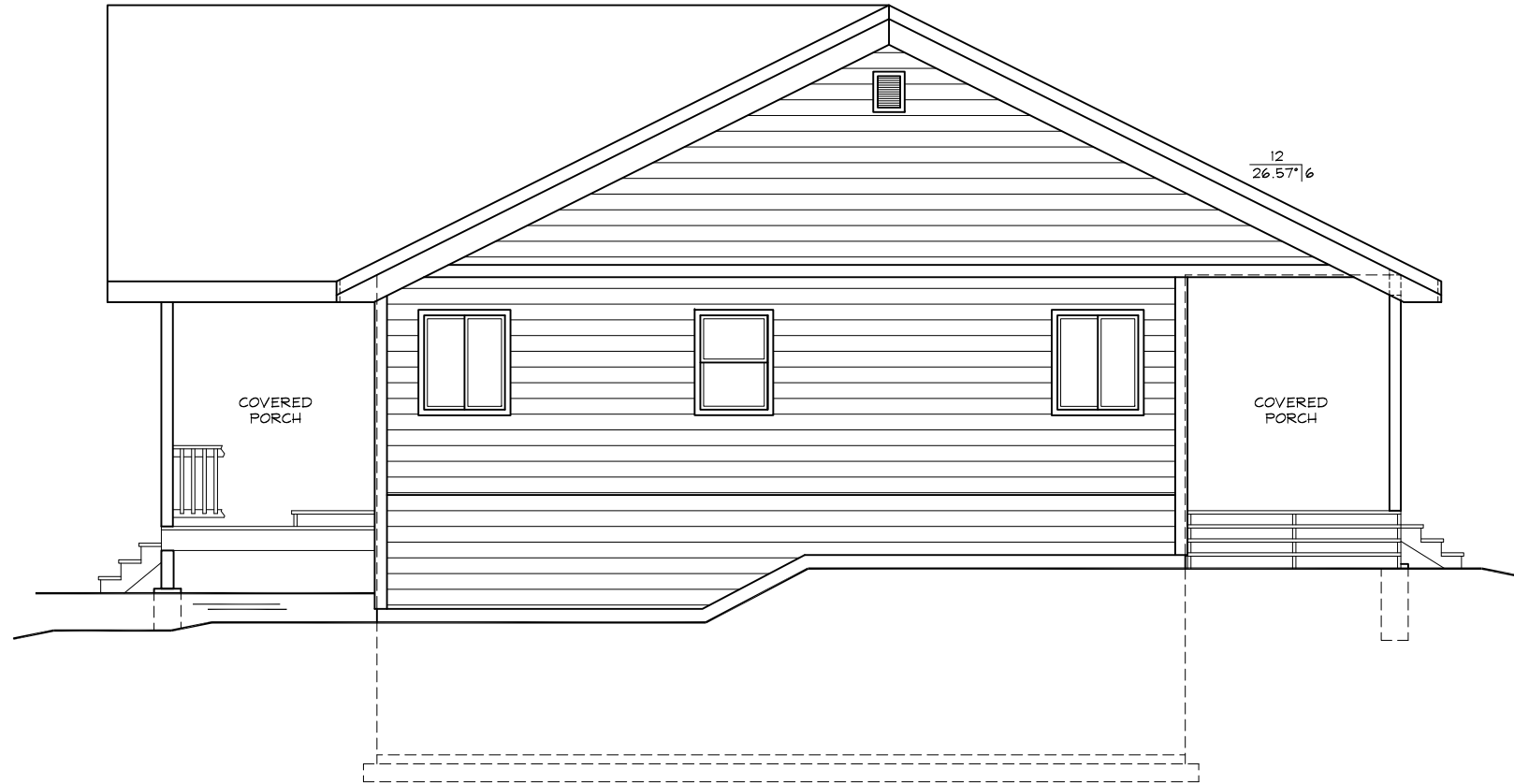
AVON STUDY PLAN
