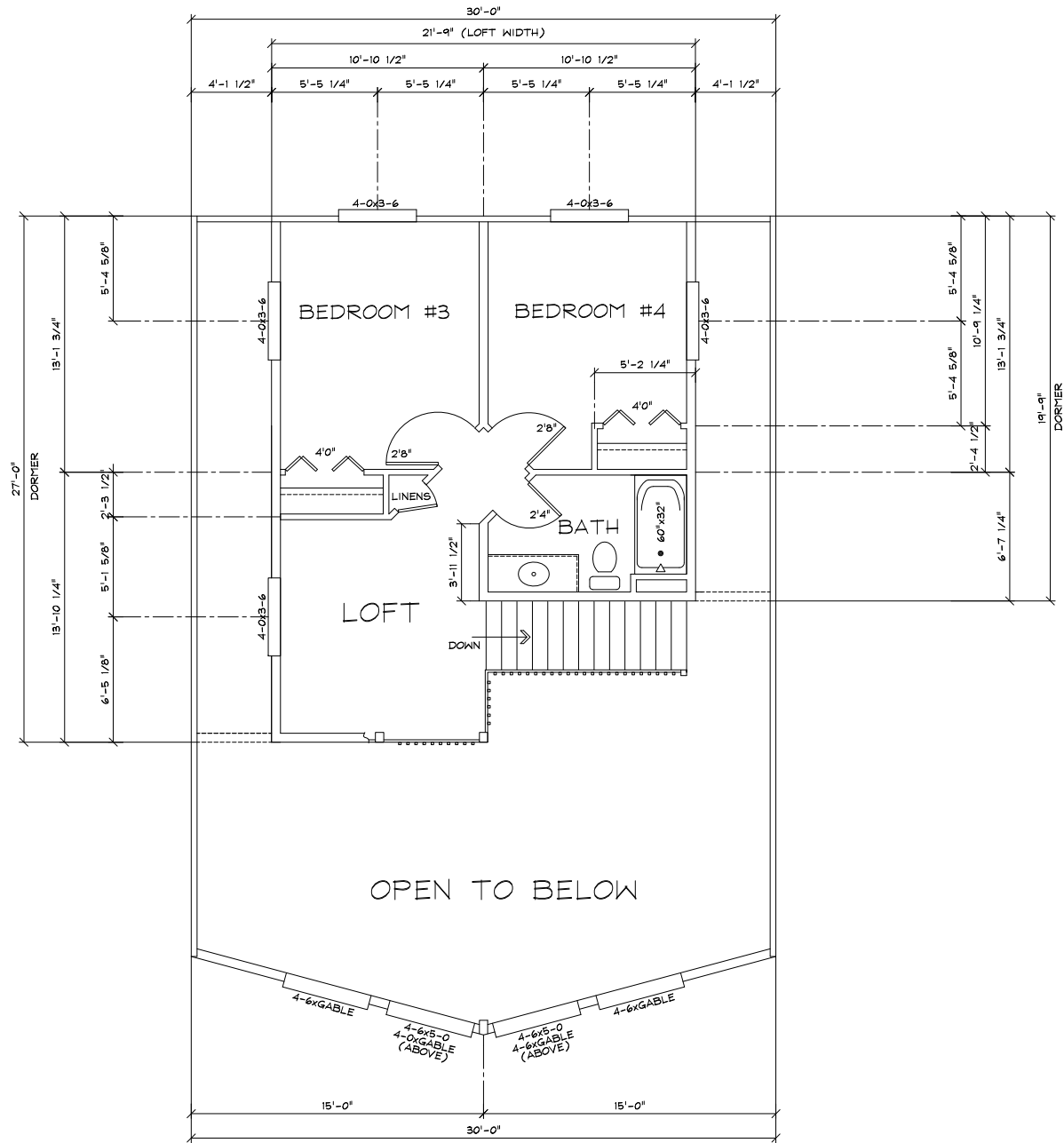


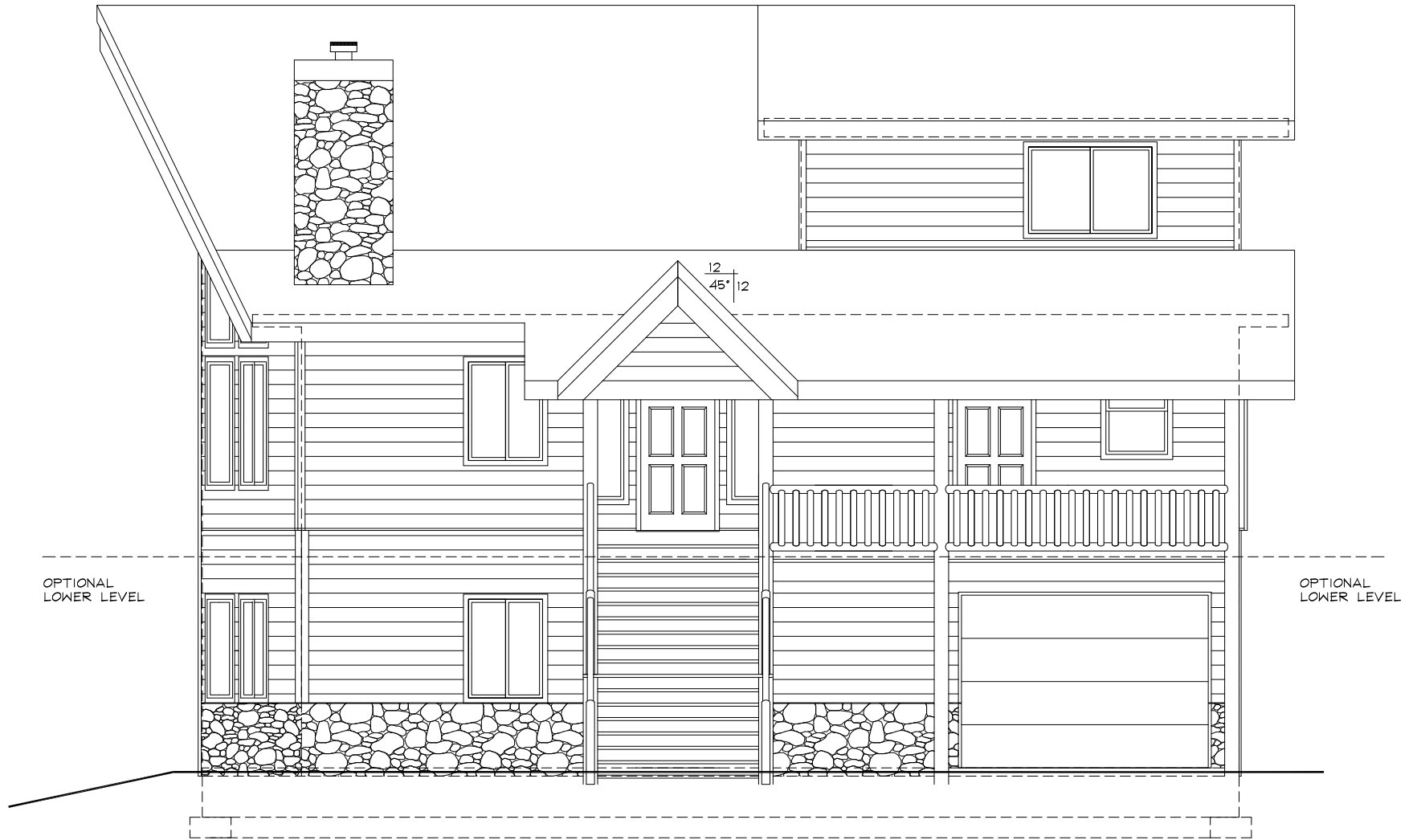

 1200 SF



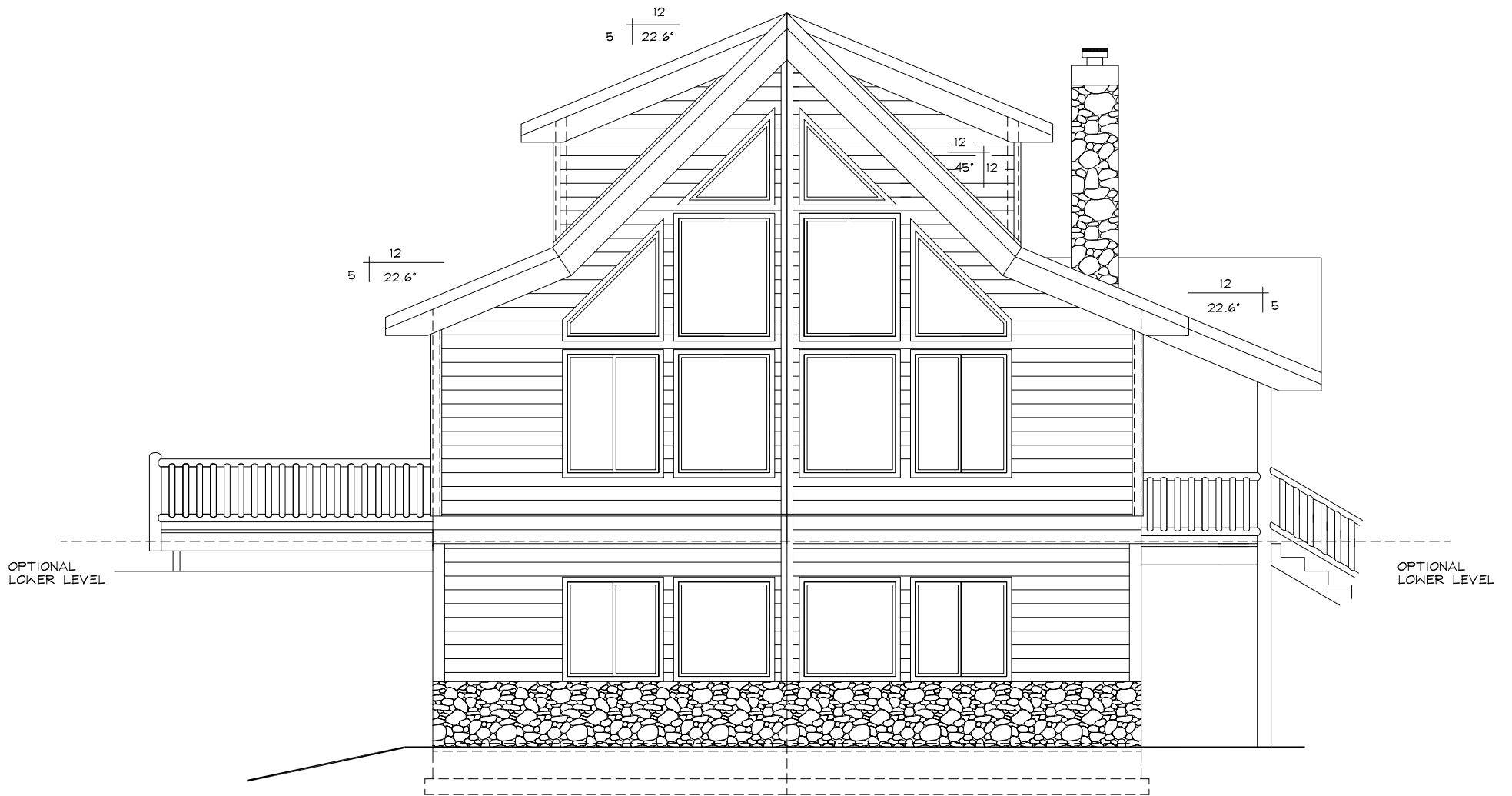

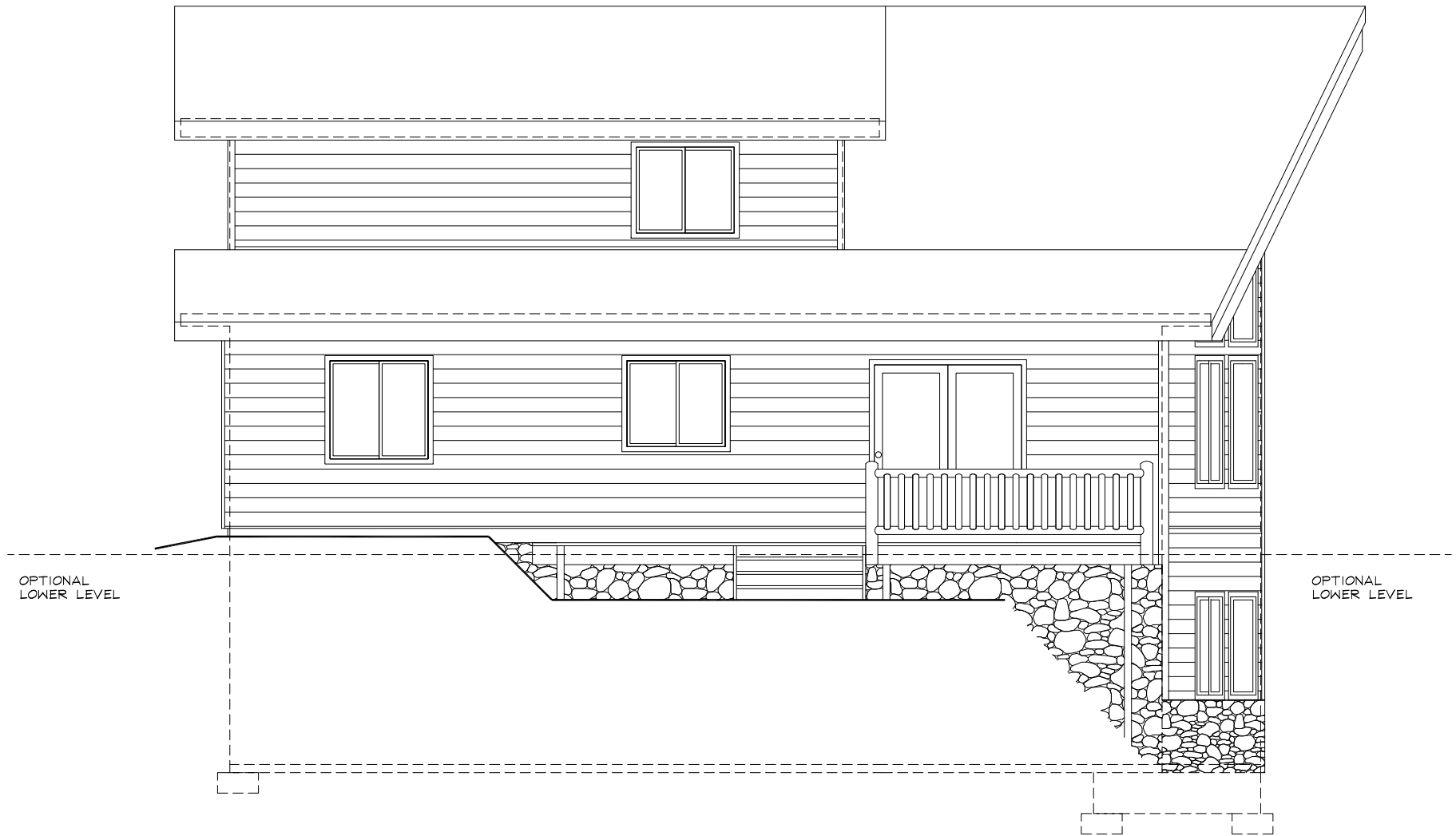

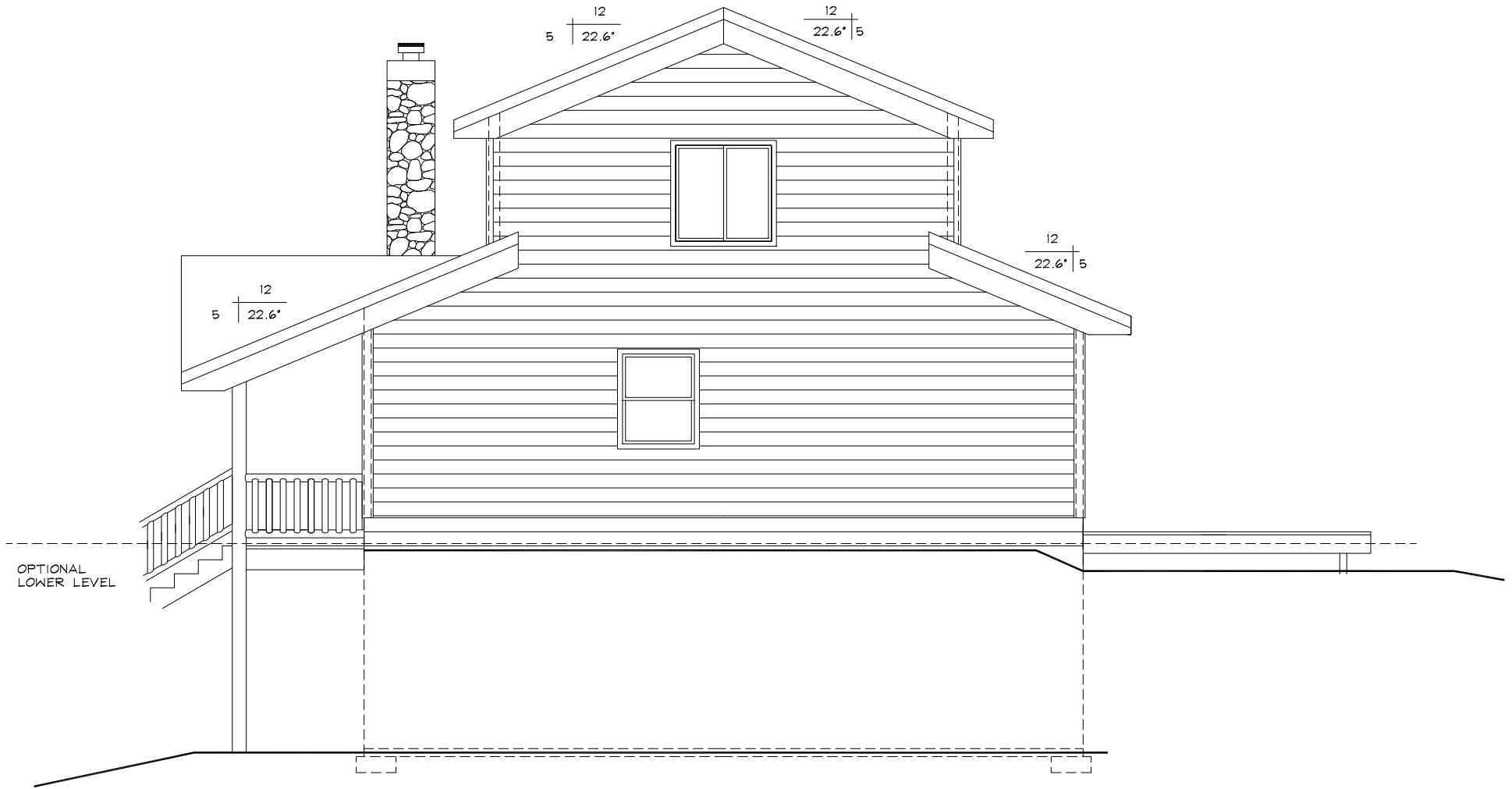
